(4) A DUI programs that are also authorized as private probation services provider, authorized providers under Section 948.15, F.S., shall not distribute a list of DUI programs in their service area or self-refer persons who are probationers to any DUI program owned in whole or in part by that private probation services provider or its affiliates. The DUI program shall document in writing, signed by the probationer, prior to the commencement of any services, that the probationer was advised of their right to choose any licensed DUI program that serves the county of their residence, employment or school attendance and that the probationer has not been referred by the private probation services provider to their DUI program. No advertising materials for a DUI program, including posters, brochures, pamphlets, or signs, shall information will be visible in any common areas of a private probation services facility, including the probation offices, hallways and any other area open to clients. <u>Interior directional and exterior business</u> <u>signs are allowed</u>. This includes all forms of media including but not limited to: posters, brochures, pamphlets and signage.

The FSU Center for Economic Forecasting and Analysis (Center) prepared an economic analysis and revised the SERC in compliance with Chapter 2010-279, Laws of Florida. JAPC suggested corrections and, on February 14, 2011, the Center issued the revised SERC.

The SERC economic analysis shows that the proposed rule is not likely to increase regulatory costs, including transactional costs, or to adversely impact economic growth, job creation, investment, business competitiveness, productivity, or innovation in excess of \$1 million in the aggregate within 5 years after rule implementation. It estimates the number of pain-management clinics subject to the rule as well as the owners, affiliated persons, and physicians likely to be affected. The rule will not affect costs to the agency, other governmental entities, nor will it affect state or local revenues. Aside from the fee to register new clinics, there are no transactional costs. The rule affects small businesses, but not small counties or cities. Alternatives to the text were discussed and considered at the rule hearing held by the department.

Notice is hereby given that the following correction has been made to the proposed rule in Vol. 36, No. 45, November 12, 2010 issue of the Florida Administrative Weekly.

The FSU Center for Economic Forecasting and Analysis (Center) prepared an economic analysis and revised the SERC in compliance with Chapter 2010-279, Laws of Florida. JAPC suggested corrections and, on February 14, 2011, the Center issued the revised SERC.

The SERC economic analysis shows that the proposed rule is not likely to adversely impact economic growth, job creation, investment, business competitiveness, productivity, or innovation in excess of \$1 million in the aggregate within 5 years after rule implementation. The economic analysis shows that the proposed rule is likely to increase regulatory costs, including transactional costs, in excess of \$1 million in the aggregate within 5 years after rule implementation and, therefore, the rule requires legislative ratification. It estimates the number of pain-management clinic physicians who are subject to the rule. The rule will not affect costs to the agency, other governmental entities, nor will it effect state or local revenues. Transactional costs of approximately 3.8 cents per controlled substance prescription yield a total of over \$422,500 per year statewide, but no other transactional costs are expected. The rule affects small businesses, but is not expected to affect small counties or cities. Alternatives to the proposal were not submitted to the department.
