53ER12-81 Rescheduling of 25th Anniversary MILLIONAIRE Million Dollar Giveaway.

(1) The 25th Anniversary MILLIONAIRE Million Dollar Giveaway described in Rule 53ER12-65, 25th Anniversary MILLIONAIRE Second Chance Promotion is rescheduled from January 12, 2013, to January 7, 2013, and will take place at the BCS National Championship Game in Miami, Florida.

(2) Paragraph (9)(a) of Rule 53ER12-65 is replaced with the following:

Upon the Florida Lottery's receipt of a first prize winner's required documentation, the Lottery will award a prize of a trip package to the Florida Lottery's 25th Anniversary Celebration for the opportunity to win a cash prize as one of five finalists in the 25th Anniversary MILLIONAIRE Million Dollar Giveaway. The winner will be provided a certificate describing the Florida Lottery's 25th Anniversary Celebration trip package along with the necessary information to make reservations to fulfill the prize.

The trip package will include some or all of the following elements based on the residency of the winner and the elements selected for use by the winner:

1. Round trip airfare (coach fare) for two persons and baggage fees (one bag/ per person/each way) from any U.S. regional or international airport with regularly scheduled

commercial service to the Florida city in which the event will be held, provided said city is at least 100 miles from the departure airport:

2. Three day/two nights' 4-star hotel accommodations for two persons:

3. Ground transportation between the airport and the hotel, and between the hotel and the Florida Lottery's 25th Anniversary Celebration venue:

4. Two tickets to the 2013 Discover BCS National Championship Game on January 7, 2013:

5. One parking pass at Sun Life Stadium for the 2013 Discover BCS National Championship Game on January 7, 2013:

6. Two tickets to the Bud Light Championship Game Day Fan Zone; and

7. \$500 in cash.
