**PURPOSE AND EFFECT:** To revise forms and procedures for applying for a waiver or modification of Florida-specific accessibility standards contained in the Florida Accessibility Code for Building Construction (FACBC). To add clarification language to Section 101.2 of the FACBC with regard to architectural barrier removal necessary to maintain consistency with the 2010 ADA Standard for Accessible Design. The modifications thereto are available via the Commissions website, www.floridabuilding.org.

**SUMMARY:** The amendments update forms and procedures to consider the standards relating to pool lifts and architectural barrier removal.

(1) All applications for a waiver or modification of the requirements of the Act or the Code shall be filed on the Form FBC 2012-01 Request for Waiver, Forms No. 2002-01 and 2001-02, Request for Waiver, effective October 2012, adopted and incorporated herein which the Commission hereby incorporates by reference, effective October 18, 2007. Copies of Form FBC 2012-01 Forms No. 2002-01 and 2001-02 are available by writing to the Codes and Standards Office, Department of Business and Professional Regulation, 1940 North Monroe Street, Tallahassee, Florida 32399 or at \_\_\_\_\_. Upon certification from an applicant that all information requested by these rules has been furnished and after review and verification by Commission Staff, the request will be scheduled for consideration at the Accessibility Advisory Council's Commission's next scheduled meeting provided that at least 7 ~~44~~ days notice can be given to the members of the Advisory Council.

(2) All Requests shall be prepared in accordance with the instructions on Form FBC 2012-01 Form No. 2002-01, but the Commission may waive a requirement in the instructions if the Commission finds the requirement unnecessary to the consideration of the Request. A Request shall be for one Project only, and no Request shall be considered by the Commission unless it shall have first been reviewed by the Council.

~~(3) The Commission and the Council may delegate to staff the authority to review an application and place it on a consent agenda only in the following circumstances:~~

- ~~(a) A majority of the Council has recommended approval of a waiver application accompanied by a particular set of design documents;~~
- ~~(b) The Commission has ordered a waiver based on the same set of design documents; and~~
- ~~(c) The Project for which application for a waiver is made is:~~

- ~~1. Owned by the same owner, franchised by the same franchiser, or licensed by the same licensor as the project previously approved by the Commission; and~~
- ~~2. To be built according to the same set of design documents previously approved by the Commission; and~~
- ~~3. The design documents described in subparagraph 2. above have been certified by the architect of record using Form 2001-02, which the Commission hereby incorporates by reference, effective October 18, 1997. Copies of Form No.~~

~~(d) The delegation has been entered in the minutes of the meetings of the Commission and of the Council. The Commission may, upon the request of any Commission member, remove an application from the consent agenda. If an application is removed from the consent agenda, it shall be placed on the agenda for hearing in sequence that day.~~

~~(4)(3)~~ At its meetings, the Council shall consider all Requests, and shall prepare a recommendation for the Commission on each Request. The recommendation may be for approval, approval for a specified time, approval with a specified condition, or disapproval. If the Council finds that the Request does not give it sufficient information to make a recommendation, it may also recommend that the Commission defer action on the Request until such information is furnished. In the absence of a quorum, individual members of the Council may present recommendations to the Commission.

~~(4)(5)~~ At the meeting of the Commission, the Chairman of the Council or his designee shall present the recommendations of the Council on each Request. At its discretion, the Commission may hear any argument in support of or opposition to any Request and it may at its discretion vote upon more than one Request together. In acting upon a Request, at its discretion the Commission may wholly or partly agree or disagree with the recommendation of the Council, and may approve any Request, may approve it for a specified time, may approve it with a specified condition, may disapprove it, or may defer it for additional information.

~~(5)(6)~~ The Commission may, subject to the limitations and requirements of Section 553.512, F.S., waive one or more Florida specific requirements of the Act or the Code created pursuant to Section 553.504-553.511, F.S. if it finds that compliance with the literal requirements will cause an unnecessary, unreasonable, or extreme hardship. A waiver or denial of a waiver shall be applicable only to the project in the Request, and no waiver shall stand as precedent for any other project or projects. In order for the Commission to find an unnecessary, unreasonable, or extreme hardship, the owner of the project must show the following:

(a) That the hardship is caused by a condition or set of conditions affecting the owner which does not affect owners in general.

(b) That substantial financial costs will be incurred by the owner if the waiver is denied.

(c) That the owner has made a diligent investigation into the costs of compliance with the Code, but cannot find an efficient mode of compliance.

~~(6)(7)~~ The Commission shall reflect its action in a Final Order. The original of each Final Order shall be filed with the Clerk of the Department, who shall also act as Clerk of the Commission. Copies of each Final Order shall be sent by

United States mail or electronic notification to the owner, to all professionals engaged in designing or building the project, and to the Building Official of the permitting jurisdiction. In addition, pertinent information concerning each Final Order shall be entered in a Master Topical Index of Final Orders, which shall be maintained by the Clerk of the Commission.

(1) through (2) No change.

(3) Training Provider Registration and Requirements.

(a) Training providers approved by the Department of Business and Professional Regulation who desire Commission approval and accreditation for advanced building code courses shall register with the Building Code Information System using the Register Training Provider function and associated online screens, Form FBC-ED-002, effective September 10, 2010, adopted herein by reference and available from the Building Code Information System at [www.floridabuilding.org/ce/ce\\_tporgapp\\_dt1.aspx](http://www.floridabuilding.org/ce/ce_tporgapp_dt1.aspx), and pay a registration fee of \$25.00.

(b) Registered training providers shall submit materials and information pertaining to courses for which Commission accreditation and approval is sought utilizing the Submit a Course Application function and associated online screens, Form FBCED 2003-03, effective ~~September 10, 2010~~ October 2012, adopted herein by reference and available from the Building Code Information System at [http://www.floridabuilding.org/ce/ce\\_default.aspx](http://www.floridabuilding.org/ce/ce_default.aspx) [www.floridabuilding.org](http://www.floridabuilding.org).

(c) The provider shall select an approved accreditor and shall provide payment for services directly to the accreditor. The accreditor selected shall meet the criteria for independence identified in paragraph (d) and shall be listed with the expertise in the field for which approval is sought.

(d) Upon submittal by a training provider, the selected accreditor shall receive an e-mail notification from the Building Code Information System at [www.floridabuilding.org](http://www.floridabuilding.org) and shall review the materials provided by the provider in accordance with the criteria identified herein. The accreditor shall complete the application by providing comments containing the results of the accreditor's review and approving or denying accreditation of the course ~~updating the accreditation approval status~~ on the Building Code Information System. An accreditor may not approve for accreditation a course application that is not complete and accurate as specified in subsection (4). The accreditor shall also provide a certification of independence that attests the person or entity does not have, nor does it intend to acquire or will acquire, a financial interest in the training provider seeking accreditation.

(e) The Building Code Information System [www.floridabuilding.org](http://www.floridabuilding.org) shall assign an accreditation number to the application upon submittal. The application shall be accredited completely and placed in the "Pending FBC Action" file on the Building Code Information System at [http://www.floridabuilding.org/ce/ce\\_tp\\_coursetrp\\_dt1.aspx](http://www.floridabuilding.org/ce/ce_tp_coursetrp_dt1.aspx) ~~www.floridabuilding.org~~ no later than 23 calendar days prior to the next scheduled meeting of the Florida Building Commission. The Commission or its designee shall finalize the accreditation process utilizing the Building Code Information System at [www.floridabuilding.org](http://www.floridabuilding.org) and notify the provider and accreditor within 3 business days of the Florida Building Commission's action on the applications. If a provider has not taken any action on a submitted but incomplete application in 180 days, the Commission may withdraw the application.

(f) On or before the effective date of changes to the Florida Building Code, providers shall ~~either designate on the Building Code Information System at www.floridabuilding.org that the course is not affected by the code changes or~~ update the existing accredited courses affected by the code changes and submit for accreditation on the Building Code Information System at [http://www.floridabuilding.org/ce/ce\\_default.aspx](http://www.floridabuilding.org/ce/ce_default.aspx). ~~If the course is not affected by the code changes, the course's status shall remain active.~~ The code version that initiated the update and reaccreditation process must be noted on the application. Accreditation of revisions to approved accredited courses shall be accomplished in the same manner as described in paragraphs (a) through (f) hereof, except ~~that~~ only the revision submitted shall be subject to review, ~~and~~ These courses shall be approved by the administrator of the education program subject to ratification by the Florida Building Commission.

(g) If an approved accredited course is not affected by the code change or requires revision to correct or update a reference, table, diagram, or quoted provision of code, law, or administrative rule, the training provider ~~shall may submit the revised course and~~ complete Form FBC-ED-002, effective September 10, 2010, adopted herein by reference and available from the Building Code Information System at [http://www.floridabuilding.org/ce/ce\\_tporgapp\\_dt1.aspx](http://www.floridabuilding.org/ce/ce_tporgapp_dt1.aspx) ~~www.~~

~~floridabuilding.org~~. The code version must be noted on the application. If a correction or update is required, the training provider must list the exact correction or update change, the specific location of the correction or update change, and reason for the change in the course and affirm this is the only correction or update to the course change. The correction or update changes to the course shall be approved by the administrator of the education program subject to ratification by the Florida Building Commission.

(h) A change to the delivery format of an approved accredited course must be submitted for accreditation.

(4) Course Content and Accreditor Review. Accreditors shall review courses submitted by registered providers to determine if the course accurately presents the technical and administrative responsibilities reflected in the current edition of the Florida Building Code, or future editions of the Code if the accreditor is reviewing a course revised to comply with an updated edition of the Florida Building Code in accordance with paragraph (3)(f) of this rule or Florida Statutes or rules related to the Florida Building Code. Accreditors shall not mutually accredit each others' courses. The accreditor shall determine if the course meets the following minimum criteria:

(a) Course title and number. The word "advanced" and, if appropriate, "internet" shall be in the title;

(b) Hours of credit;

(c) Name, address, telephone number and e-mail address of the provider;

(d) Course description completely describing what the particular course is designed to address;

(e) Course/learning objectives;

(f) Course time allotments for course content;

(g) Course outline and instructional methods – detailed description of course content in sequence of how taught and methods used to teach that content. The following instructional methods are authorized, but are not limited to: exercises, quizzes, discussion groups, reading assignments, projects, simulations and presentations;

(h) Code edition to which the course relates;

(i) Course references cited in the outline;

(j) Method of course evaluations;

(k) A minimum of 50% of the actual training materials content shall be related to the Florida Building Code or Florida Statutes or rules related to the Florida Building Code;

(l) Course materials shall accurately reflect the Florida Building Code and other topics under the jurisdiction of the Florida Building Commission; and

(m) Course materials provided to the attendee shall be provided ~~to~~ by the accreditor.

Certification, Employment or Appointment, Reactivation, and Terminating Employment or Appointment of Officers

The Criminal Justice Standards and Training Commission hereby gives notice that on August 17, 2012, the Criminal Justice Standards and Training Commission, received a petition for a permanent waiver of Rules 11B-35.002(2), and 11B-27.002(4), F.A.C., by Arcadia Police Department on behalf of Officer Robert McVey. Petitioner wished to waive

that portion of the rules which require an officer to obtain employment within four years of beginning basic recruit training. The Petition stated that Officer McVey was employed by Petitioner in May of 2012. Officer McVey had commenced cross-over basic recruit training on April 14, 2008. The Petitioner was able to register Officer McVey in the CJSTC's officer database, but learned in July of 2012 that Officer McVey was ineligible for employment because of the rules cited above. The Petition stated that the operation of the rule would violate the principles of fairness because Petitioner was able to register Officer McVey in ATMS in May of 2012 and put him to work in June of 2012, whereas other officers subject to the rule would have been blocked in ATMS and denied registration. The Petition stated that the operation of the rule creates a substantial hardship for both Petitioner and Officer McVey in that arrests and citations issued by Officer McVey would be made a nullity should he lose his eligibility to remain certified. The Petitioner would have to fill the vacancy created by Officer McVey with other officers during severe budgeting times. The Petition further supported the requested waiver by stating that Officer McVey would have to return to training school to demonstrate proficiency in the high liability areas and pass the SOCE prior to becoming eligible for employment, which would be a considerable expense to him. Notice of the waiver was published in the Florida Administrative Weekly, Vol. 38, No. 37, on September 14, 2012.

On November 1, 2012, pursuant to notice, at its regularly scheduled Business Agenda meeting held in Sarasota, Florida, the Commission found that the Petitioner's situation is unique. The Petitioner demonstrated that the strict application of the Commission's rules in this case would violate the principles of fairness. The Petitioner was able to register the officer into ATMS and work him as certified. The officer relied upon that and was instrumental in enforcing traffic laws and making arrests for his agency which would be questioned if his employment were nullified. The officer would further suffer undue hardship by being forced to demonstrate proficiency in the high liability skills and pass the SOCE if the waiver were not granted. The deficiency in the registration of the officer into ATMS was the fault neither of the agency nor the officer. The Commission found that the purposes of the underlying statute, to ensure that officers receive adequate and timely retraining, will be met by granting this waiver request. The Commission issued an order granting the Petitioner's waiver.
