SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Section 120.54(4)(a), FS, authorizes state agencies to engage in emergency rulemaking upon a finding that there is an immediate danger to the public health safety or welfare, and section 120.54(4)(b) specifically includes rules pertaining to perishable agricultural commodities in the category of public health, safety, and welfare.

The Department received a petition requesting emergency rulemaking from the Florida Citrus Packers Association, a non-profit industry organization located in Lakeland, Florida.

The emergency is due to extreme rainfall from Hurricane Isaac during the last week of August and the first week of September causing a significant portion of the navel and ambersweet orange crop to not meet the current minimum requirement and such emergency action would allow the salvage of wholesome fruit. Strict enforcement of the anhydrous acid content requirements shall result in economic waste by causing good and safe food to be ruled immature, therefore causing damage to the public welfare.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: The following notice procedure was used and relied upon by the Department of Citrus to inform the public and the Florida citrus industry of the pending adoption of emergency Rule 20ER12-1: Notice of emergency rulemaking to be taken up at an emergency meeting of the Florida Citrus Commission was made by email on October 17, 2012, to the Florida Citrus Commission, industry organizations, the Florida Press Corps and all other interested parties.

Procedures used are fair under the circumstances and are adequate to protect the public interest.

The South Florida Water Management District (District) hereby gives notice:

On October 11, 2012, the District's Governing Board issued SFWMD Order No. 2012-123-DAO-ROW to Florida Department of Transportation (Application No. 12-0628-4). The petition for waiver was received by the District on June 28, 2012. Notice of receipt of the petition requesting the waiver was published in the Florida Administrative Weekly, Vol. 38, No. 29, on July 20, 2012. No public comment was received. This Order provides a waiver of the District's criteria to allow the removal and replacement of the existing guardrail within the north right of way of C-1W at the northwest quadrant of the existing Krome Avenue (SF-997) bridge; Section 12, Township 55 South, Range 38 East; Miami-Dade County. Specifically, the Order grants a waiver from Rule 40E-6.221(9), Fla. Admin. Code, and the Basis of Review for Use or Occupancy of the Works or Lands of the District, incorporated by reference in Rules 40E-6.011(4) & (6), Fla. Admin. Code, which governs the placement of permanent and/or semi-permanent above-ground facilities within 40' of the top of the canal bank and within the District's designated 100' long equipment staging areas located at all bridge and pile-supported utility crossings within works or lands of the District. Generally, the Order sets forth the basis of the Governing Board decision to grant the waiver as follows: 1) the guardrail will not interfere with the District's current ability to perform necessary construction, alteration, operation, and routine maintenance activities; and 2) the Order granting a waiver from the subject rule is based upon a substantial hardship.

If there are none, the petition must so indicate; (e) A concise statement of the ultimate facts alleged, including the specific facts that the petitioner contends warrant reversal or

modification of the agency's proposed action; (f) A statement of the specific rules or statutes that the petitioner contends require reversal or modification of the agency's proposed action, including an explanation of how the alleged facts relate to the specific rules or statutes; and (g) A statement of the relief sought by the petitioner, stating precisely the action that the petitioner wishes the agency to take with respect to the agency's proposed action.
