SUMMARY: The rule will ensure judges, hearing officers, Department and contracted staff know that the same criteria which apply to children and young adults in Florida's foster care system and independent living program also apply to an unaccompanied refugee minor receiving federally funded child welfare services from the State.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. For these reasons, a SERC has not been prepared by the agency and legislative ratification is not required.

#### UNACCOMPANIED REFUGEE MINORS

#### 65F-1.001 Definitions.

(1) Child welfare services, as used in this rule, means foster care and all related services and benefits available to children in Florida's foster care and to young adults who remain qualified for independent living transition services.

(2) Unaccompanied refugee minor means an unaccompanied minor, as defined in 45 C.F.R. 400.111, who has met the federal eligibility standards for placement into the Unaccompanied Refugee Minor Program (URMP). Only unaccompanied refugee minors are eligible for child welfare services through the URMP.

(3) Unaccompanied Refugee Minor Program (URMP) is a federally funded and state administered program under 45 C.F.R. Part 400 and Section 402.86 of the Florida Statutes established to secure custody over an unaccompanied refugee minor and to provide the same range of child welfare services available to other children and young adults in Florida.

65F-1.002 Child Welfare Services Qualifications.

Child welfare services available to an unaccompanied refugee minor shall be equivalent, within the meaning of 45 C.F.R. 400.116(a), to other children in Florida's foster care. The eligibility requirements for specific child welfare services provided in the applicable Florida Statutes and corresponding rules shall apply to an unaccompanied refugee minor seeking those services through the URMP, to the extent the applicable Florida Statutes or rule does not conflict with 45 C.F.R. Parts 400 and 401, which shall control. For purposes of Section 409.1451(2)(b), F.S., time in foster care shall include time in the custody of the U.S. Department of Health and Human Services' Office of Refugee Resettlement.

(1) 25th Anniversary MILLIONAIRE RAFFLE<sup>TM</sup> is a number-match game with a limited number of tickets available that will be sold within a limited sales period.

(2) Each 25th Anniversary MILLIONAIRE RAFFLE ("MILLIONAIRE RAFFLE") ticket sells for \$20.

(3) MILLIONAIRE RAFFLE tickets will go on sale Friday, November 9, 2012. Sales of MILLIONAIRE RAFFLE tickets will cease immediately after the 1,000,000<sup>th</sup> ticket is sold or at midnight on December 30, 2012, whichever occurs first.

(4) Each MILLIONAIRE RAFFLE ticket will contain a unique ticket number that will be automatically entered into one of six random computerized weekly drawings based on the date it is purchased. Tickets purchased by December 23, 2012, will also be entered into the grand prize drawing on December 31, 2012, unless previously selected as a \$1,000,000 winner in a weekly drawing. Tickets purchased after December 23, 2012, will only be included in the grand prize drawing. The drawing schedule is as follows:

(7) MILLIONAIRE RAFFLE tickets cannot be cancelled.

(8) 25TH Anniversary MILLIONAIRE RAFFLE Drawings.

(a) Weekly Drawings. In each weekly drawing, only tickets purchased during the corresponding sales period will be included in the drawing. The 1st number drawn will win the first prize. The 2nd through the 51st numbers drawn will win a second prize and will serve as alternates, in the order drawn, for a first prize in the event the \$1,000,000 prize is not claimed within the 180-day claim period. A total of 306 weekly drawing prizes will be awarded.

1. In the event that all 1,000,000 MILLIONAIRE RAFFLE tickets sell out during a weekly drawing sales period in which there are fewer tickets in the weekly drawing than weekly prizes to be awarded, a two-part drawing for that weekly sales period will be held on the date scheduled. Part one of the drawing will include only those tickets sold during the sales period and prizes will be awarded in the order tickets are drawn. (13) If a winning MILLIONAIRE RAFFLE ticket for a prize of \$2,000,000 or \$1,000,000 is not presented to a Florida Lottery office for payment within 180 days from the date it was drawn, an alternate prizewinner who has claimed his or her prize within the 180-day claim period will be used as set forth in paragraph (8)(a) or (b), as applicable, to award the unclaimed prize. The Florida Lottery will attempt to notify the first alternate for a period of two weeks.
