(1) No change.

(2) Standard Utility Allowance. A standard utility allowance (SUA) of ~~\$337~~ ~~\$335~~ must be used by AGs who incur or within the eligibility period expect to incur heating or cooling expenses separate and apart from their rent or mortgage and by AGs who receive direct or indirect assistance authorized under the Low Income Home Energy Assistance Act of 1981. Actual

utility expenses are not allowed. Any additional utility expenses, including the telephone standard, are not used.

(3) No change.

(4) Telephone Standard. A telephone standard of ~~\$36~~ ~~\$33~~ must be used by AGs who incur only a telephone expense. Actual telephone expenses are not allowed. Any additional utility expenses, including the SUA or BUA, are not used.

(5) No change.

(6) Child Support Paid Out. Legally obligated child support payments are a deduction for the Food Assistance Program.

69L-6.012 Notice of Election to be Exempt  
PURPOSE AND EFFECT: The proposed rule is amended to conform to applicable provisions of Chapter 440, F.S., relating to the process through which corporate officers may apply to be exempt from Florida’s workers’ compensation coverage requirements. The proposed rule is also amended to reflect the meaning of “Corporate officer,” as defined in subsection 440.02(9), F.S. Under the aforementioned definition, members owning at least 10% of a non-construction limited liability company qualify as corporate officers and may elect to be exempt from the coverage requirements of Chapter 440, F.S. Incorporated Form DFS-F2-DWC-250 (Notice of Election to Be Exempt), which is completed on-line, is revised to accommodate application by non-construction industry employers seeking to be exempt from the coverage requirements found under Chapter 440, F.S. The proposed rule also provides updated contact information, deletes obsolete language and includes other technical changes.

SUMMARY: The proposed rule is amended to conform to applicable provisions of Chapter 440, F.S., that relate to the process whereby corporate officers may apply to be exempt from Florida’s workers’ compensation coverage requirements. The proposed rule also revises online form DFS-F2-DWC-250 (Notice of Election to Be Exempt) in order to accommodate application by non-construction industry employers.

(1)(a) Only corporate officers of non-dissolved or active corporations who meet the conditions for the issuance of valid Form DFS-F2-DWC-252, Certificates of Election to be Exempt from Florida Workers’ Compensation Law, revised 08/13, and herein incorporated by reference, as stated in Chapter 440, F.S., and implemented by this rule may file a Form DFS-F2-DWC-250, Notice of Election to be Exempt, revised 07/14 ~~08/13~~, and incorporated by reference herein. Only a business entity organized under Chapter 607 or 617, F.S., will qualify as a

corporation for purposes of issuing a Form DFS-F2-DWC-252, Certificate of Election to be Exempt from Florida Workers' Compensation Law to a corporate officer under this rule. While a limited liability company created and approved under Chapter 608, F.S., is not a corporation for purposes of Chapter 440, F.S., persons ~~engaged in the construction industry~~ who are limited liability company members owning at least ten percent (10%) of the non-dissolved or active limited liability company qualify as a "corporate officer" and are eligible for the issuance of a Form DFS-F2-DWC-252, Certificate of Election to be Exempt from Florida Workers' Compensation Law, under this rule.

(b) The Department shall deny any Form DFS-F2-DWC-250, Notice of Election to be Exempt, received from an applicant that does not meet the eligibility requirements for the issuance of a DFS-F2-DWC-252, Certificate of Election to be Exempt from Florida Workers' Compensation Law. An applicant who receives such denial from the Department and still seeks a DFS-FS-DWC-252, Certificate of Election to be Exempt from Florida Workers' Compensation Law must file a A new Form DFS-F2-DWC-250, Notice of Election to be Exempt, ~~must be submitted by the corporate officer,~~ and, if the ~~applicant corporate officer~~ is engaged in the construction industry, another \$50.00 fee must be submitted with the Form DFS-F2-DWC-250, Notice of Election to be Exempt.

(2) through (4) No Change.

(5) Incomplete Notices of Election to be Exempt, Issue Dates for Certificates of Election to be Exempt from Florida Workers' Compensation Law.

(a) An applicant shall have ninety days from the date of the Department's deficiency notice to submit a completed Form DFS-F2-DWC-250, Notice of Election to be Exempt, at which time the Form DFS-F2-DWC-250, Notice of Election to be Exempt, shall be processed, and no without any additional processing fee will be due for a construction industry applicant. The Department shall deny the Form DFS-F2-DWC-250, Notice of Election to be Exempt, if the applicant fails to submit information to complete the Form DFS-F2-DWC-250, Notice of Election to be Exempt, within ninety days of the date of the Department's deficiency notice. An applicant who receives such denial from the Department and still seeks a Form DFS-FS-DWC-252, Certificate of Election to be Exempt from Florida Workers' Compensation Law must file ~~If the Form DFS F2 DWC 250, Notice of Election to be Exempt is denied,~~ the applicant ~~must submit~~ a new Form DFS-F2-DWC-250, Notice of Election to be Exempt, and, if the applicant is engaged in the construction industry, another \$50.00 fee is required.

The United States Environmental Protection Agency is seeking public comment on a Clean Air Act (CAA) Outer Continental Shelf (OCS) air permit modification for Statoil Gulf Services, LLC (Statoil), 2103 CityWest Boulevard, Suite 800, Houston, Texas 77042. EPA previously issued Statoil an OCS air quality permit on October 28, 2013, to regulate air emissions from an exploratory drilling operation in the Gulf of Mexico and provided an opportunity for public comment on this permitting action between August 9, 2013 and September 9, 2013.

The permitted project, which has not yet begun drilling, will include operation of one of two deep water drilling vessels, the Maersk *Developer* drill rig or the Transocean *Discoverer Americas* drill ship, and associated crew and support vessels. Statoil proposes to conduct exploratory drilling at multiple sites within lease blocks located on the OCS waters in the Gulf of Mexico east of longitude 87.5° and approximately 160 miles southeast of the mouth of the Mississippi River and 200 miles southwest of Panama City, Florida. Drilling operations may occur for up to 180 days per year for a period of five to ten years. The project is for exploratory drilling only and does not include the establishment of any permanent production platforms.

Statoil has requested a permit modification to include best available control technology (BACT) limits for particulate matter with an aerodynamic diameter less than or equal to 2.5 microns (PM<sub>2.5</sub>), particulate matter with an aerodynamic diameter less than or equal to 10 microns (PM<sub>10</sub>), and volatile organic compounds (VOC) as well as revised BACT limits for nitrogen oxides (NO<sub>x</sub>) for engines on the *Developer* based on recent source test data for these pollutants that was not available at the time of permitting. Statoil has also requested that the modification decrease the total fuel consumption limit for the *Developer* and change the possible drilling locations for the *Developer* to include additional lease blocks in the same general area. The permit revision does not constitute a modification to the emission units or operation of the facility. Permit conditions unrelated to the *Developer's* updated BACT limits for PM<sub>10</sub>, PM<sub>2.5</sub>, VOCs, and NO<sub>x</sub> and operating location have not been modified in this draft permit except where necessary for clarification or to correct typographic errors.

EPA Region 4 is the agency responsible for implementing and enforcing CAA requirements for OCS sources in the Gulf of Mexico east of longitude 87.5°. Pursuant to section 328 of the CAA, (42 U.S.C. §7627), and the air quality regulations applicable to OCS sources set forth in Title 40, Code of Federal Regulations, part 55, this project is required to obtain an OCS air quality permit and is subject to Prevention of Significant Deterioration and title V operating permit requirements that apply to major sources. Certain changes to such permits require public notice. EPA has prepared draft modifications to the permit for public comment, as well as a preliminary determination and statement of basis document that explains our review of the application and changes to the permit conditions. The maximum potential annual emissions in tons per year for the project are detailed in the application materials and preliminary determination/statement of basis and are also summarized in the project fact sheet.

Permit Documents: EPA has prepared a draft permit modification for public comment, as well as a preliminary determination/statement of basis document that explains the revised permit conditions. EPA's draft permit modification and preliminary determination/statement of basis, Statoil's application and supporting documentation/data, and comments received from the public, other government agencies, and the applicant during the public comment period will become part of the administrative record for the permit. All data submitted by the applicant is available as part of the administrative record. Public Comments: All comments on the draft permit modification must be received by email at [R4OCSpermits@epa.gov](mailto:R4OCSpermits@epa.gov), submitted electronically via [www.regulations.gov](http://www.regulations.gov) (docket # EPA-R04-OAR-2014-0510) or postmarked by August 8, 2014. Comments sent by mail should be addressed to: USEPA Region 4, Air Permits Section APTMD, 61 Forsyth Street, SW, Atlanta, GA 30303 Attn: Rosa Yarbrough. An extension of the 30-day comment period may be granted if the request is submitted during the 30-day public comment period and it adequately demonstrates why additional time is required to prepare comments.

Any interested person may submit written comments on the draft permit modification during the public comment period. If you believe that any of the modified conditions in the permit are inappropriate, you must raise all reasonably ascertainable issues and submit all reasonably available arguments supporting your position by the end of the comment period. Any documents supporting your comments must be included in full and may not be incorporated by reference unless they are already part of the record for this permit or consist of state or federal statutes or regulations, EPA documents of general applicability, or other generally available reference materials. Comments should focus on the draft revisions to the air quality permit. If you have comments regarding offshore leasing, non-air quality impacts, drilling safety, or other similar issues not subject to this public comment period, you should submit them during the leasing and approval proceedings of the Bureau of Ocean Energy Management, which is the lead agency for offshore drilling.

All timely comments will be included in the administrative record without change and will be made available to the public, including any personal information provided, unless the comment includes Confidential Business Information or other information whose disclosure is restricted by statute. Information that you consider Confidential Business Information or otherwise protected should be clearly identified as such and should not be submitted through email. If you send email directly to EPA, your email address will be captured automatically and included as part of the public comment. An email or postal address must be provided with your comments if you wish to receive direct notification of EPA's final decision regarding the permit and response to comments submitted during the public comment period. All timely comments on the draft permit modification will be considered in making the final decision. EPA will respond to all significant comments on the proposed permit and may summarize and group similar comments in our response. EPA will not respond to individual commenters directly.

**Public Hearing:** Public Hearing requests must be in writing and received by EPA by July 31, 2014. Requests should be sent by email to R4OCSpermits@epa.gov or by mail addressed to: USEPA Region 4, Air Permits Section, 61 Forsyth Street, SW, Atlanta, GA 30303, Attn: Rosa Yarbrough. EPA will hold a public hearing on the draft permit modification, pursuant to 40 CFR 124.12, if EPA determines that there is a significant degree of public interest in the draft permit modification. Requests for a public hearing must state the nature of the issues proposed to be raised in the hearing. If a public hearing is held, you may submit oral and/or written comments on the permit modification at the hearing. You do not need to attend the public

hearing to submit written comments. If EPA determines that there is a significant degree of public interest, EPA will hold a public hearing from 5:30 p.m. to 7:00 p.m. on August 14, 2014, at: Bay County Public Library, Northwest Regional Library System, 898 W 11th Street, Panama City, FL 32412-0625; (850)522-2119.

If a public hearing is held, the public comment period will automatically be extended to the close of the public hearing. If no timely request for a public hearing is received, or if EPA determines that there is not a significant degree of public interest, a hearing will not be held. Such an announcement will be emailed to our OCS public notice list and posted on EPA's website given above, or you may call EPA at (404)562-9643 to determine if the hearing will not be held.

If a public hearing is held, EPA staff will be available prior to the hearing from 4:00-5:30 p.m. to answer questions and provide information on this proposed action during an informal public information session. You are not required to attend the information session to comment at the public hearing, and you may also obtain additional information about the project at EPA's website listed above.

**Final Determination:** A final decision to modify the permit or to deny the application for the permit modification shall be made after all timely and relevant comments have been considered. Notice of the final decision shall be sent to each person who has submitted written comments or requested notice of the final permit decision, provided EPA has adequate contact information.
