(1) Inmates shall utilize the informal grievance process prior to initiating a formal grievance. Inmates may skip this step and initiate the process at the formal institutional level for issues pertaining to the following: grievance of an emergency nature, grievance of reprisal, grievance alleging violations of the Americans with Disabilities Act, medical grievance, grievance involving gain time governed by Rule 33-601.101, F.A.C. Incentive Gain Time, grievance challenging placement in close management or subsequent reviews, grievances regarding the return of incoming mail governed by subsection 33-210.101(14), F.A.C., grievances regarding disciplinary action (does not include corrective consultations) governed by Rules 33-601.301-.314, F.A.C., and grievances regarding allegations of sexual abuse as defined in subsection 33-103.002(17), F.A.C. Inmates may proceed directly to the Office of the Secretary on the following issues as governed by subsection 33-103.007(6), F.A.C.: grievance of emergency nature, grievance of reprisal, protective management, admissible reading material, sentence structure issues (release date calculations), and inmate banking issues. Grievances alleging a violation of the Health Insurance Portability and Accountability Act (HIPAA) must be filed directly with the Office of the Secretary using the Request for Administrative Appeal, Form DC1-303, Request for Administrative Remedy or Appeal. Form DC1-303 is incorporated by reference in Rule 33-103.006, F.A.C.

- (a) An informal grievance shall be submitted to the designated staff by placing the informal grievance in a locked grievance box. Locked boxes shall be available to inmates in open population and special housing units. A staff person from classification, the grievance coordinator's office, or the assistant warden's office shall be responsible for the key. If the staff member collecting the grievances is from classification or the assistant warden's office, he or she shall retrieve the grievances and appeals and deliver them to the institutional grievance coordinator in a locked container. The warden shall designate one (1) staff member who shall log all informal grievances and distribute to the appropriate department or staff. Grievances shall be picked up and forwarded by the institutions daily Monday through Friday.

- (1) When an inmate decides to file a formal grievance, he or she shall do so by completing Form DC1-303, Request for Administrative Remedy or Appeal, and filing within the time limits set forth in Rule 33-103.011, F.A.C. Form DC1-303 is hereby incorporated by reference. Copies of this form are available from the Forms Control Administrator, 501 South Calhoun Street, Tallahassee, Florida 32399-2500. http://www.flrules.org/Gateway/reference.asp?No=Ref-03315. The effective date of the form is 11-13.
- (a) In institutions and private correctional facilities, inmates shall direct this form to the warden or assistant warden or deputy warden as defined in paragraph <u>33-</u>103.002(15) <u>33-103.002(14)(b)</u>, F.A.C.

- <u>64B16-28.608</u> Automated Filling Systems within a Pharmacy.
- (1) Definitions. The following definitions shall be applicable for purposes of this rule:
- (a) "Automated filling system" means an automated system used within a pharmacy to assist in filling a prescription drug order by selecting, labeling, filling, or sealing medication for dispensing. An "automated filling system" shall not include automated devices used solely to count medication, vacuum tube drug delivery systems, or systems governed by Rule 64B16-28.606 or 64B16-28.607, F.A.C.
- (b) "Electronic verification process" means an electronic verification, bar code verification, weight verification, radio frequency identification (RFID), or similar electronic process or system that accurately verifies medication has been properly dispensed and labeled by, or loaded into, an automated filling system.
- (c) "Manufacturer Unit of Use Package" means a drug dispensed in the manufacturer's original and sealed packaging, or in the original and sealed packaging of a repackager, without additional manipulation or preparation by the pharmacy, except for application of the pharmacy label.
- (d) "Repackager" means a repackager registered with the United States Food and Drug Administration (FDA), as defined by Section 499.003(50), F.S.
- (e) "Prepacked" means any drug that has been removed from the original packaging of the manufacturer or an FDA Repackager and is placed in a container for use in an automated filling system, as referenced by Section 499.003(42), F.S.
- (f) "Load" means assigning new medications for new NDC numbers to the system, which must be completed by an onsite pharmacist.
- (2) Medication Stocking. Automated filling systems (hereinafter "system") may be stocked or restocked by a pharmacist, pharmacy intern, or registered pharmacy

- technician under the supervision of a pharmacist, as each are defined by subsection 64B16-27.1001(7), F.A.C.
- (3) Medication Loading. System must be loaded by an onsite pharmacist.
- (4) Verification. Except as provided herein, a licensed pharmacist must verify the accuracy of the final contents of any medication filled or packaged by a system, and any label affixed thereto, prior to dispensing, as defined by subsection 64B16-27.1001(3), F.A.C.
- (5) The pharmacist verification requirements of subsection (4) shall be deemed satisfied if:
- (a) The pharmacy establishes and follows a policy and procedure manual that complies with subsection (6) of this rule;
- (b) The system is fully automated from the time the medication is loaded into the machine until a completed, labeled and sealed prescription is produced by the system that is ready for dispensing to the patient. No manual intervention with the medication may occur after the medication is loaded into the system. For purposes of this section, manual intervention shall not include preparing a finished prescription for mailing, delivery, or storage;
- (c) A pharmacist must perform a prospective drug review and verify the accuracy of the prescription information used by or entered into the system for a specific patient prior to initiation of the automatic fill process. The name, initials or identification codes(s) of the verifying pharmacist shall be recorded in the pharmacy's records and maintained for four (4) years after dispensing, or longer if required by applicable law;
- (d) All medication Prepacked by the pharmacy must be verified by a pharmacist pursuant to subsection 64B16-27.1001(3), F.A.C.
- (e) A pharmacist verifies the correct medication, either the Manufacturer Unit of Use Package, Repacked, or Prepacked container, was properly stocked, filled and loaded in the system. Alternatively, an electronic verification process may be used to verify a manufacturer unit of use package, repackaged, or prepacked containers;
- (f) The medication to be dispensed is selected, filled, labeled, or sealed in the prescription container by the system or dispensed by the system in a manufacturer's unit of use package, repacked, or prepacked container;
- (g) An electronic verification process is used to verify the proper prescription label has been affixed to the correct medication, prepackaged medication or manufacturer unit of use package for the correct patient; and
- (h) An audit trail is maintained for the prescription from the beginning of the system to the dispensing from the system, and maintain for four (4) years.

- (6) Policies and Procedures. Pharmacies verifying prescriptions pursuant to subsection (5) of this rule shall establish and follow written policies and procedures to ensure the proper, safe, and secure functioning of the system. Policies and procedures shall be reviewed annually by the prescription department manager or consultant pharmacist of record and shall be maintained in the pharmacy's records for a minimum of four (4) years. The required annual review shall be documented in the pharmacy's records and made available upon request. At a minimum, the pharmacy shall establish and follow policies and procedures for:
- (a) Maintaining the system and any accompanying electronic verification system in good working order;
- (b) Ensuring accurate filling, loading, and stocking of the system;
- (c) Ensuring sanitary operations of the system and preventing cross-contamination of cells, cartridges, containers, cassettes, or packages;
- (d) Testing the accuracy of the system and any accompanying electronic verification system. At a minimum, the system and electronic verification process shall be tested before the first use of the system or restarting the system and upon any modification to the system or electronic verification process that changes or alters the filling or electronic verification process;
- (e) Training persons authorized to access, stock, restock, or load the system in equipment use and operations;
- (f) Conducting routine and preventive maintenance and, if applicable, calibration;
- (g) Removing expired, adulterated, misbranded or recalled drugs;
- (h) Preventing unauthorized access to the system, including assigning, discontinuing or changing security access;
- (i) Identifying and recording persons responsible for stocking, loading and filling the system;
- (j) Ensuring compliance with state and federal law, including, all applicable labeling, storage, and security requirements;
- (k) Maintaining an ongoing quality assurance program that monitors performance of the system and any electronic verification process to ensure proper and accurate functioning, including tracking and documenting of automated filling system errors that are not corrected prior to dispensing to the patient. Such documentation shall be maintained for four (4) years and produced to the Board upon request.
- (7) Recordkeeping. Except as otherwise provided herein, records required by this rule shall be maintained in the pharmacy's records electronically or in writing for a minimum

of four (4) years, or longer if required under applicable law. If the verification requirements of paragraph (5)(d) of this rule are completed by a pharmacist, the name, initials or identification code(s) of the verifying pharmacist shall be recorded in the pharmacy's records and maintained for four (4) years after dispensing. Records shall be made available for inspection and produced to the Board or the Board's authorized designee upon request.

Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 39, No. 245, December 19, 2013 issue of the Florida Administrative Register.

- 1S-2.030 Absentee Ballots <u>for Absent Stateside</u> <u>Uniformed Services and Overseas (Uniformed Services and Civilian)</u>
- (1) Application. This rule applies solely to the request, delivery and return of absentee ballots for uniformed services voters who are absent stateside and overseas voters as defined in Section 97.021, F.S. Absent stateside uniformed services voters are those absent uniformed services voters as defined in Section 97.021, F.S., who are absent but are not overseas from the place of residence where the voter is otherwise qualified to vote.
- (2) Requests. A request for an absentee ballot shall be submitted in accordance with Section 101.62(1), F.S., which may be by phone or in writing (such as mail, fax, e mail or

online). In addition to the information required by Section 101.62(1), F.S., the request for an absentee ballot must also include the following information:

- (a) The voter's requested method of delivery for the blank absentee ballot (by mail or electronic means such as fax, e-mail or online).
- (b) The corresponding destination, whichever is applicable, to either <u>mail</u>, transmit the blank ballot or communicate how to access the blank ballot electronically by some other means:
- 1. <u>For mail delivery:</u> An applicable out-of-county mailing address or an APO/FPO or other deliverable overseas mailing address.
- 2. <u>For fax delivery:</u> A fax machine number and an applicable out-of-county address or <u>overseas</u> out of country address (only for purposes of affirming absence from the county or the United States), or <u>affirmation of overseas</u> location.
- 3. For email or online delivery: An e-mail address and an applicable out-of-county address or overseas out of country address (only for purposes of affirming absence from the county or the United States), or affirmation of overseas location.
- (3) Processing requests. When a supervisor receives an absentee ballot request from an absent stateside uniformed services voter or overseas voter, the supervisor shall:
- (a) Verify the information provided to determine if the voter is a qualified and registered voter for the election.
- (b) Provide, in accordance with the timeframes in Section 101.62, F.S., the appropriate absentee ballot, the instructions for voting and returning the ballot, and the Voter's Certificate by the means requested by the voter in subsection (2).
- (c) Record the receipt date of the request, the date and manner in which the <u>absentee</u> Supervisor of Elections made the absentee ballot was made available to the voter, and the corresponding delivery destination or manner mailing address, email address, fax number or other delivery destination to which the blank ballot was provided to the voter.
- (d) Ensure that the Supervisor of Elections' office's transmitting and receiving equipment is in a secure location with access limited to the supervisor's employees and that the absentee ballot is sent directly to the specified delivery destination requested by the voter. It is the voter's responsibility to ensure the security of the receiving equipment (e.g., facsimile machine, or computer, or receiving unit).
 - (4) Return of Voted Absentee Ballot.
- (a) An overseas voter has the option to return the voted ballot and signed certificate by mail, by fax, in person-(if he or

she returns to county of residence) or through someone else on behalf of the voter pursuant to the ballot instructions in subsection (7). If the overseas voter returns the ballot by fax, the ballot and Voter's Certificate must be sent directly to the fax number provided by the <u>S</u>supervisor of <u>E</u>elections or to a fax number provided by Federal Voting Assistance Program of the Department of Defense.

- (b) An absent stateside uniformed services voter may return the voted ballot and signed Voter's Certificate only by mail, in person (if he or she returns to the county of residence), or have it returned in person by someone else pursuant to the ballot instructions in subsection (7).
- (c) No voted absentee ballot returned by email shall be counted. A voted ballot by fax from an absent stateside uniformed voter shall not be counted.
 - (5) Deadline to Return Absentee Ballot.
- (a) To be accepted and counted, a voted absentee ballot from an absent stateside uniformed services voter must be received by the <u>S</u>supervisor of <u>Elections</u> no later than 7:00 p.m. election day in the time zone for the county in which the voter is registered.
- (b) For Ooverseas voters only casting ballots in a presidential preference primary or and general elections, are allowed a 10-day extension exists. The ballot must be postmarked or dated no later than election day and received by the Supervisor of Eelections of the county in which the voter is registered no later than 10 days after election day.
- (6) Voter's Certificate. The Voter's Certificate for absentee ballots to all absent stateside uniformed services and overseas voters shall be substantially as follows:

- 1. A member of the Uniformed Services or Merchant Marine on active duty; or an eligible spouse or dependent of such a member; or a U.S. citizen temporarily residing outside the U.S.; or other U.S. citizen residing outside the U.S.; and
- 2. I am a U.S. citizen, at least 18 years of age (or will be by the date of the election), and I am eligible to vote in the requested jurisdiction; and
- 3. I have not been convicted of a felony or other disqualifying offense or been adjudicated mentally incompetent, or if so, my voting rights have been reinstated; and
- 4. I am not registering, requesting a ballot, or voting in any other jurisdiction in the U.S.

In voting, I have marked and sealed my ballot in private and have not allowed any person to observe the marking of the ballot, except for those authorized to assist voters under State or Federal law. I have not been influenced.

My signature and date below indicate when I completed this document.

(7) Ballot Instructions. The instructions to be sent with the absentee ballot to all absent stateside uniformed services and overseas voters shall substantially contain the following statements:

INSTRUCTIONS READ THESE INSTRUCTIONS CAREFULLY BEFORE MARKING BALLOT VERY IMPORTANT

- (a) In order to ensure that your absentee ballot will be counted, complete, sign, date and return the ballot and Voter's Certificate as soon as possible to the <u>S</u>supervisor of <u>E</u>elections of the county in which you are registered. <u>Overseas voter only:</u> It must be received no later than 7:00 p.m. on election day in the time zone for the county in which you are registered. If you are an overseas voter casting a ballot in a presidential preference primary or general election, an <u>10-day</u> extension applies, provided your absentee ballot is postmarked or dated no later than election day and received <u>no later than 10 days after the election</u> by the <u>S</u>supervisor of <u>E</u>elections of the county in which you are registered to vote <u>no later than 10 days after election</u>.
- (b) Mark your ballot in secret as instructed on the ballot. You must mark your own ballot unless you are unable to do so because of blindness, disability, or inability to read or write.
- (c) Mark only the number of candidate or issue choices for a race as indicated on the ballot. If you are allowed to "Vote for One" candidate and you vote for more than one candidate, your vote in that race will not be counted.
- (d) Sign and date the Voter's Certificate. If you do not sign or date the Certificate, your ballot may not count. If your signature on the Voter's Certificate does not match your signature on record, your ballot will not count. If you need to update your signature for this election, you must send your signature update on a voter registration application to your Supervisor of Eelections so that it is received before absentee ballots are canvassed which could start as early as 15 days before election day.

- (e) Mail, deliver, or have delivered the completed mailing envelope with the voted absentee ballot and the Voter's Certificate. To mail or have your voted absentee ballot and Voter's Certificate delivered to the Ssupervisor of Eelections:
- 1. Place your marked ballot in the secrecy envelope or sleeve provided to you. If the ballot was provided to you other than by mail, use an unmarked envelope as a secrecy envelope. Seal the envelope. Do not seal the Voter's Certificate in the secrecy envelope or sleeve with the ballot.
- 2. Insert the secrecy envelope or sleeve or unmarked envelope into a inside the separate mailing envelope or the provided return envelope. and Ceompletely fill out the Voter's Certificate on the back of that mailing envelope. Or ilf you received the ballot and certificate other than by mail, place the sealed secrecy envelope or sleeve or unmarked envelope and the completed Voter's Certificate in a separate mailing envelope. Clearly mark the mailing envelope "Absentee Ballot Enclosed".
- 3. Mail the ballot to the <u>S</u>supervisor of <u>E</u>elections. <u>If</u> <u>using your own envelope:</u> To mail your ballot free of postage, use the template <u>and printing instructions</u> provided at the following link: <u>http://www.fvap.gov/eo/overview/materials/forms</u> <u>http://www.fvap.gov/resources/media/returnenvelope.pdf</u>. <u>Print directly onto the mailing envelope or otherwise affix to the mailing envelope.</u> Otherwise, provide sufficient postage. If you are an overseas voter, be sure you include your overseas address on the return envelope.
- (f) If you are an overseas voter, you have the option to fax your absentee ballot and Voter's Certificate. Fax your voted ballot and signed and dated certificate to the <u>S</u>supervisor of <u>E</u>elections at (fax phone number) or to a fax number provided by the Federal Voting Assistance Program (FVAP) of the Department of Defense. If <u>you</u> faxing your ballot and certificate to <u>FVAP</u>, <u>ensure</u> <u>make sure that</u> FVAP has sufficient time to get the ballot and certificate to the <u>S</u>supervisor of <u>E</u>elections by the 7:00 p.m. or 10-day deadline, whichever is applicable. If your fax your voted ballot, you will be voluntarily waiving your right to a secret ballot.
- (g) Voted ballots returned by regular electronic mail (email) will not be counted. A voted ballot returned by fax from an absent stateside uniformed services voter will not be counted.
 - (h) No change.
 - (8) Processing Returned Absentee Ballots.
- (a) <u>For each voted absentee ballot received, t</u>The <u>S</u>supervisor <u>of Elections</u> must record for each voted absentee ballot received the date of receipt and the manner of return.
- (b) Upon receipt by mail of a voted absentee ballot in an envelope other than an absentee ballot mailing envelope

provided by the supervisor, the canvassing board is authorized to open the mailing envelope to determine if the Voter's Certificate is enclosed in the mailing envelope. If the Voter's Certificate is not enclosed, the secrecy envelope containing the ballot shall not be opened and the envelope shall be marked "Rejected as Illegal." If the Voter's Certificate is enclosed, the supervisor of elections shall verify the overseas voter's eligibility, and once verified, the ballot shall be processed as other absentee ballots. tThe Voter's Certificate shall be reviewed and processed in accordance with Section 101.68, F.S.

- (c) No change.
- (d) Upon receipt by fax of a voted absentee ballot from an overseas voter, the <u>S</u>supervisor of <u>E</u>elections shall enclose the ballot in an envelope and seal it in order to preserve secrecy. The Voter's Certificate shall be attached to the envelope, and later reviewed, and processed in accordance with Section 101.68, F.S. Upon a determination by the canvassing board that the voter was eligible to vote, the ballot shall be removed from the envelope and duplicated so that it can be processed through the tabulating equipment.
- (9) Confidentiality. The Ssupervisor of Eelections and the supervisor's staff shall take the steps necessary to keep the voted absentee ballots received by fax as confidential as possible.
