Vessel Registration and Boating Safety

RULE NO.: 68D-24.018 RULE TITLE: St. Johns River Boating Restricted Areas

PURPOSE AND EFFECT: The purpose and effect of this rule amendment is to address needed changes to the boating restricted areas created by this rule. Additionally, the purpose is to address rule changes governing vessel speeds on the St. Johns River in Lake, Seminole and Volusia counties, where necessary, to manage this waterway and promote its use for safe boating. Staff has identified several needed changes, to include, but not limited to: repealing regulations in the tributaries of South Moon and Jungle Den Canals; making minor changes to the footprints of the State Road 40 (Astor) Bridge, State Road 44 (Whitehair) Bridge and Lake Monroe boating restricted areas; clarifying and modifying the geographic descriptions for seven zone boundaries; updating the rule maps, and removing the authority for Lake, Seminole and Volusia counties to mark the state-adopted year-round boating restricted areas.

SUMMARY: The rule amendment modifies seven zones in the Florida Intracoastal Waterway on the St. Johns River in a manner which maintains the existing footprint of each zone as currently marked. The amendment modifies the locations used to describe zone boundaries, increases the regulated vessel speed in the year-round zones from “Idle Speed No Wake” to “Slow Speed Minimum Wake,” repeals duplicative regulations in two tributaries, updates rule maps, removes the authority for Lake, Seminole and Volusia counties to mark the state-adopted

year-round boating restricted areas and includes language to exclude water bodies such as canals and boat basins.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The proposed rule will match zone boundaries established in the rule to historical boundaries established by regulatory markers. The proposed rule will allow marginally faster vessel speeds through regulatory zones.

(1) For the purpose of regulating the speed and operation of vessel traffic on the St. Johns River in Lake, Seminole and Volusia Counties, Florida the following ~~b~~Boating ~~r~~Restricted ~~a~~Areas are established. Coordinates used in the description of zone boundaries are referenced to the North American Datum of 1983 (NAD83). The boating restricted areas exclude all associated tributaries, creeks, canals, backwaters, channels, boat basins and other waterways unless otherwise designated or specifically described for inclusion:

(a) Year-Round Boating Restricted Areas –

1. Lake George Fender System: ~~An Idle Slow Speed Minimum No Wake zone boating restricted area~~ within the fender system and associated channel at the south end of Lake George, bounded on the north by ~~from~~ a line drawn perpendicular to the centerline of the channel at the north end

of the fender system ~~and bounded on the southeast by~~ ~~to~~ a line drawn perpendicular to the centerline of the channel 1,500 feet south and southeast of the south end of the fender system, as depicted in Drawing A.

2. South Moon Canal:

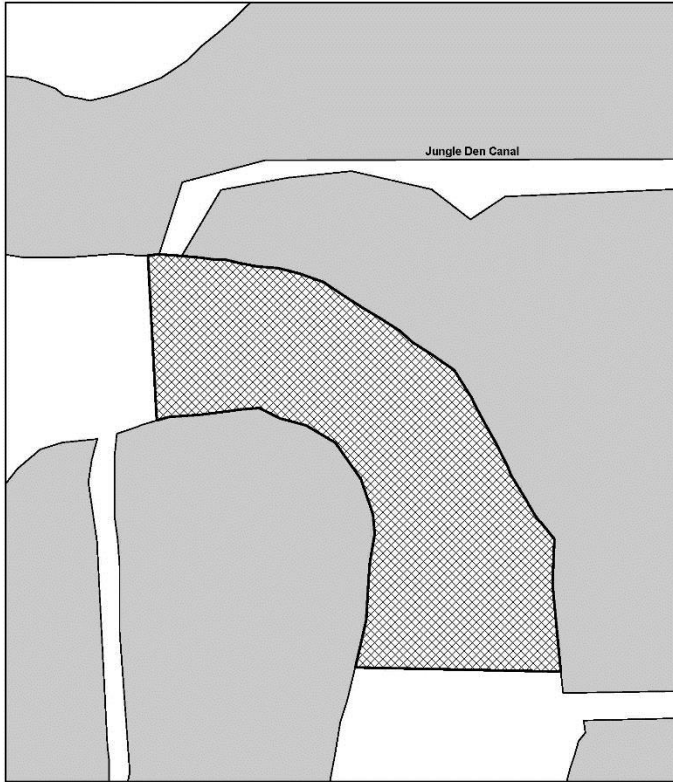




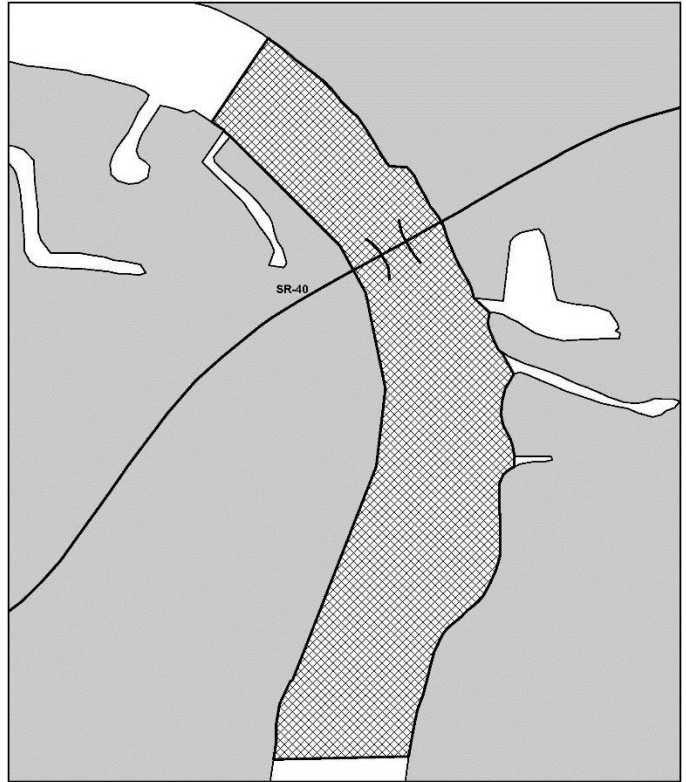




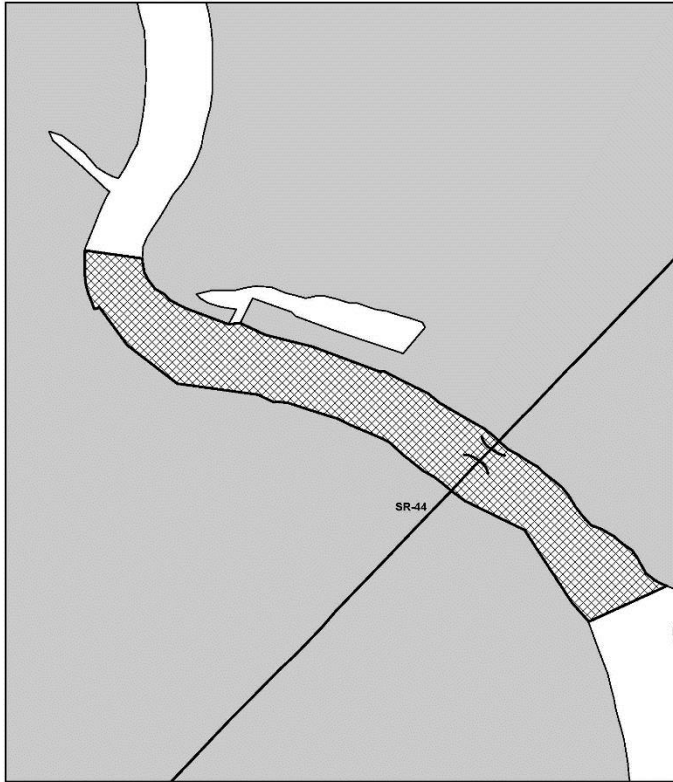




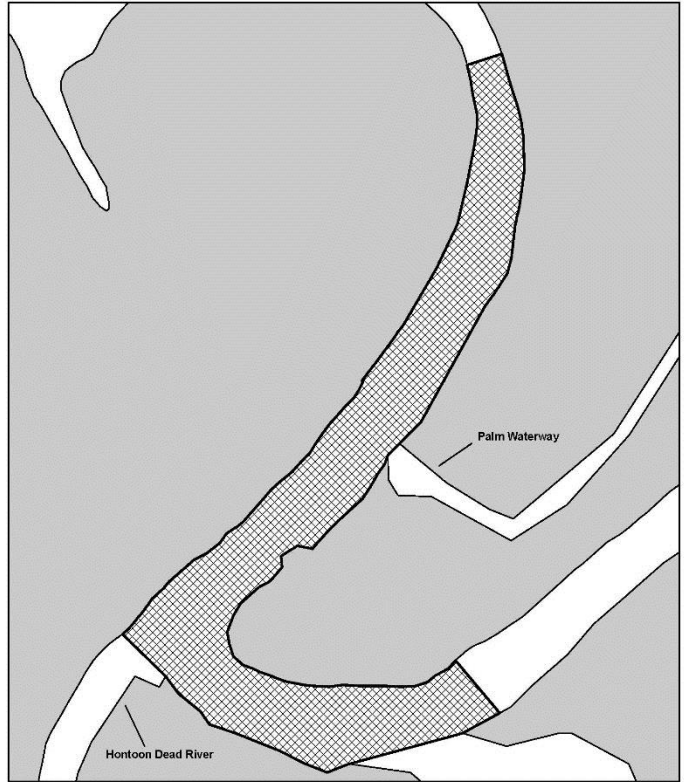
Drawing C - Jungle Den Canal

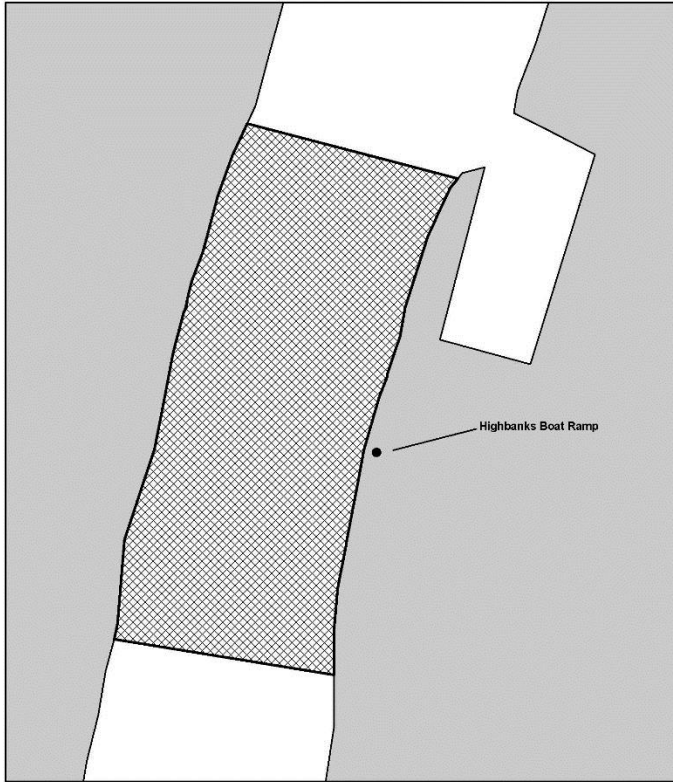


Drawing E - SR 44 (Whitehair) Bridge
[Cross-hatch symbol] Slow Speed Minimum Wake



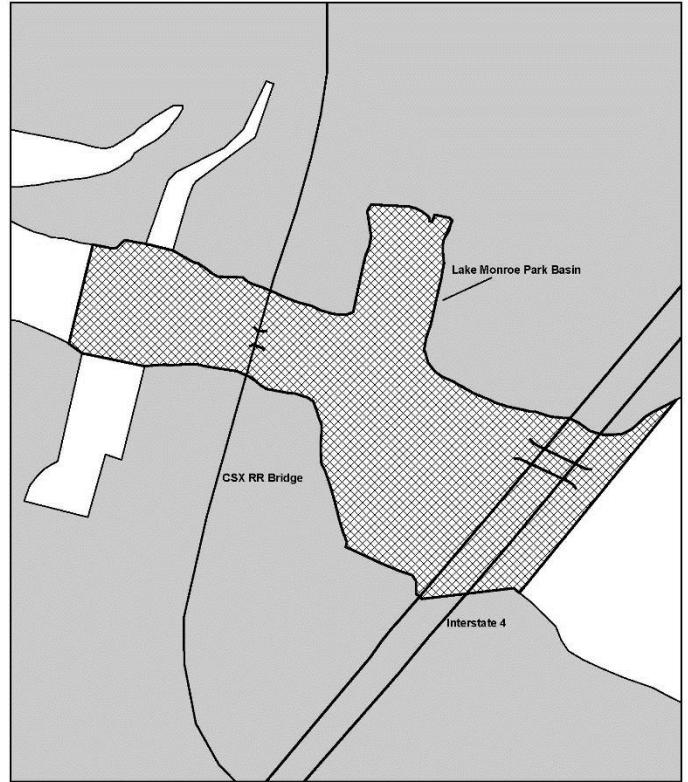
Drawing F - Hontoon Island State Park
[Cross-hatch symbol] Slow Speed Minimum Wake





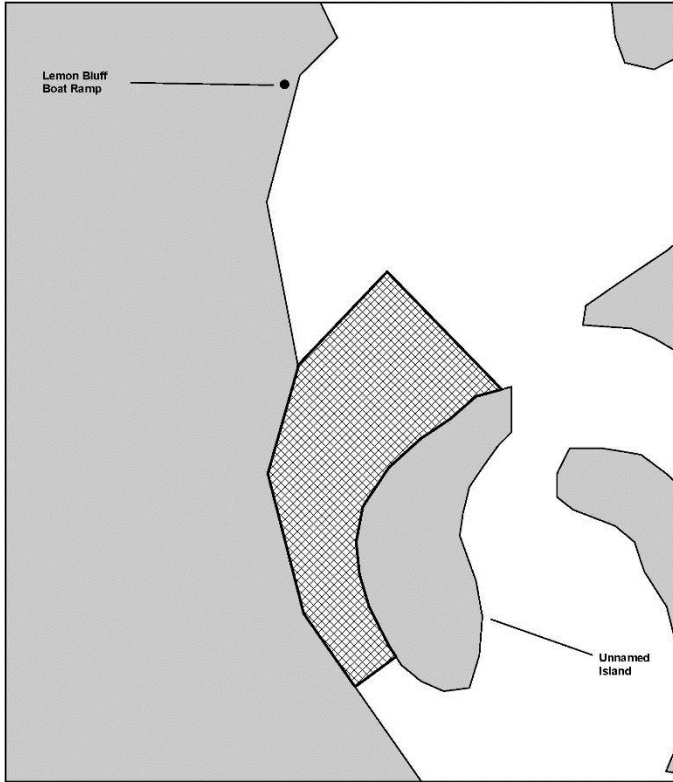
Drawing G - Highbanks Boat Ramp

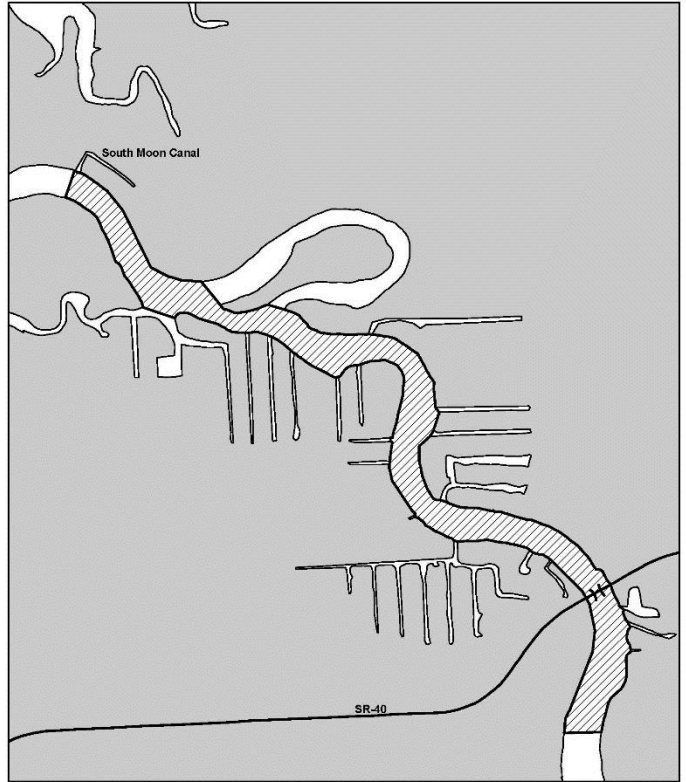


Drawing H - Lake Monroe

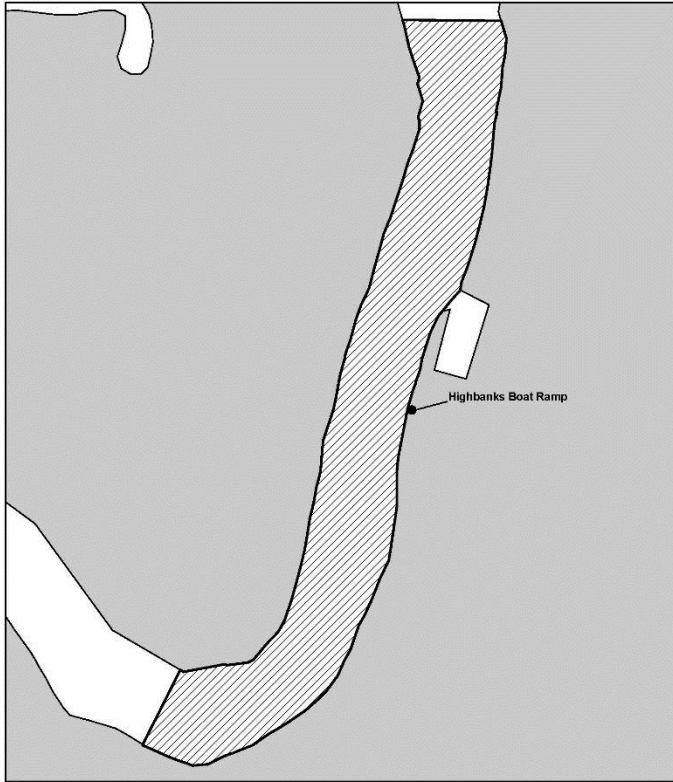


Drawing I - Lemon Bluff
[Hatched Box] Slow Speed Minimum Wake

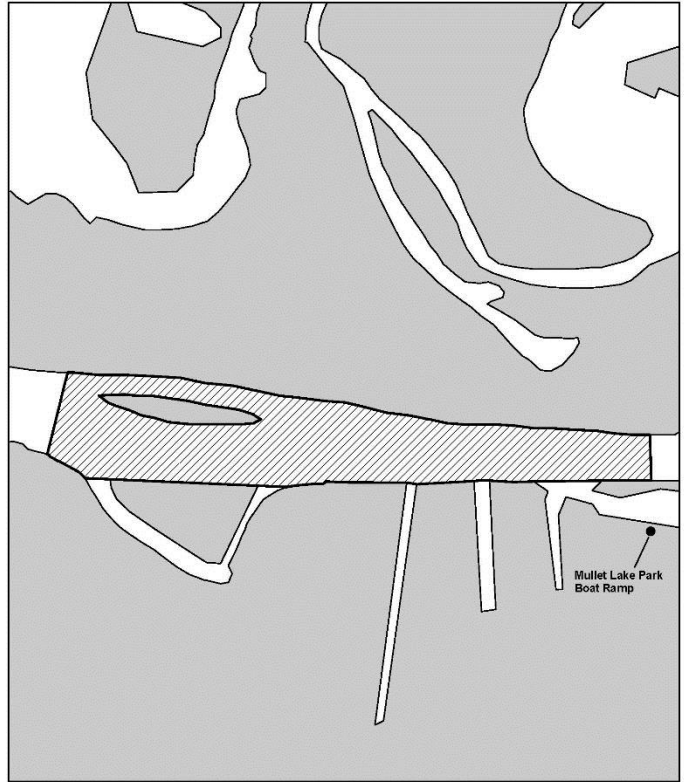


Drawing J - Astor
[Hatched Box] Idle Speed No Wake (During Flooding)



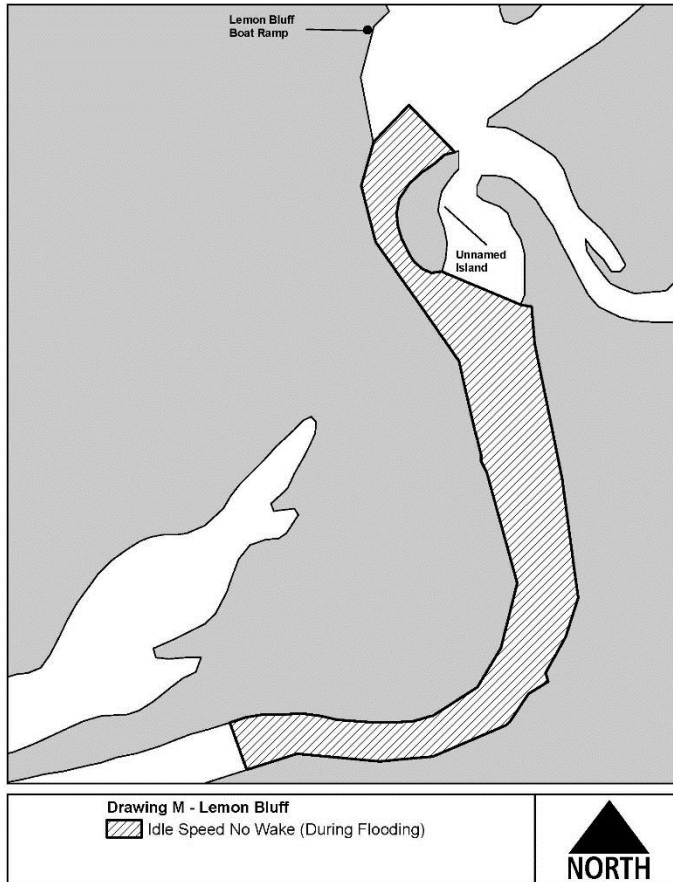


Drawing K - Highbanks Boat Ramp

The above referenced F.A.C. addresses the requirement that each establishment have an approved plumbing system installed to transport potable water and wastewater, at least one service sink for the cleaning of mops or similar cleaning tools and the disposal of mop water; dishwashing facilities for manually washing, rinsing and sanitizing equipment and utensils; an area for food preparation that has a conveniently located handwash sink and that food must be properly stored in a licensed establishment. They are requesting to install potable and wastewater holding tanks and utilize the mopsink, dishwashing, food storage and prep

facilities located within another licensed establishment under the same ownership.

The Petition for this variance was published in Vol. 40, No. 32, F.A.R., on February 17, 2014. The Order for this Petition was signed and approved on February 24, 2014. After a complete review of the variance request, the Division finds that the application of this Rule will create a financial hardship to the food service establishment. Furthermore, the Division finds that the Petitioner meets the burden of demonstrating that the underlying statute has been achieved by the Petitioner ensuring the wastewater holding tank for the handwash and three-compartment sinks is emptied at a frequency as to not create a sanitary nuisance; and potable water provided must come from an approved source and be protected from contamination during handling. The Petitioner shall also ensure the handwash and three-compartment sinks are provided with hot and cold running water under pressure; the handwash sink is provided with soap, an approved hand drying device and a handwashing sign. The Petitioner shall also ensure that the mop sink and dishwashing areas within The Pretzel Twister (DACS permit number 1500809) are maintained in a clean and sanitary manner, all sinks are provided with hot and cold running water under pressure and are available during all hours of operation. The Petitioner shall also ensure the food storage facilities in The Pretzel Twister are maintained in a clean and sanitary manner and are capable of keeping time/temperature control for safety foods at the proper temperatures. If the ownership of The Pretzel Twister (SweetSun LLC) changes, a written agreement must be provided to the division immediately.
