The continuing education hour PDH is the common denominator for other units of credit. A continuing education hour is equivalent to a professional development hour (PDH).

~~(3) Continuing Education Unit (CEU): Unit of credit customarily used for continuing education courses. One continuing education unit equals 10 hours of class in an approved continuing education course.~~

(6) Vendor: An individual or business organization who sells products or services related to an engineering area of practice.

Topics on marketing, foreign language skills, and basic math skills below the requirements set forth in Rule 61G15-20.007(1)(a), F.A.C. are not acceptable and are excluded.
