The Final Order Granting Variance requires the petitioner to employ the control techniques outlined in EPA's Aerospace Control

Technique Guidelines (CTG) (EPA-453/R-97-004) in lieu of complying with the VOC content limits contained in Rule 62-296.513, F.A.C, the MMPP RACT Rule. The Petitioner has demonstrated to the satisfaction of the Department that compliance with the MMPP RACT Rule requirement will cause an unnecessary economic and technical hardship and may cause an adverse environmental impact as an add-on control device would be required that would produce secondary emissions of criteria pollutants such as NOx, CO, and PM due to the need for supplemental fuels while compliance with the applicable Aerospace CTG regulations is expected to yield lower facility-wide VOC emissions than the rule-specified technology for a considerably lower cost and without producing secondary emissions.
