- (1) The <u>licensee must facility shall</u> ensure proper nutritional care for its <u>clients residents</u>, whether provided by the <u>licensee facility</u> or a third party, and shall provide education and training in proper nutrition and planning and preparation of meals consistent with the individualized <u>client resident</u> rehabilitation plan. The facility must comply with the requirements of the Department of Health in Rule 64E 12.004, F.A.C.
- (2) Meals provided by the licensee must be planned based on the current USDA Dietary Guidelines for Americans, and the current daily US Dietary Reference Intakes established by the Food and Nutrition Board of the Institute of Medicine of the National Academy of Sciences. of fresh produce or the preferences of the clients No more than 14 hours shall lapse between the end of an evening meal and the beginning of the following morning meal containing a protein food. Intervals between other meals shall be not less than four hours no more than 6 hours.

- (4) Regular and therapeutic menus must Menus shall be dated, and planned at least one week in advance for both regular and therapeutic diets. Clients must be encouraged to participate in menu planning. Planned menus must be posted or easily available to clients. Regular and therapeutic menus as served, with substitutions noted before or when the meal is served, must be corrected as served and kept on file in the facility for six 6 months. Portion sizes must be indicated on the menus or on a separate sheet.
