64B13-4.001 Examination Requirements.

- (1) <u>Licensure Examination.</u> The licensure examination authorized in Section 463.006(2), F.S., shall consist of the following parts:
- (a) Part I—the Applied Basic Science (ABS) portion of the examination developed by the National Board of Examiners in Optometry (NBEO);
- (a)(b) Part II— The Patient Assessment and Management (PAM) portion of the examination developed by the National Board of Examiners in Optometry (NBEO) as Part II of its examination which includes an embedded Treatment and Management of Ocular Disease (TMOD) examination. An applicant for licensure in Florida must obtain a passing score on

the TMOD section of the examination <u>as well as an overall</u> passing score on the examination.;

(b)(e) Part III— Tthe Clinical Skills (CSE) portion of the examination developed by the NBEO as Part III of its examination. In addition to an overall passing score on the CSE portion, an applicant for licensure in Florida must obtain a score of 75 percent (75%) or better on each of the Biomicroscopy, Binocular Indirect Ophthalmoscopy, and Dilated Biomicroscopy and Non Contact Fundus Lens Evaluation skills individually; and

(c)(d) Part IV Aa written examination on applicable Florida laws and rules governing the practice of optometry developed yearly by Florida Board of Optometry approved consultants in conjunction with NBEO, and administered by NBEO as Part IV of its examination. The Board shall review and approve the content of the laws and rules examination annually. A score of eighty-four percent (84%) or better must be obtained in order to achieve a passing score on Part IV of the NBEO examination.

- (d) The Florida Practical Examination. The Florida Practical Examination shall be developed by consultants approved by the Florida Board of Optometry in conjunction with the NBEO, and shall be administered by the NBEO as part of the NBEO National Clinical Skills examination.
- 1. Examiners for the Florida Practical Examination, and the grading criteria to be used by the examiners, shall be those selected by the NBEO to examine and grade the NBEO CSE.
- 2. The Florida Practical Examination shall consist of the following tested skills. Because the Board requires passage of all three (3) skills on the same test attempt, the three (3) skills are weighted equally.
  - a. Biomicroscopy
  - b. Binocular Indirect Ophthalmoscopy
- c. Dilated Biomicroscopy and Non-Contact Fundus Lens Evaluation
- 3. The passing score for each skill shall be seventy-five percent (75%) or better, and a passing score on each of the three (3) skills must be obtained on the same test attempt.
- (2) <u>Passing Scores</u>. An applicant for licensure must achieve a passing score on all four parts of the licensure examination <u>in order to be licensed in Florida</u>. Passing scores for <u>Part I, Part II, and Part III of the Florida Practical Examination and Laws and Rules portion of the NBEO licensure examination are <u>as set established</u> by <u>the Board in this rule NBEO</u>. For Part III, an applicant must receive an overall passing score on the CSE, as well as the required score of 75 percent (75%) or better on each of the three (3) individually identified skills, on the same test attempt. A score of 84 percent (84%) or better must be obtained in order to achieve a passing score on Part IV of the licensure examination. Passing scores for the Patient Assessment and</u>

Management portion and the Clinical Skills portion of the NBEO licensure examination are established by the NBEO.

(3) Certification Examination. A licensee applying for certification must obtain a passing score on either the TMOD examination embedded in the Patient Assessment and Management portion of the examination developed and administered by the NBEO or a passing score on the stand alone TMOD examination developed and administered by the NBEO. Petition to Establish the Big Island Community Development District

On September 27, 2017, the Florida Land and Water Adjudicatory Commission ("FLWAC" or "Commission") received a petition to establish the Big Island Community Development District ("District") to consist of 5,701 acres in St. Johns County, Florida. The Commission will follow the requirements of Chapter 42-1, F.A.C., and Chapter 190, F.S., as amended, in considering the petition.

SUMMARY OF CONTENTS OF PETITION: The petition requests establishment of the District covering approximately 5,701 acres of land located entirely within St. Johns County, Florida. The site is generally located north of State Road 16, south of County Road 210, west of Interstate 95, and east of County Road 16A.

SUMMARY OF ESTIMATED REGULATORY COSTS: A statement of estimated regulatory costs (SERC) was prepared at the request of the Petitioner. The complete text of the SERC is contained as Exhibit 7 to the petition. Generally, the SERC indicates the rule:

Is not expected to have any direct or indirect impact on economic growth, private sector job creation or employment, or private sector investment in excess of \$1 million in the aggregate within 5 years after the implementation of the rule; Is not likely to have any adverse impact on business competitiveness;

Is not likely to increase regulatory costs of the State or the County. The proposed District will pay a one-time filing fee to the County to offset any County expenses; and will pay the annually required Special District Filing Fee, which is meant to offset any State costs related to oversight of all special districts in the State. The District will incur overall operational costs related to services for infrastructure maintenance, landscaping and similar items. In the initial stages of development, the costs will likely be minimized. These operating costs will be funded by landowners through direct funding agreements or special assessments levied by the District;

Will require compliance by the State of Florida, St. Johns County, and current and future property owners;

Will not directly or indirectly result in any additional costs to the agency or any other state and local government entities other than those noted above and will have no anticipated effect on state or local revenues;

Will result in transactional costs to future landowners in the development to pay for facilities and services the District may provide. Financing for these facilities and services is projected to be provided by the District; and,

Will have no adverse impact on small businesses, counties or cities.

#### FINAL ORDER

#### APPROVING ISLAMORADA ORDINANCE NO. 17-09

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to sections 380.05(6) and 380.0552(9), Florida Statutes, approving land development

regulations adopted by the Islamorada, Village of Islands, Florida, Ordinance No. 17-09 (the "Ordinance").

#### FINDINGS OF FACT

- 1. The Florida Keys Area is designated by section 380.0552, Florida Statutes, as an area of critical state concern. Islamorada, Village of Islands, is a local government within the Florida Keys Area.
- 2. The Ordinance was adopted by Islamorada, Village of Islands, on August 24, 2017, and rendered to the Department on September 25, 2017.
- 3. The Ordinance amends the Islamorada, Village of Islands, Code of Ordinances to allow for up to four deed-restricted detached affordable housing units along U.S.-1 in the Residential Single Family (R1) and (R1M) zoning district.

#### CONCLUSIONS OF LAW

- 4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See sections 380.05(6) and 380.0552(9), Florida Statutes.
- 5. Islamorada, Village of Islands, is a local government within the Florida Keys Area of Critical State Concern. See section 380.0552, Fla. Stat.
- 6. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.
- 7. The Ordinance is consistent with the Islamorada, Village of Islands, Comprehensive Plan generally, and specifically Policy 1-2.3.3, Objective 3-1.1, and Policy 3-1.1.3, as required by section 163.3177(1), Florida Statutes.
- 8. All land development regulations enacted, amended, or rescinded within an area of critical state concern must also be consistent with the principles for guiding development for that area. See sections 380.05(6) and 380.0552(9), Florida Statutes. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in section 380.0552(7), Florida Statutes.
- 9. The Ordinance is consistent with the Principles for Guiding Development, as a whole, and is specifically consistent with the following Principle(s):
- (a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.
- (l) Making available adequate affordable housing for all sectors of the population of the Florida Keys.

WHEREFORE, IT IS ORDERED that the Department finds that the Islamorada, Village of Islands, Ordinance No. 17-09 is consistent with the Islamorada, Village of Islands, Comprehensive Plan and the Principles for Guiding

Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.

This Order becomes effective 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
