PURPOSE AND EFFECT: Florida Power and Light, Inc. (FPL), has submitted a petition to initiate rulemaking to establish a Site Specific Alternative Criterion (SSAC) for Total Ammonia Nitrogen (TAN) in the Northwest Mitigation Area wetlands and Barley Barber Swamp in Martin County, Florida. The waterbodies are both classified as Class III waters, with a designated use of "Fish Consumption; Recreation; Propagation and Maintenance of a Healthy, Well-Balanced Population of Fish and Wildlife." The draft SSAC is consistent with USEPA's Chronic Criterion Magnitude for TAN for waters where unionid mussels are absent and Early Life Stage fish protection is maintained. FPL has demonstrated that unionid mussels are not present in the mitigation area or Barley Barber Swamp. The draft rule amendment would revise the surface water quality criterion for TAN in these waterbodies. The draft SSAC for TAN is intended to fully protect its Class III designated use.

- (1) Each architect in Florida shall complete a minimum of 24 hours of continuing professional education, in health, safety and welfare related courses, per biennial period, as further defined in subsection (3) below. This requirement shall be met through either:
- (a) Programs approved by the Board, provided that a minimum of two (2) of the 24 required hours must be obtained by completing an approved provider's specialized or advanced course(s), approved by the board and Florida Building Commission, on the Florida Building Code, relating to the architect's respective area of practice; or
- (b) Submission of proof of compliance with the continuing education requirements of another state in which the architect is licensed, provided that the requirements of the other state equal or exceed the completion of 24 hours in a two year period, be that the education build upon the basic knowledge of architecture, and require that a minimum of two (2) of the 24 required hours be obtained by completing specialized or advanced course(s), approved by the board and Florida

Building Commission, on the Florida Building Code, relating to the architect's respective area of practice.
