60LER22-4 Amendment of Rule 60L-34.0071(3), F.A.C.
SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Executive Orders 22-218 and 22-219 declared a state of emergency for the State of Florida because Tropical Depression 9, which became Hurricane Ian, posed a severe threat to the State of Florida. Hurricane Ian caused catastrophic damage to parts of the State, which now necessitates timely precautions to protect the communities, critical infrastructure, and general welfare of this State.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: The procedure is fair in that it provides equal opportunity for additional administrative leave to state personnel system employees personally impacted by Hurricane Ian; provides at least the procedural protections given by other statutes, the State Constitution, or the United States Constitution; and takes only action that is necessary to protect the public interest under the emergency procedures in a manner that treats all similarly affected state employees fairly.

SUMMARY: This rule amends Rule 60L-34.0071(3), F.A.C., to provide an additional type of administrative leave related to Hurricane Ian.

The waiver would apply to NSLP, SBP, ASP, FFVP, SFSP, SSO, SMP sponsors throughout the state of Florida.

4. Description of the challenge the State agency is seeking to solve, the goal of the waiver to improve services under the Program, and the expected outcomes if the waiver is granted. [Section 12(l)(2)(A)(iii) and 12(l)(2)(A)(iv) of the NSLA]:

As sponsors respond to and recover from emergencies, it is important to reduce administrative burden to the fullest extent possible. FDACS desires to provide administrative and operational flexibility, where possible, while maintaining program integrity in providing nutritious meals during

emergency situations. A relief of these regulatory requirements will help us to better meet the needs of our customers.

Challenge without waiver

- Sponsors continue to face uncertainty in how to streamline operations while continuing to respond to disaster related challenges, especially power outages, flooding and school closures. Without these waivers, sponsors will spend an extraordinary amount of time completing activities related to regulatory burden rather than focusing on properly servicing students and children.

- Decreased program participation.
- Food insecurity will continue to be an issue for students and children.

Goal of Waiver to Improve Services

- Decrease some administrative pressures for the sponsor during this difficult time.
- Continued flexibility of the service options; non-congregate meals service, parent/guardian pick-up, meal service time, offer vs serve and meals at school sites provide sponsors the flexibility needed to continue to provide meals in response to emergency situations.
- Maintain sponsor and site program participation and minimize hunger in the local communities.

Expected Outcome of Waiver

- Sponsors will have an opportunity to transition back to normal operations over a longer period, which helps to assure success.
- Sponsors will implement flexibilities, as needed, to minimize the negative impact on program participation because of emergencies.
- Simplify program administration for the sponsors, so they can focus on the highest priority needs of their program/sites.

- Meals at School Sites for Unanticipated School Closures in SY 2022-23 [42 U.S.C. 1761(c)(1) and 7 CFR 225.6(d)(1)(iv)] (October 1, 2022 – April 30, 2023)

- Allow schools/site to operate open sites in areas that are not located in “Areas in which poor economic conditions exist,” as defined at section 13(a)(1)(A) of the Richard B. Russell National School Lunch Act (NSLA) and as referenced at 42 U.S.C. 1761(a)(1)(A)(i) and in regulation at 7 CFR 225.2, 7 CFR 225.6(c)(2)(i)(G), 7 CFR 225.6(c)(3)(i)(B), 7 CFR 225.6(d)(1)(i), 225.14(c)(3), and 7 CFR 225.16(b)(4).

6. Detailed description of alternative procedures and anticipated impact on Program operations, including technology, State systems, and monitoring:

If approved, there are no significant impacts on technology or state systems. These waivers will allow NSLP, SBP, ASP, FFVP, SMP, SSO and SFSP sponsors in good standing to serve meals under during extraordinary cases due a disaster, in a non-congregate setting. Approval of these waivers will ensure that children have the nutrition needed during an unanticipated school closure due to an emergency and when the children return to school. Through trainings, visits and reviews, FDACS will maintain a track of sponsors that were approved to utilize these waivers during an emergency or extraordinary case related to it.

Anticipated impact:

The waivers will decrease the administrative burden, allow for efficient and effective oversight of program operation, and allow SFAs and SFSP sponsors to meet the needs of their families and children. The FDACS will continue to ensure program integrity through the application approval process and technical assistance visits.

If the waivers are not approved, the following impact will likely occur:

- The students and children will not have access to meals daily,

- The SFAs and SFSP sponsors will not receive funds by reimbursement, affecting their financial area, leading them to no comply with the program meal patterns, forcing them to close operations and
- Affect nutritional, physical and well-being families’ health.

7. Description of any steps the State has taken to address regulatory barriers at the State level. [Section 12(1)(2)(A)(ii) of the NSLA]:

The state agency has not had to address any barriers as these flexibilities were in place. If the waiver is not approved, there will be an increase in administrative burdens, an increase in

barriers to participation, and it will create a negative effect on program operations.

There are no anticipated challenges with waiver implementation for eligible sponsors.

EMERGENCY FINAL ORDER

Pursuant to sections 120.569(2)(n), 252.36, and 252.46, Florida Statutes, and upon consideration of the State of Florida Executive Order No. 22-218 and the following findings of fact, the State of Florida Department of Economic Opportunity ("Department") enters this Emergency Final Order ("Order"), including Findings of Fact and Conclusions of Law, in response to the imminent or immediate danger to the public health, safety, and welfare of the citizens of the State of Florida posed by Hurricane Ian (hereinafter "the Hurricane").

FINDINGS OF FACT

1. On September 23, 2022, by State of Florida Executive Order No. 22-218 ("Executive Order 22-218"), as amended by Executive Order No. 22-219 on September 24, 2022, the Governor declared that a state of emergency exists throughout the State of Florida based upon the serious threat to the public health, safety, and welfare posed by the Hurricane.
2. The Department has the ultimate authority over the administration of Florida's Reemployment Assistance (RA) Program pursuant to sections 20.60(5)(c)(3) and 443.1317(1)(a), Florida Statutes, and Chapters 73B-10 and 73B-11, Florida Administrative Code.
3. On October 1, 2022, the Department publicly announced that Disaster Unemployment Assistance (DUA) was available to Florida businesses and residents whose employment or self-employment was lost or interrupted as a direct result of the Hurricane.
4. DUA is available for individuals who are not eligible for regular RA benefits, pursuant to Chapter 443, Florida Statutes,

and whose employment was lost or interrupted as a direct result of the Hurricane.

5. The online work registration and reporting requirements of section 443.091(1)(b), Florida Statutes, generally apply to claimants seeking DUA and RA benefits.[\[1\]](#)

6. The work search reporting requirement of section 443.091(1)(d), Florida Statutes, generally applies to claimants seeking DUA and RA benefits.

7. The one week waiting period requirement of section 443.091(1)(f), Florida Statutes, applies only to RA claims.

8. The one week waiting period requirement of section 443.091(1)(f), Florida Statutes, does not apply to DUA claims.

9. Executive Order 22-218, recognizes that special duties and responsibilities rest upon some State, regional, and local agencies and other governmental bodies in responding to the emergency may require waiver or deviation from the statutes, rules, ordinances, and orders those agencies and governmental bodies administer.

Pursuant to Executive Order 22-218, the Department, as a State agency, may suspend the provisions of any state statute or regulation prescribing the procedures for conduct of state business or the orders or rules of the Department, if strict compliance with the provisions of any such statute, order, or rule would in any way prevent, hinder, or delay necessary action in coping with the effects of the Hurricane.

10. The Department finds that the Hurricane creates a state of emergency threatening the public health, safety, and welfare in the counties designated by the Federal Emergency Management Agency’s (FEMA) Disaster Declaration No. FEMA-4673-DR-FL. As a result of the emergency and for the administration of RA and DUA, it is necessary to immediately waive the online work registration and reporting requirements of section 443.091(1)(b), Florida Statutes, and the work search reporting requirement of section 443.091(1)(d), Florida Statutes. It is also necessary to immediately waive the one week waiting period requirement of section 443.091(1)(f), Florida Statutes, for RA claims. These waivers apply to the counties designated in FEMA Disaster Declaration No. FEMA-4673-DR-FL.

11. The Department finds that immediate, strict compliance with sections 443.091(1)(b), 443.091(1)(d), and 443.091(1)(f), Florida Statutes, for RA and DUA claims, as applicable, would prevent, hinder, or delay necessary action in coping with the emergency, and the actions authorized under this Order are narrowly tailored to address the immediate need for action and are procedurally appropriate under the circumstances.

CONCLUSIONS OF LAW

1. Based on the findings recited above, it is hereby concluded that the emergency caused by the Hurricane poses an immediate danger to the public health, safety, or welfare and requires an immediate order of the Department.

2. Pursuant to Executive Order 22-218 and sections 120.569(2)(n), 252.36, and 252.46, Florida Statutes, the Secretary, or designee, of the Department is authorized to issue this Emergency Final Order.

3. The waiver of sections 443.091(1)(b), 443.091(1)(d), and 443.091(1)(f), Florida Statutes, for RA and DUA claims, as applicable, is required so as not to prevent, hinder, or delay necessary action in coping with the emergency.

THEREFORE, IT IS ORDERED that for the counties designated in FEMA Disaster Declaration No. FEMA-4673-DR-FL, the online work registration and reporting requirements of section 443.091(1)(b), Florida Statutes, and the work search reporting requirement of section 443.091(1)(d), Florida Statutes, are hereby waived for RA and DUA claims. The one week waiting period requirement of section 443.091(1)(f), Florida Statutes, is hereby waived for RA claims for the counties designated in FEMA Disaster Declaration No. FEMA-4673-DR-FL. This Emergency Final Order shall take effect September 25, 2022, and shall expire on November 19, 2022, unless modified or extended by further order.
