<u>61G15-20.0011 Structural Engineering Recognition</u>
<u>Program For Professional Engineers</u>

Pursuant to Section 471.055, F.S., the Board establishes the following minimum requirements for Florida licensed professional engineers who specialize in structural engineering

and who have exceeded required minimum professional engineer licensing standards in that specialty area to receive recognition through the Structural Engineering Recognition Program for Professional Engineers.

- (1) Any professional engineer currently licensed in good standing in the state of Florida who desires Recognition as a Structural Engineer in Florida shall submit an online form to the Board. The form is located on the board's website at www.FBPE.org/FBRSE. The Board shall recognize only those applicants who have completed the online form, including submission of required documentation, and who have demonstrated to the Board that they have:
- (a) Passed the NCEES Structural I and Structural II exams taken prior to January 1, 2011, OR
- (b) Passed an equivalent 16-hour state-written examination prior to January 1, 2004, OR
- (c) Passed the NCEES Structural II exam plus an equivalent 8-hour state-written structural examination prior to January 1, 2011, OR
- (d) Passed the NCEES 16-hour S.E. examination (vertical and lateral) taken after January 1, 2011, OR
- (e) Held an active license or registration (as applicable) in any US Jurisdiction and:
- 1. has at least fifteen (15) years of experience working on significant structural engineering projects. For purposes of this paragraph, "significant structural engineering projects" is defined as the design of structural components and systems of any of the following:
  - a. Buildings over three stories.
  - b. Buildings with an occupancy greater than 250 persons.
- c. Risk Category III or IV buildings, as defined by Table 1604.5 RISK CATEGORY OF BUILDINGS AND OTHER STRUCTURES in the current Florida Building Code or equivalent classification in another jurisdiction.
  - d. Vehicular Bridges.
- 2. The license and/or registration must have been awarded at least 15 years prior to the application date, and must remain valid continuously through the application process, and
- 3. The license and/or registration must not have been disciplined or otherwise acted against for a violation related to the field of structural engineering.
- (2) Any Florida Licensed PE recognized by the Florida Board may be so indicated by using the designation "Florida Board Recognized Structural Engineer" or "FBRSE." A professional engineer who is recognized by the program may identify such recognition in her or his professional practice, including marketing and advertising materials.
- (3) Recognition by the program is not required for a professional engineer to practice structural engineering.
- (4) Upon submission of the online form, the Board will timely notify an applicant of any information that is required to

complete the request. If an applicant fails to supply any requested information within one (1) year of notification, the request will be presented to the Board for review and decision on the request as submitted.

(5) No later than December 31, 2026, the Board shall review and consider amendment, modification, or repeal of this rule if review determines this rule creates barriers to entry for private business competition, is duplicative, outdated, obsolete, overly burdensome, or imposes excessive costs. Failure by the Board at act in accordance with this provision will result in the expiration of this rule on December 31, 2026.

A request for raptor take permits from nonresidents shall include a copy of the applicant's falconry permit; a list of the species, number, and age of raptors proposed to be taken; a list of all other raptors held under the applicant's falconry permit; and a description of the general area where raptors are proposed to be taken. Permit issuance will be based on consideration of the population status of the species requested; whether or not the species requested is listed by FWC or the Service as threatened, endangered, or of special concern; the number of raptors to be taken; and the permit class of the applicant. Applicants for nonresident raptor take permits shall adhere to the restrictions on take and possession limits for Florida residents as provided in this rule section, and shall submit to FWC, Division of Law

Enforcement, 620 South Meridian Street, Tallahassee, FL 32399-1600, or online through <a href="http://www.GoOutdoorsFlorida.com">http://www.GoOutdoorsFlorida.com</a>, a list of all raptors taken and the location(s) where they were captured within 10 days of take.

If the bird is transferred due to injury, a copy of the certification of injury from a veterinarian or a rehabilitator must also be provided.

The purpose of the audit is to ensure that the voting system deployed in the election tabulated all votes properly. An audit is not required in any election in which only paper ballots are used and are not tabulated by a voting system or in which a manual recount is conducted.

## (2) Requirements for Approval and Use of an Automated Independent Audit System.

This subsection provides the requirements for testing, approval, and use of an automated independent audit system.

- (a) Any person desiring to have an automated independent audit system approved for use in Florida shall submit a letter to the Bureau of Voting Systems Certification, Division of Elections, Department of State, requesting approval and providing the automated independent audit system's technical data package.
- (b) The automated independent audit system must satisfy the following criteria prior to approval:
- 1. Be completely independent of any voting system certified in the State of Florida. The automated independent audit system must not contain any proprietary election-related hardware or software in common with a voting system certified for use in the State of Florida. Any commercially available software or hardware shared between the two systems must not be modified. However, information used to decode the ballot artwork and any barcoding schemes on ballots may be shared from the primary vote tabulation system to the automated independent audit system. For purposes of comparison, standardized results files may be brought into the automated independent audit system.
- 2. Be fast enough to produce final, public audit results no later than 11:59 p.m. (local time where the audit occurs) on the 7th day following certification of the election by the county canvassing board or the local board responsible for certifying the election.
- 3. Be capable of demonstrating the ballots of record have been accurately adjudicated by the audit system.
- 4. For all elections, be capable of operating without outside manufacturer or vendor support to use the system. However, if desired, a county may decide to use the audit system's manufacturer or vendor support.
- 5. Be capable of automatically comparing the audit results to the certified results by precinct and ballot type. If the certified results are not available by precinct and ballot type the automated independent audit system must be able to automatically compare the audit results to the certified results at the lowest level of detail reported.
- 6. If the independent audit system captures and retains paper ballot images, then the front and back of a single card must be viewable together either as a single file or multiple associated files.
- 7. Automated independent audit systems submitted for approval must be capable of automatically examining marked ballots to determine a valid vote, no vote, and marginal mark.
- 8. Be capable of identifying the physical storage location of each specific ballot based on the designated paper ballot image if digital images are used.
- 9. Reflect that the audit results will be the same using all specific auditing scanners approved for use with the system.
- (a) All examination and testing of the automated independent audit system shall occur at the Bureau of Voting

Systems Certification in Tallahassee, Florida, unless the Department of State approves the examination and testing to occur at the vendor's desired location. The vendor shall reimburse the Department of State an amount equal to the actual costs incurred by the department in its testing and examination of the automated independent audit system. Reimbursable actual costs of testing include reasonable travel costs such as lodging, car rental, parking, gas, airfare, travel-related fees and meals, not to exceed the per diem rate established per section 112.061(6), F.S.

(b)

- 1. Notice of approval or non-approval will be provided within 45 days after all examination and testing of the automated independent audit system is completed.
- 2. After approval of an automated independent audit system, any changes to the approved system must be submitted to the Bureau of Voting Systems Certification for approval. The new system or new version of an existing system may not be used in Florida until approval is granted.

In accordance with Rule 65D-30.0141, F.A.C., the Department published the results of its methadone medication-assisted treatment needs assessment for fiscal year 2021-2022.
