SUMMARY: Notice of Renewal of Emergency Rule 12AER22-5. This emergency rule implements the provisions of Section 49 of Chapter 2022-97, Laws of Florida, which provides a temporary sales tax exemption on the retail sale of new ENERGY STAR appliances for noncommercial use made during the period of July 1, 2022, through June 30, 2023.

12AER22-5 Sales Tax Exemption for ENERGY STAR Appliances During the Period of July 1, 2022, through June 30, 2023.

- (1) Definitions. For purposes of this rule, the following definitions apply:
- (a) "ENERGY STAR" means a product that is designated by the US Environmental Protection Agency and the US Department of Energy as meeting or exceeding each agency's

- <u>requirements under the ENERGY STAR program and is affixed</u> with an ENERGY STAR label.
- (b) "Exemption period" means the period from July 1, 2022, through June 30, 2023.
- (c) "Remote sale" means a retail sale of tangible personal property ordered by mail, telephone, the Internet, or other means of communication from a person who receives the order outside of this state and transports the property or causes the property to be transported from any jurisdiction, including this state, to a location in this state. For purposes of this emergency rule, tangible personal property delivered to a location within this state is presumed to be used, consumed, distributed, or stored to be used or consumed in this state.
- (2) During the exemption period, tax is not due on the retail sale of new ENERGY STAR appliances for noncommercial use.
- (a) The following appliances are eligible for this exemption:
 - 1. A washing machine selling for \$1,500 or less.
 - 2. A clothes dryer selling for \$1,500 or less.
 - 3. A water heater selling for \$1,500 or less.
- 4. A refrigerator or combination refrigerator/freezer selling for \$3,000 or less.
- (b) The sales tax exemption applies only to eligible items purchased for noncommercial use and does not apply when the product is purchased for trade, business, or resale.
 - (3) Gift Cards.
- (a) Eligible items purchased during the exemption period using a gift card will qualify for the exemption, regardless of when the gift card was purchased.
- (b) Eligible items purchased after the exemption period using a gift card are taxable, even if the gift card was purchased during the exemption period.
 - (c) A gift card does not reduce the sales price of an item.
- (4) Buy One, Get One for a Reduced Price. The total price of items advertised as "buy one, get one for a reduced price" cannot be averaged in order for both items to qualify for the exemption.
 - (5) Exchanges.
- (a) If a customer purchases an eligible item during the exemption period, then later exchanges the item for the same item (e.g., different size or different color), no tax will be due even if the exchange is made after the exemption period.
- (b) If a customer purchases an eligible item during the exemption period, then later returns the item and receives credit towards the purchase of an item that did not qualify for the exemption, the new item purchased is subject to tax.
- (6) Coupons, Discounts, and Rebates. The sales price of an item includes all consideration received by the retailer for that item. The price of an item is not limited to the amount paid by a customer.

- (a) Manufacturer's coupons do not reduce the sales price of an item, because the retailer is reimbursed for the amount of any discount provided to a customer. Therefore, the amount of the reimbursement is included in the taxable sales price of an item.
- (b) Store coupons, discounts, or rebates offered by the retail seller reduces the sales price of an item because it reduces the total amount received by the retail seller for the item.
- (c) Rebates occur after the sale and do not affect the sales price of an item purchased.
- (7) Returns. When a customer returns an item purchased during the sales tax exemption period and requests a refund or credit of tax the customer must produce a receipt or invoice showing tax was charged and paid on the original purchase of the item, or the retailer must have sufficient documentation to show tax was paid on the original purchase of the item.
- (8) Rain Checks. Eligible items purchased during the exemption period using a rain check will qualify for the exemption regardless of when the rain check was issued. However, issuance of a rain check during the exemption period will not qualify an eligible item for the exemption if the item is purchased after the exemption period.
- (9) Layaway Sales. A layaway sale is a transaction in which merchandise is set aside for future delivery to a customer who makes a deposit, agrees to pay the balance of the purchase price over a period of time, and receives the merchandise at the end of the payment period. Eligible items placed on layaway during the exemption period are tax exempt, even if final payment of the layaway is made after the exemption period. If a customer makes a final payment and takes delivery of the item during the exemption period, the eligible items are tax exempt.
 - (10) Remote Sales.
- (a) Eligible items purchased through a marketplace provider or from a remote seller are exempt when the order is accepted by the marketplace provider or remote seller during the sales tax exemption period for immediate shipment, even if delivery is made after the sales tax exemption period.
- (b) An order is accepted by the company when action has been taken to fill the order for immediate shipment. Actions to fill an order include assigning an "order number" to a telephone order, confirming an Internet order by an email to the customer, or placing a date received on an order received by mail.
- (c) An order is considered to be for immediate shipment when delayed shipment is not requested by the customer. An order is for immediate shipment even if the shipment may be delayed because of a backlog of orders or stock is currently unavailable or on back order.
- (11) Shipping and Handling Charges. When separately stated shipping charges are part of the sales price, and both taxable and exempt items are listed on a sales invoice or receipt, the shipping charges must be proportionately allocated to the

charge for each item to determine the total sales price of the item. The charge for each item is divided by the total charge of all the items ordered to obtain the percentage of charge that each item bears to the total order. The amount of the shipping charge applicable to each item is calculated by multiplying the total shipping charge by the percentage of cost for each item. If the item sold is exempt, the associated shipping charge is also exempt.

(12) Service Warranties. The taxation of any charges for a service warranty contract depends on the taxability of the product being sold. If the retail sale of an item is exempt from tax, the charge for a service warranty sold with the item is exempt.

(13) License Fees or Other Fees Imposed by Panama City and Panama City Beach. Panama City and Panama City Beach impose a 1% merchant's license fee or tax on retailers. The merchant's license fee is included in the sales price of each item. When the fee is separately stated, and both taxable and exempt items are listed on a sales invoice or receipt, the merchant's fee must be allocated to the charge for each item on the invoice. If the item is exempt, the associated merchant's license fee is exempt.

(14) Installation Charges. When an eligible ENERGY STAR appliance does not become a part of real property and remains tangible personal property when installed, any separately itemized charge for the installation of the product is a part of the sales price of the product and is exempt when the total sales price of the eligible ENERGY STAR appliance does not exceed the applicable threshold.

(15) Rentals. Rentals of eligible items do not qualify for the exemption.

<u>12AER22-6 Sales Tax Exemption for Children's</u> <u>Diapers; Baby and Toddler Clothing, Apparel, and Shoes</u> During the Period of July 1, 2022, through June 30, 2023.

- (1) Definitions. For purposes of this rule, the following definitions apply:
- (a)1. "Clothing" and "apparel" means any article of clothing or wearing apparel intended to be worn on or about the human body.
- 2. "Clothing" and "apparel" do not include watches, watchbands, jewelry, umbrellas, and handkerchiefs.
- (b) "Exemption period" means the period from July 1, 2022, through June 30, 2023.
- (c) "Remote sale" means a retail sale of tangible personal property ordered by mail, telephone, the Internet, or other means of communication from a person who receives the order outside of this state and transports the property or causes the property to be transported from any jurisdiction, including this state, to a location in this state. For purposes of this emergency rule, tangible personal property delivered to a location within this state is presumed to be used, consumed, distributed, or stored to be used or consumed in this state.

- (2) During the exemption period, tax is not due on the retail sale of the following:
- (a) Single-use and reusable children's diapers, including those used for toilet training, and diaper inserts.
- (b) Baby and toddler clothing, apparel, and shoes, primarily intended for children age 5 or younger.
- (3) Sales of Sets Containing Both Exempt and Taxable Items. When exempt items are normally sold together with taxable merchandise as a set or single unit, the sales price of the set or single unit is subject to sales tax.
 - (4) Gift Cards.
- (a) Eligible items purchased during the exemption period using a gift card will qualify for the exemption, regardless of when the gift card was purchased.
- (b) Eligible items purchased after the exemption period using a gift card are taxable, even if the gift card was purchased during the exemption period.
 - (5) Exchanges.
- (a) If a customer purchases an eligible item during the exemption period, then later exchanges the item for the same item (e.g., different size or different color), no tax will be due even if the exchange is made after the exemption period.
- (b) If a customer purchases an eligible item during the exemption period, then later returns the item and receives credit towards the purchase of an item that did not qualify for the exemption, the new item purchased is subject to tax.
- (6) Returns. When a customer returns an item purchased during the sales tax exemption period and requests a refund or credit of tax the customer must produce a receipt or invoice showing tax was charged and paid on the original purchase of the item, or the retailer must have sufficient documentation to show tax was paid on the original purchase of the item.
- (7) Rain Checks. Eligible items purchased during the exemption period using a rain check will qualify for the exemption regardless of when the rain check was issued. However, issuance of a rain check during the exemption period will not qualify an eligible item for the exemption if the item is purchased after the exemption period.
- (8) Layaway Sales. A layaway sale is a transaction in which merchandise is set aside for future delivery to a customer who makes a deposit, agrees to pay the balance of the purchase price over a period of time, and receives the merchandise at the end of the payment period. Eligible items placed on layaway during the exemption period are tax exempt, even if final payment of the layaway is made after the exemption period. If a customer makes a final payment and takes delivery of the item during the exemption period, the eligible items are tax exempt.
 - (9) Remote Sales.
- (a) Eligible items purchased through a marketplace provider or from a remote seller are exempt when the order is accepted by the marketplace provider or remote seller during

- the sales tax exemption period for immediate shipment, even if delivery is made after the sales tax exemption period.
- (b) An order is accepted by the company when action has been taken to fill the order for immediate shipment. Actions to fill an order include assigning an "order number" to a telephone order, confirming an Internet order by an email to the customer, or placing a date received on an order received by mail.
- (c) An order is considered to be for immediate shipment when delayed shipment is not requested by the customer. An order is for immediate shipment even if the shipment may be delayed because of a backlog of orders or stock is currently unavailable or on back order.
- stated shipping and Handling Charges. When separately stated shipping charges are part of the sales price, and both taxable and exempt items are listed on a sales invoice or receipt, the shipping charges must be proportionately allocated to the charge for each item to determine the total sales price of the item. The charge for each item is divided by the total charge of all the items ordered to obtain the percentage of charge that each item bears to the total order. The amount of the shipping charge applicable to each item is calculated by multiplying the total shipping charge by the percentage of cost for each item. If an item is exempt, the associated shipping charge is also exempt.
- (11) License Fees or Other Fees Imposed by Panama City and Panama City Beach. Panama City and Panama City Beach impose a 1% merchant's license fee or tax on retailers. The merchant's license fee is included in the sales price of each item. When the fee is separately stated, and both taxable and exempt items are listed on a sales invoice or receipt, the merchant's fee must be allocated to the charge for each item on the invoice. If the item is exempt, the associated merchant's license fee is exempt.
- (12) Alterations to Eligible Items. Alterations to clothing or footwear do not qualify for the exemption, even though alterations may be sold, invoiced, and paid for at the same time as the item to be altered is purchased.
- (13) Rentals. Rentals of eligible items do not qualify for the exemption.

68CER22-1 Manatee Protection Zone for FPL Cape

Canaveral Energy Center in Brevard County

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Large numbers of manatees congregating as part of the ongoing temporary field response operations at the Florida Power & Light Cape Canaveral Energy Center's (FPL CCEC) are likely to cause a navigational hazard to any boaters utilizing the waterway within the area that the congregation is

occurring. This hazard creates an immediate public safety issue that could result in injury to the public due to collisions or in the process of attempting to avoid such collisions. Implementing a No Entry Zone in the waters immediately adjacent to and within the intake canal of the FPL CCEC can protect both watercraft operators and manatees from bodily harm that could be sustained during a collision.

Starting in December of 2020, the number of manatee mortalities reported along Florida's Atlantic coast has significantly exceeded the baseline annual average for the Atlantic coast management unit. The increase in manatee mortalities prompted the declaration of an Unusual Mortality Event (UME) by the U.S. Fish and Wildlife Service (USFWS). Ongoing investigations indicate starvation as the primary cause of death due to a decline in critical food sources within the Indian River Lagoon (IRL) and surrounding areas. Preliminary data suggest that manatees may prioritize seeking warm water over finding forage, making UME response efforts during the colder months critically important. While the entire IRL is important habitat for manatees throughout the year, certain areas within the IRL, such as the waters near FPL CCEC, are more heavily used in winter months when manatees seek sources of warm water.

Temporary field response activities, including continued biological monitoring, live animal rescue, and a targeted supplemental feeding trial, will take place at the FPL CCEC in areas adjacent to the large congregation of a manatees seeking warm water during winter months. The large presence of manatees in the area may also lead to a higher incidence in collisions between vessels and manatees if the area is left unregulated. Boating safety is already a concern at the FPL CCEC as interactions with vessels, including manatee mortality due to watercraft, have been documented in this area since the 1970s. The likelihood of public presence increasing in this narrow waterway to observe the congregation of manatees poses additional safety concerns for operators and passengers of motorized and non-motorized vessels (e.g., paddle craft), including those staff and volunteers participating in the efforts. Additionally, an increase in the presence of waterway users may result in the direct disturbance of manatees and abandonment of the warm-water refuge.

The creation of a No Entry Zone in the waters immediately adjacent to and within the intake canal of the FPL CCEC will 1) protect watercraft operators and manatees from bodily harm that could be sustained during a collision and 2) reduce unintended harassment of manatees from the public while field response efforts are underway.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: Per Section 68C-22.001, F.A.C., the Commission provided notice to the public by publication in the Florida Administrative Register, on

September 21, 2022, that FWC would pursue permanent rulemaking to establish a seasonal No Entry Zone in the waters surrounding the CCEC Temporary Field Response Station. Furthermore, the September 28th and 29th Commission Meeting advertised agenda items on the Commission webpage, including a consent item to approve rulemaking for the zone. The regularly scheduled Commission Meeting was cancelled due to Hurricane Ian and permanent rulemaking will continue at the next scheduled meeting on November 30 and December 1, 2022. This emergency rule is being established as an interim protection measure while permanent rulemaking procedures continue. The procedures followed provide at least the procedural protection given by other statutes, the State Constitution, or the U.S. Constitution.

SUMMARY: Given the current decline of available food sources, the increased manatee mortality rate, and the onset of winter temperatures, this temporary No Entry Zone is fair and necessary to protect both vessel operators and manatees during this manatee field response which includes rescue, monitoring, and supplemental feeding. In the creation of this emergency rule, the agency is taking the limited action necessary for human and manatee protection. The No Entry Zone being sought is specific to the small area of the waterway we anticipate being affected by the UME Response; therefore, this limited temporary emergency zone protects the public interest, provides protection for the public safety concerns, and still meets the agency's statutory charge of manatee protection.

<u>68CER22-1 Manatee Protection Zone for FPL Cape</u> <u>Canaveral Energy Center in Brevard County</u>

- (1) Scope. This emergency rule creates a temporary "No Entry Zone" as defined in 68C-22.002(11) to protect manatees from harmful collisions and harassment during field operations due to an Unusual Mortality Event. A temporary "No Entry Zone" is established in areas south of the FPL Cape Canaveral Energy Center jetty as follows:
- (a) All waters south of the FPL Cape Canaveral Energy Center jetty, west of a line beginning at the southeasternmost point of the jetty (latitude 28° 28' 07" N, longitude 80 45' 18" W) and running 180° of said jetty point south by 200 meters (latitude 28° 28' 01" N, longitude 80° 45' 18" W), those waters north of an east-west 709 meter line, ending at the shoreline terminus at Mullet Court Road (latitude 28° 28' 01" North, longitude 80° 45' 02" West), and those waters east of the general westernmost shoreline of the Indian River, excluding those

waters west of the north-south over-water foot bridge structure of the FPL intake canal.

- (b) The Coordinates used in the description of the zone boundaries are referenced to the North American Datum of 1983 (NAD83_2011) using the Florida GDL Albers projection. Access to the No Entry Zone designated in paragraph (2)(a) will be provided in accordance with procedures set forth in subsection (3).
- (2) Access to the No Entry Zone designated in paragraph (1) is permitted by the following:
- (a) FPL employees or designees, with current company identification or authorization, provided entry into, and activities conducted within the zone are under the discretion and consideration of the company.
- (b) FPL authorized agents and contractors, provided that entry into the zone is necessary to conduct activities associated with power plant operation and maintenance, construction emergency response or environmental monitoring.
- (c) U.S. Fish and Wildlife Service employees, designees, or their authorized agents for activities associated with manatee response or monitoring.
- (3) The effective date of the emergency rule is November 15, 2022 and is not dependent on the installation of regulatory signage.

WHEREAS, on September 23, 2022, by State of Florida Executive Order No. 22-218 ("Executive Order 22-218"), as amended by Executive Order No. 22-219 on September 24, 2022, the Governor declared that a state of emergency exists throughout the State of Florida based upon the serious threat to the public health, safety, and welfare posed by Tropical Depression 9 (now known as Hurricane Ian); and

WHEREAS, the Department of Economic Opportunity ("Department") has the ultimate authority over the administration of Florida's Reemployment Assistance Program pursuant to sections 20.60(5)(c)(3) and 443.1317(1)(a), Florida Statutes, and Chapters 73B-10 and 73B-11, Florida Administrative Code; and

WHEREAS, Executive Order 22-218 recognizes that special duties and responsibilities rest upon some State, regional, and local agencies and other governmental bodies in responding to the emergency may require waiver

or deviation from the statutes, rules, ordinances, and orders those agencies and governmental bodies administer.
