(b) Justification for the need to provide dental services by dentists who are not licensed in this state.

(c) A plan of operation which establishes that any non-Florida licensed dentist employed by the permit holder will be practicing dentistry under the general supervision of a Florida licensed dentist.

(d) through (e) renumbered (b) through (c) No change.

(f) As to each non Florida licensed dentist employed or sought to be employed:

1. The dentist's name and age,

2. Proof of said dentist's graduation from an accredited dental college or school,

3. The dentist's licensure status in other jurisdictions, including disciplinary action and pending disciplinary action,

4. The status of any dental malpractice actions that have been noticed or filed in any jurisdiction,

5. Proof of having successfully completed Board approved courses on Human Immunodeficiency Virus and Acquired Immune Deficiency Syndrome, a course in domestic violence, and proof of current CPR certification.

(2) A non-profit corporation permit holder shall follow the requirements of subsection 64B5 7.001(4), F.A.C., and Rule 64B5 7.003, F.A.C., regarding application, requirements for conducting the program and qualifications for any permit holders who will be employed at their facility.

(3) Any non Florida licensed dentist employed by the holder of a permit pursuant to this rule shall be bound by all requirements for permit holders set forth in Rule 64B5-7.003, F.A.C., and shall be compensated only by salary which is not based upon productivity.

(4) Each non profit corporation at which a non Florida licensed dentist practices dentistry shall inform the Board office of the termination of practice of said dentist. Such notice shall be in writing and within thirty (30) days of termination.

PURPOSE AND EFFECT: The Board proposes the rule amendment to clarify that dental hygienists who want to perform remediable restorative functions must have a delegating dentist in order to enroll in the program and that the delegating dentist must supervise and evaluate a portion of the clinical requirements and take an online course prior to doing so. The proposed rule amendment also eliminate the need for live patients for the course and reorganizes the course hours without increasing the hours.

SUMMARY: The rule text will update the qualifications for the dental hygienists who want to perform remediable restorative functions and the requirements of the delegating dentist.

64B5-16.0061 Delegation of Remediable Restorative Functions to Dental Hygienists; Supervision Level; and Training and Experience Requirements.

Notwithstanding any other rule provision to the contrary, a dentist may delegate remedial intraoral restorative functions to a Dental Hygienist in strict compliance with the provisions of this rule. All functions delegated under this rule shall be performed under direct supervision.

(1) No change.

(2) Mandatory Training Course Prerequisites: To be eligible to be admitted into the mandatory training course required in subsection (3), a dental hygienist (Candidate) shall meet the following conditions:

(a) through (e) No change.

(f) All students must have a delegating dentist to enroll in the program. The commitment of the delegating dentist is to supervise and evaluate a portion of their clinical requirements and submit a report to the CE provider.

(g) The delegating dentist must attend a two-hour online interactive video conference mandatory training on the Laws and Rules of Remediable Restorative Functions, and calibration of the clinical requirements and procedures. (3) Mandatory Training Course: The mandatory training course shall be offered by a dental or dental hygiene school or program that is accredited by a dental accrediting entity recognized by the United States Department of Education. The training course must be specifically designed and implemented to comply with the provisions of this rule. The training program shall ensure that the candidate meets all the qualifications in subsection (2) before accepting the candidate into the training program. At a minimum, the training shall include and contain the following:

(a) 85 clock hours including a minimum of 5 hours dedicated to preclinical didactic hours, and a clinical portion consisting of a minimum 55 hours dedicated to simulated lab and a minimum of 25 hours dedicated to live patients, divided in 12 clinical hours with the delegating dentist, and 13 clinical hours at the course provider institution. The pre-clinical didactic hours may be offered online. At the completion of the preclinical didactic hours, the course shall require the passing of an initial written examination prior to the clinical portion of the training. A passing score shall require a score of 75 percent or above.

(b) through (c) No change.

(d) A <u>elinical and</u> lab <u>case-based clinical scenario</u> session to size, fit and contour, but not permanently cement, stainless steel crowns<del>, which shall include live patients</del>.

(e) through (f) No change.

(4) through (5) No change.

(6) This rule shall be reviewed, and if necessary, repealed, modified, or renewed through the rulemaking process five years from the effective date.

A dentist shall maintain patient dental records in a legible manner and with sufficient detail to clearly demonstrate why the course of treatment was undertaken.

(1) Dental Record: The dental record shall contain sufficient information to record each patient/dentist in person encounter, identify the patient, support the diagnosis, <u>identify</u> and justify the treatment and document the course and results

of treatment accurately, by including, at a minimum, patient histories; X-rays (if taken); examination results; test results; records of drugs prescribed, dispensed, or administered; reports of consultation or referrals; <u>identification of all treatments and</u> <u>procedures performed and when they were performed</u>; and copies of records or reports or other documentation obtained from health care practitioners at the request of the dentist and relied upon by the dentist in determining the appropriate treatment of the patient.

(2) through (8) No change.

RULE NO.:RULE TITLE:690ER23-2Claims-Handling Manuals

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Section 18 of Chapter 2023-172, Laws of Florida, authorizes the Financial Services Commission to promulgate emergency rules to implement the provision of the newly created Section 627.4108, F.S., which contains minimum requirements for claims-handling manuals, requirement that authorized residential property insurers annually attest and certify that their manuals meet the requirements of law, that they have adequate resources to implement those manuals, and will provide copies of the claims-handling manuals upon request. The bill is effective July 1, 2023, and the first attestation and certification required by the law must be filed by August 1, 2023 on a form provided by the Commission. The promulgation of this emergency rule ensures that authorized residential property insurers are notified in the most expedient and appropriate manner regarding the requirement to attest and certify that those insurers claims-handling manuals meet the requirements of law, the adoption of two new forms, and the ability of the public to access the forms free of charge from the Department.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: The Legislature expressly authorized the promulgation of emergency rules to implement the provisions of Section 18 of Chapter 2023-172, Laws of Florida. Additionally, these emergency rules are the most expedient and appropriate means of notifying taxpayers of the provisions of Section 18 of Chapter 2023-172, Laws of Florida.

SUMMARY: Emergency Rule 69OER23-2, creates a new rule in order to incorporate two forms required to implement the newly created Section 627.4108, F.S., regarding claimshandling manuals.

## 690ER23-2 Claims-Handling Manuals

(1) Each authorized residential property insurer conducting business in this state must certify and attest that the insurer's current claims-handling manuals for residential property insurance comply with the requirements of the Florida Insurance Code, including the provisions of Section 627.4108(1), F.S., and comport with the usual and customary claims-handling practices of the insurance industry. The insurer must also certify and attest that the insurer maintains adequate resources available to implement the requirements of each of its claims-handling manuals at all times, including during natural disasters and catastrophic events.

(2) This attestation and certification shall be submitted to the Office no later than August 1, 2023, on Form OIR-B3-495, effective 7/23, "Annual Certification of Claims-Handling Manuals," incorporated herein by reference and available at www.flrules.org/XXXXX. The form may be obtained from https://www.floir.com.

(3) Upon request by the Office, insurer will provide the Office with a true and correct copy of any claims-handling manual requested within 5 business days as specified on Form OIR-B3-496, 7/23, "Submission of Requested Claims-Handling Manuals," incorporated herein by reference and available at www.flrules.org/XXXXX. The form may be
