Revised requirements include: additional screening, required parent notification, and definition of dyslexia-specific interventions for students who show characteristics of dyslexia; notification to parents of eligible students for New Worlds Scholarship Accounts; prioritization of highly effective teachers in K-2 classrooms; assignment of literacy coaches; ensuring reading instruction and professional learning are grounded in the science of reading; prohibition of three-cueing in the teaching of word reading; and including all district schools including charter schools, unless a charter school elects to submit a plan to the sponsoring Local Educational Agency independently from the school district that complies with all of the plan requirements. - 1. For two or more violations of any combination of the following within a 24-month period or for four violations over any period of time, which result in dispositions other than dismissal or acquittal and which were issued to any person owning or operating the livery:
- a. Subsection 327.54(2), F.S., except as provided in subparagraph 2. below.
- b. Subsections 327.54(4), (5), (6), (7), (8), and (9), F.S.
- c. Paragraph 327.54(3)(a), (b), (c), (d), or (e), F.S.
- 2. For three or more violations of any combination of the following within a 12-month period or for five violations over any period of time, which result in dispositions other than dismissal or acquittal and which were issued to any person owning or operating the livery:
- a. Failure to provide the Commission with updated information within 10 days of a change of such information, as provided in subsection 327.54(2), F.S.
- b. Subsection 327.54(10), F.S.
- c. Paragraph 327.54(3)(f) or (g), F.S.
- (b) Revocations of livery permits and denials of livery permit applications pursuant to this section shall be in effect for two years for a first revocation or denial. A second revocation of a livery permit pursuant to this section shall be permanent. #### FINAL ORDER

APPROVING LAKE COUNTY ORDINANCE NO. 2023-50 The Florida Department of Commerce ("Commerce"), formerly known as the Florida Department of Economic Opportunity[1], hereby issues its Final Order, pursuant to section 380.05(6), Florida Statutes, approving land development regulations adopted by Lake County, Florida, Ordinance No. 2023-50 (the "Ordinance").

#### FINDINGS OF FACT

- 1. The Green Swamp Area is designated by section 380.0551, Florida Statutes, as an area of critical state concern. Lake County is a local government within the Green Swamp Area.
- 2. The Ordinance was adopted by Lake County on August 8, 2023, and rendered to Commerce on September 20, 2023.
- 3.The Ordinance repeals Section 3.02.09, Minimum Size Requirements, of the Lake County Code ("Code"), Appendix E, Land Development Regulations, in its entirety.
- 4.The Ordinance amends Section 10.01.03, Accessory Dwelling Units, of the Code, Appendix E, Land Development Regulations, to remove language that

references Section 3.02.09, which is now repealed. The Ordinance also amends Section 3.01.02.A.1, Residential Uses, of the Code, Appendix E, Land Development Regulations, to remove language that requires single-family dwelling units to have a minimum width of 23 feet and 4 inches.

#### CONCLUSIONS OF LAW

- 5. Commerce is required to approve or reject land development regulations that are adopted by any local government in the Green Swamp Area of Critical State Concern. See section 380.05(6), Florida Statutes.
- 6. "Land development regulations" include "local zoning, subdivision, building, and other regulations controlling the development of land." Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.
- 7. The Ordinance is consistent with the Lake County Comprehensive Plan generally, as required by section 163.3177(1), Florida Statutes, and specifically is consistent with Objective I-1.1, Policy I-1.2.2, Policy I-7.2.1, and Policy 1-7.2.3.
- 8.All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See section 380.05(6), Florida Statutes. The Principles for Guiding Development for the Green Swamp Area of Critical State Concern are set forth in Rule 28-26.003(1), Florida Administrative Code.
- 9.The Ordinance is consistent with the Principles for Guiding Development for the Green Swamp Area of Critical State Concern as a whole.

WHEREFORE, IT IS ORDERED that Commerce finds that Lake County Ordinance No. 2023-50 is consistent with the Lake County Comprehensive Plan and the Principles for Guiding Development for the Green Swamp Area of Critical State Concern and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
