Wells shall be located so as not to pose a threat of contamination to the groundwater water resource. Minimum spacing between wells and sanitary hazards shall be as set forth in Table 1 of Chapter 62-532, F.A.C., (February 16, 2012), which is incorporated by reference in subsection 40B-3.035(3), F.A.C. and surface waters or sanitary hazards such as septie tanks, drainfields, or cesspools shall be as specified by Section 381.272, F.S., and the respective rules of the Department or DOH. Wells shall not be located on lands below the 100-year flood elevation of the Suwannee River system defined as the 100 year floodplain of the Suwannee, Alapaha, Withlacoochee, Santa Fe, and Aucilla Rivers when an alternative to such location exists on the property.

40B-3.517 Grouting and Sealing.

Wells shall be grouted and sealed to protect the groundwater water resource from degradation caused by movement of waters along the well annulus either from the surface to the aquifer or between aquifers, and to prevent loss of artesian pressure in artesian aquifers. All wells shall be constructed and sealed using a method that ensures which insures that an open or unnaturally permeable annular space does not remain when a well is completed. All wells that are constructed in a manner which creates an annular space between the casing and the naturally occurring geologic formations shall be grouted and sealed as set forth in Chapter 62-532, F.A.C., (February 16, 2012), which is incorporated by reference in subsection 40B-3.035(3), F.A.C. will be grouted and sealed in accordance with the methodologies listed in this section.

(1) In order to prevent possible migration of surface waters down the annulus any well located on lands below the 100 year flood elevation of the Suwannee River system defined as the 100 year floodplain of the Suwannee, Alapaha, Withlacoochee, Sante Fe, and Aucilla Rivers shall have a minimum six inch thickness of grout to a depth of two feet below natural land

surface and be in accordance with the methodologies listed in this section.

- (2) Wells obtaining water from a consolidated formation and having a casing less than four inches in diameter shall have a nominal one inch thickness of grout sealing the annular space.
- (3) Wells obtaining water from a consolidated formation and having a casing diameter equal to or greater than four inches in diameter shall have a nominal two inch thickness of grout sealing the annular space.
- (4) Where confining beds are present, grout shall extend from the bottom of the casing to the top of or ten (10) feet into the confining bed overlying the producing aquifer, whichever is less.
- (5) Where confining beds are not present, grout shall extend from the bottom of the casing to the top of the producing aquifer.
- (6) To prevent interchanges of water when multiple aquifers or zones are penetrated, grout shall extend from the bottom of the casing to the top of the uppermost confining bed or ten (10) feet into the uppermost bed, whichever is less.
 - (1) (7) No change.
- (2) (8) Grouting and sealing of well casings not driven or jetted into place shall be accomplished in the following manner unless otherwise authorized by the District in accordance with Section 373.326(1), F.S.: Grouting and sealing of water wells shall be accomplished in the following manner unless otherwise granted a variance by the District in accordance with Section 120.542, F.S.
 - (a) No change.
- (b) The minimum set time for grouting of casing before drilling operations may continue shall will be 12 hours.
 - (c) No change.
- (d) Neat In all eases, neat cement grout shall will be introduced into the annular space from bottom to top.
- (9) Other approved methods and materials may be used if deemed by District staff to be reasonable, and assurance is given for resource protection.
- (3) (10) In those cases where, during grouting operations, circulation of the neat cement grout is lost so that the annular space being grouted cannot be filled in one continuous operation, a tremie pipe shall be installed in the annular space to a point immediately above the zone of lost circulation; and the annulus shall be filled from that point using clean sand or rock introduced in a manner that prevents bridging within the annular space until a level is reached at which grouting can be continued bridged at that point by sand and/or other suitable material introduced through the pipe until a level is reached at which grouting can be continued.

FINAL ORDER

APPROVING MONROE COUNTY ORDINANCE NO. 029-2022

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to sections 380.05(6) and 380.0552(9), Florida Statutes, approving land development regulations adopted by Monroe County, Florida (the "County"), Ordinance No. 029-2022 (the "Ordinance").

FINDINGS OF FACT

- 1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. The County is a local government within the Florida Keys Area.
- 2. The Ordinance was adopted by the County on November 15, 2022 and rendered to the Department on December 16, 2022.
- 3. The Ordinance amends Sections 131-2 of the County's Land Development Code to provide for an exception to the height limit of residential buildings elevated to meet or exceed the FEMA Base Flood Elevation. New and existing residential buildings located in Special Flood Hazard Areas shall have a maximum height limit of 40 feet to ensure alignment with updated FEMA Insurance Rate Maps and compliance with the Florida Building Code flood elevation standards.

CONCLUSIONS OF LAW

- 4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See §§ 380.05(6) and 380.0552(9), Fla Stat.
- 5. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. The regulations adopted by the Ordinance are land development regulations.
- 6. The Ordinance is consistent with the Monroe County Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and specifically, with Goal 101, Objective 101.5, Policy 101.5.32, and Policy 101.5.33.
- 7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. §§ 380.05(6) and 380.0552(9), Fla Stat. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in Section 380.0552(7), Florida Statutes.
- 8. The Ordinance is consistent with the Principles for Guiding Development as a whole, and specifically complies with the following:
- (a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.
- (f) Enhancing natural scenic resources, promoting the aesthetic benefits of the natural environment, and ensuring that development is compatible with the unique historic character of the Florida Keys.

- (k) Limiting the adverse impacts of public investments on the environmental resources of the Florida Kevs.
- (g) Protecting the historical heritage of the Florida Keys.
- (n) Protecting the public health, safety, and welfare of the citizens of the Florida Keys and maintaining the Florida Keys as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Monroe County Ordinance No. 029-2022 is consistent with the Monroe County Comprehensive Plan and Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.

This Order becomes effective 21 days after publication in the Florida Administrative Register, unless a petition is timely filed as described in the Notice of Administrative Rights below. DONE AND ORDERED in Tallahassee, Florida.

- 1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. The County is a local government within the Florida Keys Area.
- 2. The Ordinance was adopted by the County on November 15, 2022, and rendered to the Department on December 16, 2022.

- 3. The Ordinance amends Section 101-1 of the County's Land Development Code ("Code") to update the definitions of terms related to Floodplain Management.
- 4. The Ordinance also repeals and reenacts an updated version of Chapter 122 of the County's Code, which is the applicable chapter regarding Floodplain Management, to be consistent with the Florida Division of Emergency Management's model floodplain management ordinance.

CONCLUSIONS OF LAW

- 5. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See §§ 380.05(6) and 380.0552(9), Fla Stat.
- 6. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. The regulations adopted by the Ordinance are land development regulations.
- 7. The Ordinance is consistent with the Monroe County Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and specifically, with Goal 101, Objective 101.5, Goal 216, Objective 216.1, and Policy 218.5.1.
- 8. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. §§ 380.05(6) and 380.0552(9), Fla Stat. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in Section 380.0552(7), Florida Statutes.
- 9. The Ordinance is consistent with the Principles for Guiding Development as a whole, and specifically complies with the following:
- (a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.
- (f) Enhancing natural scenic resources, promoting the aesthetic benefits of the natural environment, and ensuring that development is compatible with the unique historic character of the Florida Keys.
- (k) Limiting the adverse impacts of public investments on the environmental resources of the Florida Keys.
- (n) Protecting the public health, safety, and welfare of the citizens of the Florida Keys and maintaining the Florida Keys as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Monroe County Ordinance No. 026-2022 is consistent with the Monroe County Comprehensive Plan and Principles for

Guiding Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to sections 380.05(6) and 380.0552(9), Florida Statutes, approving land development regulations adopted by Monroe County, Florida (the "County"), Ordinance No. 030-2022 (the "Ordinance").

FINDINGS OF FACT

- 1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. The County is a local government within the Florida Keys Area.
- 2. The Ordinance was adopted by the County on November 15, 2022.
- 3. The Ordinance amends Sections 138-25, 138-28, 138-52, and 138-55 of the County's Land Development Code to amend the procedures and evaluation criteria for residential ROGO and NROGO to require updated scores based on the updated FEMA Flood Insurance Rate Maps and to require, if necessary, plan revisions to building department applications to demonstrate full compliance with the Florida Building Code and the updated FEMA Flood Insurance Rate Maps.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local

- 7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. §§ 380.05(6) and 380.0552(9), Fla Stat. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in Section 380.0552(7), Florida Statutes.
- 8. The Ordinance is consistent with the Principles for Guiding Development as a whole, and specifically complies with the following:
- (a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.
- (k) Limiting the adverse impacts of public investments on the environmental resources of the Florida Keys.
- (n) Protecting the public health, safety, and welfare of the citizens of the Florida Keys and maintaining the Florida Keys as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Monroe County Ordinance No. 030-2022 is consistent with the Monroe County Comprehensive Plan and Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.
