20ER23-1 Orange Maturity Standards - Processed SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Section 120.54(4)(b), Florida Statutes, states that

those rules pertaining to perishable agricultural commodities shall be included in the definition of rules relating to the public health, safety, or welfare.

Section 601.111, Florida Statutes explicitly states that an emergency may be created by hurricanes that affect a substantial part of the citrus industry. An emergency rule adopted under that subsection must contain an expiration date of no longer than one year after its effective date.

Due to the effect of Hurricane Ian, a significant amount of the Florida orange crop will have a minimum ratio of solids to citric acid below the nine to one (9.0:1) minimum established in rule during the 2022-2023 season. The current rule will harm growers financially due to the inability to sell the fruit that does not meet the current minimum ratio of solids to citric acid or brix value.

After discussing the matter at a telephonic meeting and hearing in Bartow, Florida on February 22, 2023, the Florida Citrus Commission found that there exist unusual weather conditions which caused a substantial portion of the orange crop to fail maturity requirements. The FCC voted unanimously to adopt Emergency Rule 20ER23-1, lowering the minimum Brix requirement, and waiving the ratio of total soluble solids to anhydrous citric acid for all oranges for the period of February 23, 2022, through May 23, 2023.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: Adequate notice procedures were used by the Department of Citrus to inform the public and the Florida citrus industry of the pending adoption of Emergency Rule 20ER23-1 lowering the Brix requirement and waiving the minimum ratio of total soluble solids to anhydrous citric acid for all oranges, in that notice was sent via email on February 21, 2023 of the emergency rulemaking to take place at the February 22, 2023, meeting to members of the Florida Citrus Commission, all industry organizations, the Florida Press Corps and other interested persons.

SUMMARY: Emergency rule 20ER23-1 lowers the Brix requirement and waives the minimum ratio of total soluble solids to anhydrous citric acid for all oranges for the period beginning February 23, 2023, through May 23, 2023, assuring good and safe citrus products go to market and the industry is not harmed financially.
