PURPOSE AND EFFECT: The purpose of this Notice of Proposed Rule (NOPR) is to revise Rules 62-210.300, 62-210.310 and 62-210.360, F.A.C., to provide a permit exemption for Source-Separated Organics Processing Facilities, revise existing exemptions for boilers to align with federal regulations, phase out the authorization for Ethylene Oxide Sterilizer Facilities to operate under an Air General Permit, and streamline the administrative corrections processes for minor operating permits and Title V operating permits.

SUMMARY: The proposed rule amendments address Stationary Sources – General Requirements.

(3) Exemptions from Permitting. Except as otherwise provided herein, an owner or operator shall not be required to obtain an air construction permit or non-Title V air operation permit, or to use an air general permit pursuant to Rule 62-210.310, F.A.C., for any facility, emissions unit, or pollutantemitting activity that satisfies the applicable permitting exemption criteria of paragraph 62-210.300(3)(a) or (b), F.A.C., or has been exempted from permitting pursuant to Rule 62-4.040, F.A.C. Failure of a facility, emissions unit, or activity to satisfy the exemption criteria of paragraph 62-210.300(3)(a)or (b), F.A.C., does not preclude such facility, emissions unit, or activity from being considered for exemption pursuant to Rule 62-4.040, F.A.C.
