Brake Fluid Renewal of Registration Instructions JULY 1, ____ THROUGH JUNE 30, ____

June 30 is the expiration date of current permits authorizing the sale of brake fluid in Florida. If you plan to continue to market brake fluid, you will be required to renew your permit. The renewal fee is \$50.00 for **each formula of each currently registered brand** and should accompany your renewal application. A penalty of \$25.00 is assessed on any renewal application postmarked after midnight June 30.

The notarized affidavit must give the applicant full authorization to register the brand name; must be signed by the owner of the brand name; and must accompany this application. The affidavit must include all affected brand names, the owner's company or corporate name and address, the applicant's company or corporate name and address, and a statement from the owner authorizing the applicant to register the product with the Florida Department of Agriculture and Consumer Services (FDACS). The owner of the brand name shall maintain complete control over each product sold under that brand name in this state.

The appropriate fee as a check or money order payable to FDACS is to be attached to the **original** renewal application form and sent to:

In addition: 1) At least 24 fl. oz. of the sample of the brake fluid on which the renewal permit is being sought shall be submitted in a container, or containers, labeled exactly as containers of this brake fluid will be when sold in Florida; 2) the sample of brake fluid being submitted shall have the formula written on the container; 3) A set of labels, front and back, for record retention by the department; and 4) A **copy** of the original renewal application are to be sent to:
