Provided further, that in the event of any claim and/or claim payment by the surety under this bond the surety shall forthwith notify the Chief of the Bureau of Liquefied Petroleum Gas Inspection, Department of Agriculture and Consumer Services of the State of Florida at Tallahassee, Florida, of said claim and/or claim payment; and provided further that either the principal of the surety may cancel this bond by giving thirty (30) days written notice to the Department of Agriculture and Consumer Services at Tallahassee, Florida, and if cancelled by the surety, a copy of said cancellation notice shall be sent by mail to the principal at his business address. In case of such cancellation, no further obligation shall be incurred under this bond by the surety after the expiration of said thirty (30) days, but the liability of the surety shall apply as above set out as to any acts or omissions which may have occurred prior to the effective date of such cancellation.
