The association hereby makes application for a Fair Permit under Chapter 616, Florida Statutes, and rules promulgated there under by the Department.

The following materials are enclosed with this application:

- 1. Permit Fee calculated by attendance at the prior year's annual public fair:
Two Hundred Dollars (\$200) for attendance under 25,000;
Two Hundred and Seventy-five Dollars (\$275) for attendance of 25,000 to 100,000.
Three Hundred and Fifty Dollars (\$350) for attendance over 100,000.
- 2. Affidavit, FDACS-06101 (Rev. 05/13) certifying existence of contract with the central amusement company.
- 3. Copy of premium list.
- 4. Proof of midway liability insurance, \$1,000,000 minimum.
- 5. Proof of liability insurance for the association, not less than \$300,000 per occurrence.
- 6. Certified copy of annual review of financial statements made by a qualified accountant licensed by the State or financial statements signed by a county official if fair attendance is below 25,000.
- 7. Copy of the association charter and by-laws with the latest amendments.
- 8. A list of the current Board members and their home address and an email address or phone number.
- 9. Copies of cover letters sent to fair associations located within 50 miles of the site of the proposed annual public fair, showing that a copy of this application was sent with each letter.

IMPORTANT NOTE: Florida has a broad public records law (Chapter 119, Florida Statutes). Most written communications to or from FDACS are public records obtainable by the public upon request. This application and any supporting documentation may be considered public and will only be withheld from disclosure if deemed confidential or exempt pursuant to the laws of the State of Florida.
