Moreover, I understand that not all sales texts are a violation, for instance, when: 1. a prior or existing business relationship exists; 2. in response to an express request of the person called; 3. from a newspaper publisher; 4. in connection with an existing debt or contract; 5. a real estate agent responds to my advertisement. Further, I understand that texts from political parties, research/survey companies, collection agencies and organizations requesting a donation generally do not sell products or services and therefore are not making a sales text in violation. I understand that the ability of the department to successfully pursue action depends, in part, on the accuracy and timeliness of the information provided.
