INDEMNITY BOND (\$300,000)

KNOW ALL MEN BY THESE PRESENTS:

That we, _____ as principal,
and _____, as surety, are held and firmly bound to pay
unto _____ as Governor of the State of Florida, and his/her successors in
office, the penal sum of Three Hundred Thousand Dollars (\$300,000), for the payment whereof, well and truly to be made,
we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these
presents; provided however, that the aggregated liability of the surety to all persons shall in no event exceed the said penal
sum of Three Hundred Thousand Dollars (\$300,000).

The condition of this bond is such that, whereas, the above bounden principal has applied to the Department of
Agriculture and Consumer Services of the state of Florida for a license to be issued by said Department to engage in the
business of _____, in pursuance of the provisions of Chapter 527, Florida
Statutes, such Act being a law regulating such aforesaid business: _____

Now therefore, if the above bounden principal shall well and truly comply with the provisions of the aforesaid Act and
all such rules and regulations as said Department of Agriculture and Consumer Services may prescribe with respect to the
conduct of the aforesaid business: _____,
for which such principal seeks a license and shall indemnify and save harmless any and all persons from loss of damage by
reason of the above principal's failure to comply with any of such provisions of said Act or any of such rules and regulations,
then this obligation to be null and void, otherwise to be and remain in full force, virtue and effect.

Provided further, that in the event of any claim and/or claim payment by the surety under this bond the surety shall forthwith notify the Chief of the Bureau of Compliance, Department of Agriculture and Consumer Services of the state of Florida at Tallahassee, Florida, of said claim and/or claim payment; and provided further that either the principal of the surety may cancel this bond by giving thirty (30) days written notice to the Department of Agriculture and Consumer Services at Tallahassee, Florida, and if cancelled by the surety, a copy of said cancellation notice shall be sent by mail to the principal at his business address. In case of such cancellation, no further obligation shall be incurred under this bond by the surety after the expiration of said thirty (30) days, but the liability of the surety shall apply as above set out as to any acts or omissions which may have occurred prior to the effective date of such cancellation.
