2. Affiant has personally inspected the amusement rides listed in the table on page 2 of this form on the date indicated, and certifies that all of the amusement rides listed are in general conformance with the requirements of Section 616.242, Florida Statutes, and Rule Chapter 5J-18, Florida Administrative Code, as well as manufacturer required or recommended bulletins.
3. Affiant certifies that, as a part of the annual permitting process, each amusement ride listed in the table has undergone at least a visual nondestructive test for metal fatigue, conducted by a Level II or Level III technician, unless exempt from nondestructive testing by Section 616.242(7)(d), Florida Statutes, and:
 - a. All nondestructive tests are current.
 - b. All nondestructive tests required or recommended by the manufacturer were conducted.
 - c. Unless exempt each identified inspection point on the amusement ride has received at least a visual nondestructive test, and that visual nondestructive test is adequate for the amusement ride to be in general conformance with the requirements of Section 616.242, Florida Statutes, and Rule Chapter 5J-18, Florida Administrative Code.
 - d. For those amusement devices for which the manufacturer has not required or recommended a visual nondestructive test, affiant has designated the required non-destructive test, the component area and frequency or testing of the component to be tested.
 - e. Maintenance plan/schedule has been reviewed and is current per ASTM F770-18 as incorporated by reference in rule 5J-18.0011, F.A.C.
