To qualify under the provisions of Chapter 601, Florida Statutes, to guarantee payment of citrus excise taxes to the State of Florida, Department of Citrus, every handler of citrus fruit shall:

File with the Department of Citrus a good and sufficient cash bond or surety bond executed by the handler as principal and by a surety company qualified and authorized to do business in this State as surety, to be approved by the Department of Citrus, based on the following formula:

#### Step 1

Multiply the number of boxes utilized in the prior season or estimated utilization during the current season, whichever is greater, times the current tax rate for each variety to determine the total estimated tax.

#### Step 2

Divide the total estimated tax by the number of weeks for which tax returns were required to be filed during the previous season to determine the estimated weekly tax due.

#### Step 3

Multiply the estimated weekly tax due times two to determine the amount of bond required.

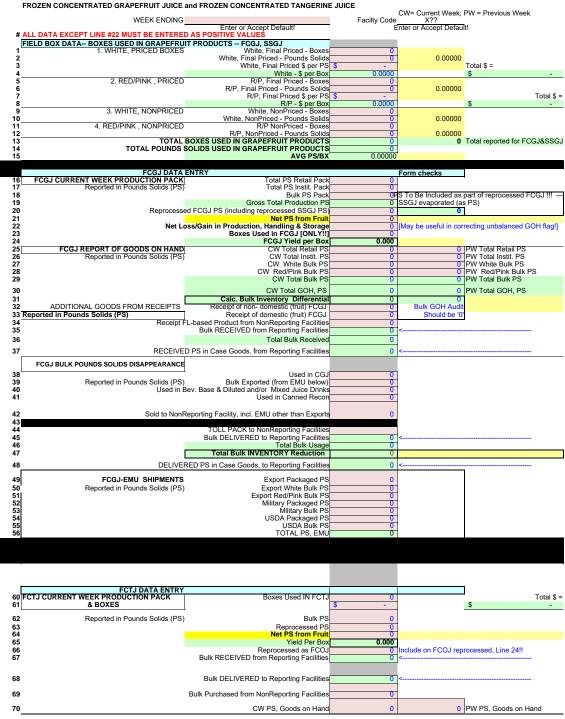

#### Deadlines for data submission – Thursday, Noon (data for the preceding week)

#### FDOC STATISTICAL DATA

Overview – each week, every processor and storage facility submits its production, inventory, and movement data to FDOC headquarters. These submissions meet the State of Florida laws and Florida Department of Citrus rules with respect to requirements of citrus fruit dealers, citrus processors and storage facilities to report required citrus production statistics. FDOC compiles the data for the industry as a whole, while allowing for confidentiality of individual facility data. The Forms used to submit data are also provided by the FDOC and are submitted in electronic format via e-mail.

FDOC personnel record the incoming data within spreadsheets in workbooks for further compilation of raw data. Data is compiled for a specific reporting 'week' and is identified according to a 'Week Ending' date. By convention, the end of the reporting week is set for midnight Saturday. Data from previous weeks and years is also entered into the weekly compilation workbook. From the compiled data, reports are generated for publishing to the industry and to other interested parties. The reports are also published on the FDOC website, fdocgrower.com.

The process of compiling and reporting data is divided into several major activities –

• Compilation of individual processor and storage facility data, and the entering of data on categorized forms provided by FDOC. The forms are supplied to each Reporting Facility by FDOC as individual spreadsheets in a workbook. Completed forms (the whole workbook) are submitted via email to FDOC headquarters in electronic format, or occasionally by fax if necessary. Each set of forms is identified by a 'Week Ending' date, and a facility 'code' (not the facility name) used to identify the facility. The data and forms provided weekly by facilities to FDOC are treated with great confidentiality. Only the combined data from all facilities is published.

- Weekly data compilation personnel at FDOC utilize additional spreadsheets each week to enter and compile data. Preparation includes importing previous week and year's comparative data, and the setting of certain universal labels and parameters required for each week's calculations and reports. As data is received, each facility's data is entered under a 'code' identifier to keep the information confidential. Data checks points where the data is auditable or comparable on different forms -- are built in that allow the FDOC personnel to review and confirm the accuracy and 'reasonableness' of the information provided.
- Weekly Reports the data is organized into compilation and calculation areas associated with
  various categories of production, inventory, and movement, e.g., an area for production and pack,
  inventory changes, and movement compilation data exists for each product area --- FCOJ, FCGJ
  and FCTJ, and single strength juices. Specific compiled data is grouped for reports and each report
  is then converted into Adobe .pdf format for publication.

# FDOC DEFINES THE WEEK OF REPORTING DATA AS RUNNING FROM SUNDAY TO SATURDAY, ENDING AT MIDNIGHT, SATURDAY

Individual Reporting Facilities may operate under a different definition of 'work week'. All facilities are requested to report their data in a consistent manner, as of the end of their defined 'work week' closing day.

#### **Statistics Reporting Definitions**

#### **Hybrids and Tangerines**

- 1. **MURCOTTS** Murcotts when processed alone, (i.e., not with round oranges), into Murcott concentrate, shall be reported on same basis as tangerines since they are legally classified as tangerines. The concentrate shall be reported as total Pounds Solids (PS).
- 2. **TEMPLES AND TANGELOS** Temples and tangelos are legally classified as oranges and shall be reported as round oranges whether processed alone or together with round oranges. The concentrate from this fruit shall be reported as total Pounds Solids (PS).
- 3. **TANGERINES AND MURCOTTS** Tangerines and/or Murcotts when processed together with round oranges shall be reported on same basis as round oranges. 'Dancy' and 'Robinson' tangerine varieties have been removed from the lists of fruits with classification standards ('Non-classified' tangerine/mandarin types and should not be reported as Tangerines).
- B. Price definitions for fruit used in the production of concentrates and single strength juices
- 1. <u>"SPOT"</u> Fruit delivered to the processor's yard with no pre-determined price or with a price based on the yard price or prices for that given day.

- 2. <u>"CONTRACT"</u> Fruit purchased on a basis where a price is stated or is determinable on the basis of specified language or data (other than the yard price), and for which the price is available during the week of fruit processing. (This includes bulk contracts).
- 3a. <u>"FINAL PRICE"</u> A price (either stated in contract language, or to be determined based upon contract language) which is known or will be determined before or during the week of fruit processing. This may also include contracts with 'floor' and 'rise' language, if the FINAL price or pricing basis for the 'rise' is known during the week of delivery/processing.
- 3b. "INTERMEDIATE PRICE" A price (either stated in contract language, or to be determined based upon contract language) 1) before the final price is known, and 2) for which the Final price may be greater but not less than the Intermediate price, and 3) which only the (Intermediate) price is available during the week of fruit processing. This may also include contracts with 'floor' and 'rise' language, if the FINAL price or pricing basis for the 'rise' is NOT known during the week of delivery/processing.
- 4. "<u>LONG TERM"</u> Fruit purchased on a multi-season basis, including fruit with prices established prior to current crop season, fruit contracted for the current and future seasons, and for multi-year future seasons (long term contract basis--LTC).
- 5. "OTHERS (COOP., PROCESSOR OWNED, ETC.)" Fruit which is not purchased by the processor see definition below for 'non-priced fruit'
- 6. <u>"WEEK OF PROCESSING"</u> The "week of processing" is the week within which the fruit is received and processed. FDOC defines each processing week to run from Sunday to Saturday. Each week ends at midnight on Saturday.
- 7. "LAST REPORT" The "last report" is the report for the last week of the fruit processing season in which processing from fruit takes place.
- 8. <u>"NON-PRICED FRUIT"</u> -The reporting instructions exclude the reporting of fruit as "priced" (spot, contract, or intermediate):
  - (1) if the fruit was delivered/sold by a corporation to itself, or
  - (2) if a subsidiary corporation delivered/sold its fruit to a parent corporation, or
  - (3) if an owner, major stockholder, officer or employee of a processing corporation delivered/sold their fruit to the processing corporation.
  - (4) Fruit falling under any of the above three categories would be reported as non-priced fruit.
- **"Concentrate"** refers to juices that have been processed through an evaporator to remove a substantial amount of water. Concentrated citrus juices are most commonly identified by the percentage of "Pounds/Solids" remaining in the concentrated form ("degrees Brix").
- <u>"Pounds/Solids"</u> a.k.a. Pounds Solids, Juice Solids, "PS" a basic and standardized measurement of the amount of dissolved citrus sugar (plus a few other chemical components like citric acid) found in juice. Also referred to as "Percent sugar solids" or "degrees Brix" (e.g., 42° Brix). Fruit delivered to a processing plant is most often contracted for, and paid for, in terms of the Pounds of Solids in a load of fruit. Juice produced at a processing plant is most often referenced at a given 'Brix' value, i.e., at a given percent of sugar solids.
- "Advertising Tax" refers to taxes imposed by the Florida Department of Citrus (FDOC)
- "Inspection Fees" refers to fees for 'test house' inspections on incoming fruit by the Florida Department of Agriculture (or its agent)
- <u>"Retail"</u> goods packaged in various configurations (units per case, various sizes i.e., '48/6', referring to 48, 6 oz units per case; typically, retail units are not consumed at the point of purchase

- <u>"Institutional"</u> goods packaged in various configurations (units per case, various sizes i.e., '12/32', referring to 12, 32 oz units per case; typically, institutional units are typically consumed at the point of purchase or service (e.g., schools, hospitals, prisons) or industry (including restaurants, food-caterers, cafeterias, hotel chains, airlines). Most Institutional packs are 32 oz. or more.
- <u>"Bulk"</u> refers to all non-retail or non-institutional packaged forms of FCOJ/FCGJ/FCTJ/SSOJ/SSGJ/SSTJ, including, pails, bins, totes, barrels, and tankfarm stored products
- "Total Gross Gallons" includes all retail, institutional, and bulk product
- "Reprocessed" refers to any previously manufactured products being packed, packaged, or blended into the same or a different form. Concentrates may be 'reprocessed' by actions such as reconstitution into single strength form, or by packaging into retail, institution, or bulk forms of concentrates. Single strength juices may be 'reprocessed' by activities such as packaging, blending SSJ for bulk shipment, or by evaporation to produced concentrated forms.
  - Data entry must take into consideration the proper Pounds Solids associated with volumes at different Brix values and the final form of the product. When entering data for 'reprocessing', the reprocessing value is to be associated with the final form of the product (e.g., concentrate), and not necessarily the form of the starting material. When SSJ is evaporated into concentrate, the PS being reprocessed are credited to concentrate the PS produced become a 'receipt' of PS to the concentrate inventory (as well as a reduction in the SSJ inventory). The total PS of inventory remains substantially the same only the form of the juice product changes. 'Re-processed' always refers to production activities utilizing previously existing juices (usually from storage); reprocessed juices are considered differently from 'new' juice freshly extracted from fruit.
- "Chilled Juice" refers to any juice at 'Single Strength Equivalence' (single strength orange juice is defined to be juice at less than 20° Brix; grapefruit single strength juice is only defined as "unconcentrated" by US Standards of Identity). Chilled juice may be produced from juice as it expressed (extracted) from fruit, or juice prepared by reconstitution of concentrated juice with water. Both 'Not From Concentrate' juices and juices reconstituted from concentrates are considered to be 'chilled juices'.
- "Total Net Pounds Solids (PS)" or "Net Pounds Solids (PS) from Fruit" is calculated as Total Gross PS produced minus Reprocessed PS; the resulting PS figure represents the PS of juice from fruit for the week. All production must come from one of two sources fruit, or pre-existing (reprocessed) inventory. The Total Gross PS reported as 'produced' [packed or produced] MUST equal the total PS supplied as reported as coming from the combination of PS from Fruit, and Reprocessing PS.
- "Reported Net Loss or Gain" refers to circumstances where the previous week's ending inventory, plus all receipts, and minus all usages, does not total to the measurement or calculation of current week's ending inventory. 'Net losses or gains' represent this discrepancy. All facilities should pay attention to significantly large or commonly occurring net loss/gain values being reported. Consistently significant net loss/gain values should be reported to production/management for investigation of cause(s). NET LOSS VALUES ARE THE ONLY NEGATIVE VALUES THAT MAY BE REPORTED ON PROCESSOR STATISTICS DATA ENTRY/INPUT FORMS- ALL OTHR VALUES MUST BE REPORTED AS POSITIVE VALUES!!
- <u>"Yield, Gal/Bx"</u> is calculated as Total Net Gallons [from fruit]/Total Boxes fruit for the named product (FCOJ/FCGJ/FCTJ/SSOJ/SSGJ); this value is calculated from the PS/Box yield.

- "Goods on Hand" Inventory held and or controlled, in Pounds Solids (PS), for all goods (packaged or bulk) at the close of the reporting week. Goods On Hand is to include all physical inventory of products held in the reporting facility's warehouses within the State of Florida, or held and controlled by you in non-reporting facilities outside storage within the State of Florida. It does NOT include product owned by you but held within another reporting facility's warehouse(s); that inventory is to be reported by the other reporting facility(s). It includes inventory held in your warehouses for both reporting and non-reporting entities (Co-packed or other stored product). It includes inventory covered by (i) firm contract; (ii) bill and hold; (iii) unshipped confirmed orders; (iv) by bearer warehouse receipts held by you without regard the source of the product and without regard to whether the product is intended to be delivered in fulfillment of futures contracts; (v) includes foreign imports even though under Customs bond and even though duty is unpaid; and (vi) toll pack product.
- "Brix equivalent" gallons of juice converted on the basis of Brix value (sugar content), to gallons of juice at another Brix value; tables for converting one Brix value and volume to another Brix value and volume are available.
- "Non-Domestic (Fruit) Product" products produced from non-domestic fruit sources. This category is also meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This category is also used to capture non-domestic FCOJ held in the US and transported into Florida, where the <u>fruit</u> source for the product is non-domestic fruit.
- "Domestic (Fruit) Product" products from domestic fruit sources other than Florida fruit (this may include U.S. state and U.S. protectorate sources). This category is meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.).
- <u>"FL-based Product, Non-Reporting Facility"</u> product already based in FL that is stored or supplied to a Non-Reporting (Florida-based) Facility. 'Non-Reporting Facility' is any third-party possessing product in Florida, not currently reporting data to FDOC. The FDOC rules attempt to capture data from most Florida parties or facilities handling citrus products, but there some facilities that are exempt, or otherwise not currently reporting to FDOC, and there may be the occasional receipt from such facilities.
- <u>"Disappearance"</u> in context refers to reduction of inventory by various activities; this data primarily tracks the usage of concentrates to produce other products, and to track the associated reduction in concentrate inventory
- "Used in Chilled Juice" in the context of concentrate disappearance, chilled juice refers to juice prepared by reconstitution of concentrated juice with water. This category of disappearance is used to account for PS reduction in concentrate inventory, AND the PS must also be reported on Input Form SSJ as part of the 'reprocessed' product used in the total production of 'chilled juice' (on the SSJ form, chilled juice includes both reconstituted and Not From Concentrate (NFC) juice production).
- <u>"Bulk Pounds Solids Exported"</u> "Exported" any product exported out of the United States (This will include Canada).
- "Used in Beverage Base or Diluted Drinks" refers to the use of concentrated products for the
  purpose of producing beverage base products, blended juice products, or other products composed of
  less than 100% juice

- <u>"Used in Canned Recon"</u> use of concentrated inventory to produce re-constituted juices (where water is added to concentrate to reduce the Brix value of the product to levels defined as 'single strength juice'), and to produce canned products.
- "TOLL PACK to Non-Reporting Party" Toll Packed products are generally products processed/packaged for a third party. For reporting purposes, delivery of product is reported as "Toll Pack" whether delivered during the week of processing or not. "Toll Pack" amounts are reported as 'disappearance' only during the Reporting Week that the product is delivered (when inventory is relieved). The most common circumstance involves a third party delivering fruit to a processor for processing where the delivering party maintains ownership of the resulting product; when the processor delivers the stored product to the toll packer, or as directed by the toll pack product owner, the disappearance is reported under TOLL PACK. If the product is delivered to another Reporting Facility, it is to be reported as a intercannery/interfacility delivery.
- **"Sold (or Delivered) to a Reporting Facility"** includes bulk products transferred between Reporting Facilities; this category is recorded separately to allow transfer of products without creating a 'movement' (the net reported inventory does not change with such an exchange of products). Also 'Intercannery Transfer'.
- **E-M-U** [Export-Military-USDA]— Movement of Frozen Concentrates, Canned Products, and Chilled Juices
  - "Movement" delivery of inventory by Export, or by Military or USDA purchase contracts.
    - "Export" Any product transported out of the country (this will include Canada)
    - "Military" contracts for sale to the United States Military Services
    - "USDA" -- contracts for sale to the United States Department of Agriculture

# FDOC INPUT FORM FB/FCOJ ORANGE FIELD BOX DATA and FROZEN CONCENTRATED ORANGE JUICE

Input Form FB/FCOJ is to be filed weekly, when fruit is being processed for any orange product, when FCOJ is being produced by fruit processing, and during those weeks when fruit is not being processed but in which FCOJ products are being processed/reprocessed for packaging and bulk activities. Input Form FB/FCOJ is designed to provide data that will be compiled and published by FDOC as Weekly Reports to the Florida citrus industry and other interested parties. ALL DATA ON THIS WORKSHEET MUST BE ENTERED AS POSITIVE VALUES, EXCEPT FOR LINE 26 - 'NET LOSSES/GAINS'.

#### Input areas include --

- (1) **FIELD BOX DATA—BOXES USED IN ALL ORANGE PRODUCTS**--data associated with the amount of fruit delivered/processed, the Pounds/Solids (PS) realized, and the pricing associated with that fruit for the week; data will generate calculations of the yields of FCOJ in terms of both gallons/box of fruit, and PS/box of fruit.
- (2) FCOJ CURRENT WEEK PRODUCTION PACK --data associated with the amount of processed concentrated products, processing of fruit into FCOJ, reprocessing of existing FCOJ, and the combined packaging and bulk manipulation of FCOJ for the week;
- (3) **FCOJ REPORT OF 'GOODS ON HAND'** --data associated with inventories, receipts and deliveries of FCOJ products to third parties, and data for transfers of FCOJ products among and between the reporting Facilities (Intercannery/Interfacility Transfers ICT)
- (3a) FCOJ BULK POUNDS SOLIDS (PS)-- USAGE data associated with the various categories of usage of bulk FCOJ at a reporting facility; *aka* 'disappearance'
- (3b) **FCOJ EXPORT-MILITARY-USDA** [E-M-U] **PURCHASES** data associated with activities specifically for Exports, Military Purchases, and USDA purchases.

As with all data Forms, accuracy in data reporting, and auditing of data inputs, is extremely important. The electronic format of **Input Form FB/FCOJ** incorporates multiple auditing evaluations and warning 'flags' that evaluate data for accuracy and reasonableness. Specific calculations and audits are described below.

#### Input Form FB/FCOJ - Specific Data Entry Instructions

#### FIELD BOX DATA—BOXES USED IN PRODUCTION OF ORANGE PRODUCTS (FCOJ,

**SSOJ)**. On **Input Form FB/FCOJ**, each data entry, or calculation, line is numbered. Several cells on the worksheet will 'flag' errors such as missing data or data that produces values outside of expected historical or otherwise reasonable values. Flags may appear, then disappear as expected (or yet to be entered) data is entered. Facilities are expected to audit/review their data and to correct data associated with flags before submission of data to FDOC.

<u>Tangerine/mandarin fruit</u> received and co-processed with round oranges are to be reported on Form FB/FCOJ. Tangerine varieties that meet the federal/state standard of identity for 'tangerine' and that are processed solely as 'tangerine' products are to be reported on **Form FCGJ/FCTJ** (in the 'FCTJ' section).

N.B. --Note that starting from the 'delivered in' price, neither advertising tax nor inspection fees should be included when reporting the average price per PS; 'average prices' are to be reported as 'weighted average prices' (average of costs for all PS and all boxes for each category).

#### PRICED FRUIT --With Final Price Known For Fruit Received During The Week Of Reporting

## <u>'1. Final Spot And Contracted Prices Basis Established For Current Crop Season Only (S/CSC)'</u>

This category may also include contracts with 'floor' and 'rise' language, if the FINAL price or pricing basis for the 'rise' is known during the week of delivery/processing.

- **Line 1-** Enter the number of boxes of fruit acquired for the week on a 'Spot' or current season 'Contract' basis, where the pricing has been established, and final pricing is based upon the current crop season only (S/CSC). If a value is entered on Line 1, audit flags will 'expect' a value to be entered on Lines 2 & 3.
- **Line 2** Enter the number of Pounds Solids (PS) acquired for the week on a S/CSC basis. This is the total of PS reported by the State Test House for the boxes received and reported on Line 1. Audit flags will check for reasonable yields.
- **Line 3** Enter the weighted average price for the PS reported on Line 2. The 'weighted average price' per PS should be calculated as the sum of dollars required for total PS received on a S/CSC basis, divided by the total PS received on a S/CSC basis.
- **Line 4** Calculates the S/CSC \$price/box by dividing the sum of dollars required for the total PS received, by the number of total boxes received on a S/CSC basis.

## <u>'2. Final Pricing Basis Established Prior to Current Crop Season, or for Current and/or</u> future seasons (Long Term Contract Basis--LTC)

- **Line 5** Enter the number of boxes of fruit acquired for the week on an LTC [Long Term Contract] basis. If a value is entered on Line 5, audit flags will 'expect' a value to be entered on Lines 6 & 7.
- **Line 6** Enter the number of Pounds Solids (PS) acquired for the week on an LTC basis. This is the total of PS reported by the State Test House for the boxes reported on Line 5.
- **Line 7** Enter the weighted average price for the PS reported on Line 6. The 'weighted average price' per PS should be calculated similarly as described above.
- Line 8 Calculates the LTC \$price/box by dividing the sum of dollars required to acquire the total PS, by the number of total boxes acquired for the week on an LTC basis.

## PRICED FRUIT --With Only an Intermediate Price Known For Fruit Received During The Week Of Reporting

#### '3. With Only a Known Intermediate Price'

- **Line 9 -** Enter the number of boxes acquired for the week, <u>With only a Known Intermediate Price.</u> This includes 'Participation' pricing, both seasonal and multi-year; this may also include contracts with 'floor' and 'rise' language, if the FINAL price or pricing basis is <u>not known</u> during the week of delivery/processing. If a value is entered on Line 9 audit flags will 'expect' a value to be entered on Lines 10 & 11.
- **Line 10** Enter the number of Pounds Solids (PS) acquired for the week on a Known Intermediate Price basis. This is the total of PS reported by the State Test House for the boxes reported on Line 9.

**Line 11 -** Enter the weighted average price for the PS reported on Line 10. The 'weighted average price' per PS should be calculated similarly as described above.

**Line 12 -** Calculates the Known Intermediate Price \$price/box by dividing the sum of dollars required to acquire the total PS, by the number of total boxes.

NON-PRICED FRUIT – Final or Intermediate prices are not known for Fruit Received During The Week Of Reporting, or prices otherwise not reported by instructions. Non-priced fruit may be fruit for which a facility is 'co-packing' for another facility, where the processing facility does not know, or is not provided, the price of the fruit being co-packed.

#### '4. WITHOUT Final or Intermediate Price Known'

Line 13 - Enter the number of boxes acquired for the week with no Final or Intermediate pricing known during the week the fruit is received.

**Line 14** - Enter the number of Pounds Solids (PS) acquired for the week for the boxes with no Final or Intermediate pricing known. This is the total of PS reported by the State Test House for the boxes reported on Line 13.

#### '5. Others (Co-ops, Processor Owned)'

Line 15 - Enter the number of boxes acquired for the week on an 'Others' basis during the week the fruit is received. This includes boxes for which prices are not reported due to price reporting instructions (fruit owned by a Co-op, owned by a processor, processor employee owned, etc.)

**Line 16** - Enter the number of Pounds Solids (PS) acquired for the week on an 'Others' basis. This is the total of PS reported by the State Test House for the boxes reported on Line 15.

#### **SUMS**

Line 17 – Calculation that sums the total boxes reported for all categories of fruit used in the production of orange products. This sum is also used later for Yield and Average Prices per box calculations. Cells to the right will report the sum of boxes reported as used for FCOJ and SSOJ on their respective Data Input Forms. These values should be audited for equivalence! The total of boxes used for producing FCOJ and SSOJ must equal the total of boxes received.

**Line 18** - Calculation that sums the total PS reported for all categories of fruit used in the production of orange products. This value is also used later for 'Yield' and 'Average PS per box' calculations.

Line 19- Calculation of the yield of 'Avg. PS/Box' from the totals on Lines 17 and 18. The cells in the columns to the right side of column 'D', Lines 1 to 19, contain various audit functions and formulas. These auditing cells 'flag' (present) a message only when an occurrence of data entry is not properly matched with other required data e.g., entering boxes without entering PS, or entering values for the number of boxes in a section of priced fruit without entering a price. There are also calculation cells that show the total dollars for each pricing category.

All 'PS/Box' yields are calculated for each category, and flags are raised when the yield values calculated do not fall within expected ranges.

Each auditing, flag, and calculation cell is 'locked' [as are other cells that have a light green background]. All locked (usually with light green or yellow background) cells are either calculation cells, or the accompanying descriptions. Cells with a yellow background are also locked, and are associated with key data points, 'flags' or other auditing information.

**FCOJ CURRENT WEEK PRODUCTION PACK** – On **Input Form FB/FCOJ**, Production data is entered showing the total production (*aka* 'pack') of FCOJ from fruit, and from pre-existing inventories, along with certain packaging, reprocessing, and production associated adjustments to inventory. This data will be utilized to test inventory balances, to provide 'movement' calculations, and to calculate production activities. The production of FCOJ is to be reported on the basis of total Pounds Solids (PS) produced/utilized, by category, for the week.

The auditing system assumes that the total amount of 'production' (pack) PS for all packed materials must be matched by the total amount of PS used. The total amounts of PS used must come from 're-processing' (meaning reworking and using pre-existing solids) or from fruit processed for the week ('new' solids). The production total PS must equal the source total PS used. If this equivalence does not occur, a flag will appear stating 'Net PS DO NOT Calculate'. This flag must be cleared by changing one or more values. The amount of production and the amount of reprocessing reported will be used in auditing processes performed later for Goods On Hand. This 'Net PS' calculation does not incorporate production, handling, or storage losses or gains. That net (loss/gain) value is associated with inventories reported and audited later.

- Line 20 Enter total PS of FCOJ packed (packaged) into 'Retail'-sized units
- Line 21 Enter total PS of FCOJ, that have been packed into 'Institutional'-sized units
- Line 22 Enter total PS of FCOJ that have been packed or stored in 'Bulk'-type containers ((pails, totes, tankfarm tanks, etc.)
- Line 23 Calculation sum of Lines 20-22; termed 'Gross Total Production PS'
- Line 24- Enter the total PS of FCOJ 'reprocessed'. This value represents the volume of pre-existing inventory that was re-used during the current week to generate all or part of the reported activity in 'Retail' or 'Institutional' packaged goods, and all or part of the 'bulk' packaged/processed/produced. Reprocessing amounts for FCOJ may also include the amount of FCTJ (Frozen Concentrated Tangerine Juice) PS blended with FCOJ, Single Strength Orange Juice (SSOJ) PS evaporated to produce FCOJ, and received (incoming) FCOJ PS manipulated, blended, and either packaged or transferred to bulk storage. On Line 24, adjacent cells will show values you have entered (or must enter) on Forms FCGJ/FCTJ, Line 66, 'FCTJ Reprocessed' (as FCOJ), and Form SSJ, Line 9, 'Evaporated SSOJ PS' (into FCOJ). The value shown in the adjacent cells will come from data entry on FCTJ & SSOJ respective Input Forms. These volumes ARE NOT automatically entered as part of the value on Line 24; they are there as a reminder to you to include them in the 'reprocessed' value.
  - a. When there is no fruit processed, it is assumed that all packaged or bulk goods produced have come from the 'reprocessing' of pre-existing or received FCOJ, FCTJ, or SSOJ inventories. When SSOJ is evaporated, those solids are considered to be part of FCOJ 're-processing', not SSOJ re-processing; the product type being made is the key.
  - b. When fruit is being processed, it is important that processing activity associated with 'new' inventory (that came from fruit processing) is distinguished from processing and packaging activities that involve pre-existing ('old') inventory.
  - c. FDOC compiles and reports separately the value of 'new' inventory that is created strictly by the processing of fruit. This calculation sums all packing activities and subtracts all that activity that was derived from pre-existing inventory (e.g., 're-processing'). The solids derived only from fruit is called 'Net PS from Fruit'

d. Verify data on other Input Forms that report PS concentrate from tangerines, and from hybrids, and PS of SSOJ reprocessed into concentrate; these values must be reported as part (or all) of the reported 'reprocessed' FCOJ PS on Line 24.

Line 25 - "Net Pounds Solids (PS) from Fruit" -- calculated by the difference in "Reprocessed PS" and 'Gross Total Production PS' (Packed). This value is later used in the calculations and reporting of 'Yield' as FCOJ PS produced per box of fruit. It is important to report the value for 'Reprocessed PS' so that it includes known work-in-progress (WIP), carryover, or other juices derived from the reprocessing activities for the reporting week. This allows the 'Net PS from Fruit' value to represent only concentrates derived from <a href="fruit processing">fruit processing</a>. FDOC will assume that <a href="fruit PS From Fruit">IF NO fruit is reported as being processed for the Reporting Week</a> any value for 'Net PS from Fruit' is reported in error. The Input Form FB/FCOJ will calculate and compare these data entry points, and a flag will be generated if the data does not calculate appropriately.

A processor will often have an accurate measurement of the 'Net PS from Fruit', and will calculate the 'Reprocessed' value from known values for 'Pack' and 'Net PS from Fruit'. Either calculation is acceptable.

Line 26 – Enter known losses or gains realized during FCOJ production, handling, transportation, or storage. During production, it is common to experience losses or gains in packaged amounts or weekly inventory determinations, compared to calculated expectations. Spillage or other losses must also be accounted for in properly reporting current FCOJ Goods on Hand. This value shall include any known losses or gains occurring during the transportation of FCOJ between processors ('Intercannery transfers'), or transportation between storage locations controlled by a single reporting facility ('Interfacility transfers'). Failure to account for these gains or losses may give rise to 'false' movement figures for the industry as a whole. THIS IS THE ONLY LINE ON THIS WORKSHEET WHERE NEGATIVE VALUES ARE ACCEPTABLE!!!

**Line 27** - Enter the total boxes of fruit used ONLY for the production of FCOJ. <u>This value is critical</u> for calculating and reporting accurate Yield data for PS/box and gallons/box of 42° Brix FCOJ.

Line 28 – Calculates the 'Yield per Box' of fruit. The 'FCOJ Yield per Box' is calculated from the Total Boxes of fruit used in the production of FCOJ, and the Net [FCOJ] PS from Fruit; if the calculated value falls outside of expected (historical) ranges, a flag will be generated. FDOC expects facilities to audit data entry forms for flags and to address the questionable data. Reasonable FCOJ PS yield values have historically ranged between 4.1 and 8.2 PS per box.

The yield in terms of PS of FCOJ per box of fruit is a key value used by the industry, expressed in equivalent Gallons of 42° Brix FCOJ on FDOC Weekly Reports. It is critical to report the 'Net PS from Fruit', and 'Boxes Used in FCOJ (ONLY!)' values correctly.

FCOJ REPORT OF GOODS ON HAND-- Input Form FB/FCOJ provides data entry points for Goods on Hand (GOH) for both the current week (CW), and the previous week (PW). This data is needed to support calculations of both individual facility and combined Reporting Facility data 'movement' values, and to provide key data for auditing the 'reasonableness' and accuracy of data within a facility's GOH reporting. Values are reported as Pounds Solids (PS) GOH.

Report all inventories held by you within your facilities or held for you under your control at an outside storage facility that does not report to the FDOC. All storage facilities of a certain size are required to report inventory and production activities to FDOC, but in the rare case where

this is not true, each facility is responsible for reporting that inventory. Your facility is also responsible for reporting any inventory you hold, whether it is owned by you, owned by another Reporting Facility (or its subsidiaries), or inventory held under your control for any other party. You are not responsible for reporting your inventory held and controlled by any other facility currently reporting this data to the FDOC.

Line 29 – Enter both the CW and PW values for 'Retail' Goods on Hand.

Line 30 - Enter both the CW and PW values for 'Institutional' Goods on Hand.

Line 31 - Enter both the CW and PW values for 'Bulk' Goods on Hand.

Line 32 – Calculation that sums the total Goods on Hand, both PW and CW

Line 33 – Calculation of 'Bulk Inventory Differential' -- Input Form FB/FCOJ will calculate the 'net' change in bulk inventory (Line 33) by summing production, net losses/gains, and all receipts of bulk products to the PW GOH, and subtracting reprocessing and CW bulk GOH. This calculation generates a weekly 'Bulk Inventory Differential' that reflects the net changes in inventory value due to processing, production packing, and receipts. This value will be later compared to the sum of all forms of bulk FCOJ usage ('disappearance'). Those values must be equal, and this calculation provides an audit trail for verifying accurate reporting of the CW bulk Goods on Hand.

#### Receipts of bulk Inventory, with reporting based upon sources

Line 34 – 'Receipts of Non-Domestic (Fruit) Product' – enter the PS of bulk FCOJ received that was produced from non-domestic fruit sources. This category is also meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This category is also used to capture non-domestic FCOJ held in the US and transported into Florida, where the <u>fruit</u> source for the product is non-domestic fruit. This Line is also where you are to report receipts of 'blended' FCOJ products where <u>no domestic fruit</u> product sources are declared as part of the blend, but would include blends of any combination of declared non-domestic fruit origin products.

Line 35- Receipts of Domestic (Fruit) Product' – enter the PS of bulk FCOJ received which was produced from domestic fruit sources other than Florida fruit (this may include U.S. state and U.S. protectorate sources). This category is meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This does not include non-domestic fruit brought into the US and processed domestically.

This Line is also where you are to report receipts of 'blended' FCOJ products where a domestic fruit source product is declared as part of the blend.

Once a non-Florida (fruit source) product (domestic or non-domestic) product is reported as received in Florida, it is only reported as a domestic/non-domestic receipt the one time; once included in the Florida industry inventory, the product becomes 'Florida-based' inventory and the fruit source distinction is no longer relevant to these reporting instructions. Only the facility that first takes physical possession within Florida (or ownership if the received product is transferred to a third party [non-reporting] storage facility under the Reporting Facility's control) will report the amount as a receipt of a domestic/non-domestic product. If, for instance, one Reporting Member moves any bulk FCOJ product (e.g., Brazilian FCOJ or All-Florida FCOJ) within Florida to another Florida facility, it is reported as 'Bulk Delivered to a Reporting Facility (Line 47 below); it is not again to be reported/categorized as a 'domestic/non-domestic receipt/delivery'.

**Line 36** -'Receipts of FL-based Product from Non-Reporting Facility' – enter the PS of product already based in FL that has been received from a Non-Reporting (Florida-based) Facility. 'Non-Reporting Facility' is any third-party possessing product in Florida, not currently reporting data to FDOC. The

FDOC rules attempt to capture data from most Florida parties or facilities handling citrus products, but there some facilities that are exempt, or otherwise not currently reporting to FDOC, and there may be the occasional receipt from such facilities.

'Foreign Imports', and 'Domestic receipt of a non-FL product' -- this terminology was used previously in reporting receipts into Florida facilities, and distinction was made between 'dutiable' and 'nondutiable' or 'zero rate duty' FCOJ products. Those distinctions are no longer utilized within these reporting instructions for domestic and non-domestic product receipts.

Line 37 – A total of 'Bulk RECEIVED from Reporting Facilities' appears in the Line 37 summation cell. This data captures one part of the transfer of bulk products between all Reporting Facilities. Receipt data is entered into the adjacent section (to the right) of the Input Form FB/FCOJ as receipts of bulk FCOJ from each specific processing or storage facility. Enter the PS of bulk FCOJ received from each of the Reporting Facilities listed; each current Reporting Facility's abbreviation is listed so that data is entered in a specific cell. Do NOT change headings or create your own. If you have a transaction with an unlisted facility, please contact FDOC Staff for instructions. The worksheet 'Facility Abbrev' provides translations of the abbreviations.

- a. Report as 'Bulk Received from a Reporting Facility' the transfer of product from your facility to, or from, an outside storage facility in Florida (also a Reporting Facility). When losses and gains associated with such transfers are realized, those volumes will be reported to FDOC as part of "Net Gains or Losses due to processing, handling, and storage" for the week.
- b. Intercannery/Interfacility Transfers (ICT) differentials are maintained and tracked separately for the purposes of isolating these amounts from other calculations of 'movement'. From the perspective of the Florida citrus industry, an ICT of FCOJ from one Reporting Facility to another is equivalent to moving FCOJ from one tankfarm to another within a single facility --- there should be no net change in total GOH once the transaction has been completed. Recognized gains or losses during ICT should be reported as part of FCOJ 'Net Loss/Gain in Production, Handling & Storage' on Line 26.

In the short term, ICT differentials may often be generated due to timing issues in shipping and receiving bulk goods. Data submitted to FDOC for any one reporting week may not capture all ICT shipments and receipts that actually occurred over more than one effective Week Ending reporting date. One facility may ship product in one reporting week, while the receipt of that product is accounted for in a following reporting week by the receiving facility. FDOC will track net ICT, and identify unbalanced transfers, throughout the season.

Do NOT report the transfer of products between you own company storage facilities if they do not separately report data to the FDOC. Those inventories are part of the total goods on hand you report every week, and these internal transfers do not require FDOC tracking. Recognized gains or losses during such transfers should be reported as part of FCOJ 'Net Loss/Gain in Production, Handling & Storage' on Line 26.

Line 38 – 'Total Bulk Received' – Calculation sum of Lines 34-37

**Line 39** – As with bulk FCOJ received from another facility, enter the amount, in PS, of Cased Goods of FCOJ received from a Reporting Facility in the area adjacent to Line 39.

**FCOJ BULK PS -- USAGE - Input Form FB/FCOJ** provides data entry points for several forms and categories of bulk FCOJ usage. The primary descriptions of FCOJ usages are also termed categories of 'Bulk FCOJ Disappearance'.

Line 40 – 'Used in COJ' - Bulk FCOJ PS Used in Chilled Orange Juices [COJ] (Packaged and Bulk) – Enter the PS of FCOJ used by the reporting facility in the production of Chilled Juice products. Do not report any values other than what is known to have occurred within your facilities or under your control (the point of this value is to account for part of your FCOJ 'disappearance'). A 'flag' may prompt you to check the data entry point on the SSJ Input Form for equivalence to this value. This value should be equal to the value shown on the SSJ Input Form, Line 4.

**Line 41** – 'Bulk Exported' – This value is referenced from data entry further down the Input Form (within the "E-M-U" data entries. This value will reflect the PS of bulk FCOJ used for export. This includes bulk FCOJ shipped to Canada.

Line 42 – 'Used in Beverage Bases and Diluted Drinks'-- Enter the PS of bulk FCOJ used by the reporting facility in the production of beverage bases, or in the production of diluted (less than 100% juice) drinks and blends.

Line 43 – 'Used in Canned Recon' – Enter the PS of bulk FCOJ used by the reporting facility in the production of reconstituted, and canned, products.

**Line 44** – 'Sold to a Non-Reporting Facility or Customer' – Enter the bulk PS of inventory sold/delivered to a third party (non-reporting) in or out of the State of Florida. This value should include <u>bulk</u> products sold under special purchase plans such as Military contracts, and USDA purchase plans. **Do Not** include exports; these are accounted for separately.

Line 45 – DELETED – NO LONGER USED

Line 46 – 'TOLL PACK to Non-Reporting Facility/Owner' - (Reported <u>during the Week Shipped</u>)— Enter the PS of bulk FCOJ used by the Reporting Facility in the production of product processed for a third party (Non-Reporting). For FDOC reporting purposes, product is reported as 'Toll Pack" during the week that the product is actually delivered, whether delivered during the week of production or not. "Copacked" products delivered to another reporting facility are reported on **Line 47**.

**Line 47** – 'Bulk Delivered to a Reporting Facility' (Includes Co-Pack amounts delivered to Reporting Facilities). – A total of 'Bulk DELIVERED to other Reporting Facilities appears in the Line 47 summation cell. Receipt data is entered into the adjacent section (to the right) of the **Input Form.** Enter the data as described above for Line 37 (Total Bulk Received).

- a. Do NOT record as bulk disappearance or usage the transfer of product between your facilities, or from your facility to an outside storage facility (non-Reporting facility), if you maintain ownership of the product shipped. This is an 'interfacility transfer', as described for Line 37. You have not changed your inventory and that type of change in warehousing should not be reported. When losses and gains associated with such transfers are realized, those volumes will be reported to FDOC as part of "Net Gains or Losses due to processing, handling, and storage" for the week.
- b. A list of current Reporting Facilities is included with these documents, and provided through updates from FDOC, to assist in the proper recording of 'intercannery/interfacility' transfers (between reporting facilities only)
- **c.** Do NOT include Futures transactions as additional values on Line 47. Futures transactions are not recorded separately from other transactions.

Line 48 – 'Total Bulk Usage' - Calculation sums Lines 40 – 47.

**Line 49** – 'Total Bulk Inventory Reduction' – Calculation that sums Line 40-48, and other bulk deliveries of bulk FCOJ, e.g., E-M-U shipments.

This calculated value is compared on **Input Form FB/FCOJ** to the value on Line 33. Any difference other than zero will generate a flag alerting data entry personnel that the data does not match; <u>a further audit of data entries should be made to determine the source of the discrepancies and clear this flag.</u> 'Round-off' differences will occasionally produce a value of +/- 1 that can be ignored.

**Line 50** – In the area adjacent (to the right) to Line 50, enter the amount, in PS, of any cased goods delivered to another Reporting Facility.

Line 51; Line 52 – No longer used

## FCOJ EXPORT-MILITARY-USDA [E-M-U] SHIPMENTS – Input Form FB/FCOJ provides data entry points for specific deliveries for Exports, Military Purchases, and USDA purchases.

Line 53 – Enter the PS amounts of packaged FCOJ products Exported (including Canada).

**Line 54** – This value is copied into Line 41 above for part of the 'disappearance' calculations. Enter the PS of bulk FCOJ used for export (including Canada).

Line 55 – Enter the PS of packaged FCOJ products delivered as Military Purchase.

**Line 56** – Enter the PS of bulk FCOJ delivered as Military Purchase; this amount should already have been included in the total reported on Line 44.

Line 57 - Enter the PS of packaged FCOJ delivered as USDA Purchase

**Line 58** – Enter the PS of bulk FCOJ delivered as USDA Purchase; this volume should already have been included in the total reported on Line 44.

Line 59 – Calculation that sums all EMU sales

# FDOC INPUT FORM FCGJ & FCTJ GRAPEFRUIT FIELD BOX DATA and FROZEN CONCENTRATED GRAPEFRUIT JUICE

Input Form FCGJ & FCTJ is to be filed weekly, when fruit is being processed for any grapefruit product, when FCGJ and or FCTJ is being generated by fruit processing, and during those weeks when fruit is not being processed but in which FCGJ or FCTJ products are being processed for packaging and bulk activities. Input Form FCGJ & FCTJ is designed to provide data that will be compiled and published by FDOC as Weekly Reports to the Florida citrus industry and other interested parties. ALL DATA ON THIS WORKSHEET MUST BE ENTERED AS POSITIVE VALUES, EXCEPT FOR LINE 26 – 'NET LOSSES/GAINS'!!! Instructions for the FCTJ portion of the Form are available as a separate set of instructions.

#### Input areas include --

- (1) FIELD BOX DATA—BOXES USED IN ALL GRAPEFRUIT PRODUCTS --data associated with the amount of fruit processed, the Pounds/Solids (PS) realized, and the pricing associated with that fruit for the week; data that generates calculations of the yields of FCGJ in terms of PS/box of fruit.
- (2) FCGJ CURRENT WEEK PRODUCTION PACK --data associated with the volume of processed concentrated products, processing of fruit into FCGJ, reprocessing of existing FCGJ, and the combined packaging and bulk manipulation of FCGJ for the week;
- (3) FCGJ REPORT OF GOODS ON HAND --data associated with inventories, receipts and deliveries of FCGJ products, both to third parties, and transfers of FCGJ products between Reporting Facilities (Intercannery/Interfacility Transfers ICT)
- (3a) FCGJ BULK Pounds Solids (PS) -- USAGE data associated with the various categories of usage of bulk FCGJ at a Member facility
- (3b) **FCGJ EXPORT-MILITARY-USDA** [E-M-U] **PURCHASES** data associated with specific sales movement for Exports, Military Purchases, and USDA purchases.

As with all data Forms, accuracy in data reporting, and auditing of data inputs, is extremely important. The electronic format of **Input Form FCGJ & FCTJ** incorporates multiple auditing evaluations and warning 'flags' that compare data for accuracy and reasonableness. Specific calculations and audits are described below.

# Input Form FCGJ - Specific Data Entry Instructions FIELD BOX DATA—BOXES USED IN PRODUCTION OF GRAPEFRUIT PRODUCTS (FCGJ, SSGJ) -- On Input Form FCGJ, grapefruit are classified as 'white' or 'red/pink' [also 'colored'], and as 'priced' or 'nonpriced'. Each data entry, or calculation, line is numbered on Input Form FCGJ. Several cells on the worksheet will 'flag' errors such as missing data or data that produces values outside of expected values. Flags may appear, then disappear as expected data is entered. Facilities are expected to

*N.B.* --Note that starting from the 'delivered in' price, neither advertising tax nor inspection fees should be included when reporting the average price per PS; 'average prices' are to be reported as 'weighted average prices' (average of costs for all PS and all boxes for each category).

audit/review their data and correct data associated with flags before submission of data to FDOC.

#### 'White, Priced'

- **Line 1-** Enter the number of boxes of white grapefruit acquired on a 'priced' basis, for the week. 'Priced' fruit means that **final** prices/box (or PS) are known during the week of delivery/processing it may include contracts with 'floor' and 'rise' language, if the FINAL price <u>is known</u> before or during the week of delivery/processing.
- **Line 2** Enter the number of Pounds Solids (PS) acquired on a 'white, priced' basis, for the week. This is the total of PS reported by the State Test House for the boxes reported on Line 1.
- **Line 3** Enter the weighted average price for the PS reported on Line 2. The 'weighted average price' per PS should be calculated as the sum of dollars required to acquire the total PS, divided by the total PS acquired on a 'white, priced' basis.
- **Line 4** Calculates the 'white, priced' \$price/box by dividing the sum of dollars required to acquire the total PS, by the number of total boxes.

#### 'Red/Pink, Priced'

- **Line 5** Enter the number of boxes of red or pink grapefruit acquired on a 'priced' basis. 'Priced' fruit means that **final** prices/box (or PS) are known during the week of delivery/processing it may include contracts with 'floor' and 'rise' language, if the FINAL price is known before or during the week of delivery/processing.
- **Line 6** Enter the number of Pounds Solids (PS) acquired on a 'red/pink, priced' basis, for the week. This is the total of PS reported by the State Test House for the boxes reported on Line 5.
- **Line 7** Enter the weighted average price for the PS reported on Line 6. The 'weighted average price' per PS should be calculated similarly as described above.
- **Line 8 -** Calculates the 'Red/Pink, Priced' \$price/box by dividing the sum of dollars required to acquire the total PS, by the number of total boxes.

#### 'White, NonPriced'

- **Line 9** Enter the number of boxes acquired on a 'White, NonPriced' basis for the week. 'Non-Priced' fruit is fruit for which the price may only be determined at a later date (later than the week of delivery/processing). This category will also include contracts with 'participation' language; it may include contracts with 'floor' and 'rise' language, if the FINAL price is not known during the week of delivery/processing.
- **Line 10 -** Enter the number of Pounds Solids (PS) acquired on a 'White, NonPriced' basis for the week. This is the total of PS reported by the State Test House for the boxes reported on Line 9.

#### 'Red/Pink, NonPriced'

- Line 11 Enter the number of red or pink grapefruit boxes acquired on a 'NonPriced' basis. 'Non-Priced' fruit is fruit for which the price may only be determined at a later date (later than the week of delivery/processing). This category will also include contracts with 'participation' language; it may include contracts with 'floor' and 'rise' language, if the FINAL price is not known during the week of delivery/processing.
- **Line 12** Enter the number of Pounds Solids (PS) acquired on a 'Red/pink, NonPriced' basis for the week. This is the total of PS reported by the State Test House for the boxes reported on Line 11.
- Line 13 Calculation that sums the total boxes reported for all categories of fruit used in the production of grapefruit products. Also used later for Yield and Average Prices per box calculations. Cells to the

right will report total boxes reported as used in FCGJ and SSGJ; these totals should be audited for equivalence!

**Line 14** - Calculation that sums the total PS reported for all categories of fruit used in the production of grapefruit products. Also used later for Yield and Average PS per box calculations.

Line 15 - Calculation of the yield of 'PS/Box' from the totals on Lines 13 and 14.

The cells in the columns to the right side of column 'D', Lines 1 to 15, contain various audit functions and formulas. These auditing cells 'flag' (present) a message only when an occurrence of data entry is not properly matched with other required data e.g., entering boxes without entering PS, or entering values for the number of boxes in a section of priced fruit without entering a price. There are also calculation cells that show the total dollars for each pricing category. All 'PS/Box' yields are calculated for each category, and flags are raised when the yield values calculated do not fall within expected ranges.

Each of these auditing, flag, and calculation cells is 'locked' as are any other cells that have a light green background. All light green background cells are either calculation cells, or the accompanying descriptions of those calculations. Cells with a yellow background are also locked and are associated with 'flags' or other auditing information.

FCGJ CURRENT WEEK PRODUCTION PACK – On Input Form FCGJ & FCTJ, Production data is entered showing the total production (*aka* 'pack') of FCGJ from fruit, and from pre-existing inventories, along with certain packaging, reprocessing, and production associated adjustments to inventory. This data will be utilized to test inventory balances, to provide 'movement' values, and to calculate production activities. The production of FCGJ is to be reported on the basis of the PS produced by category, for the week.

The auditing system assumes that the total amount of 'production' (pack) PS for all packed materials must be matched by the total amount of PS used. The total amounts of PS used must come from 're-processing' (meaning reworking and using pre-existing solids) or from fruit processed for the week ('new' solids). The production total PS must equal the source total PS used. If this equivalence does not occur, a flag will appear stating 'Net PS DO NOT Calculate'. This flag must be cleared by changing one or more values. The amount of production and the amount of reprocessing reported will be used in auditing processes performed later for Goods On Hand. This 'Net PS' calculation does not incorporate production, handling, or storage losses or gains. That net (loss/gain) value is associated with inventories reported and audited later.

Line 16 – Enter total PS of FCGJ packed (packaged) into 'Retail'-sized units

Line 17 - Enter total PS of FCGJ, that have been packed into 'Institutional'-sized units

Line 18 - Enter total PS of FCGJ that have been packed or stored in 'Bulk'-type containers ((pails, totes, tank farms, tanks)

Line 19 – Calculation sum of Lines 16-18; termed 'Gross Total Production PS'

Line 20- Enter the total PS of FCGJ 'reprocessed'. This value represents the volume of pre-existing inventory that was re-used during the current week to generate part or all of the reported activity in 'Retail' or 'Institutional' packaged goods. Reprocessing volumes may also include Single Strength Grapefruit Juice (SSGJ) PS evaporated to produce FCGJ, and received (incoming) FCGJ PS manipulated, blended, and either packaged or transferred to bulk storage.

On Line 20, an adjacent cell will show the value you have entered on Form SSJ, Line 39, 'Evaporated SSGJ PS for FCGJ'. These volumes **ARE NOT automatically entered** on Line 20; they are there as a reminder to you to include them in the 'reprocessed' value.

- a. When there is no fruit processed, it is assumed that all packaged goods produced have come from the 'reprocessing' of pre-existing or received FCGJ or SSGJ inventories. When SSGJ is evaporated, those solids are considered to be part of FCGJ 're-processing', not SSGJ re-processing; the product type being made is the key.
- b. When fruit is being processed, it is important to distinguish processing activity associated with 'new' inventory (that came from fruit processing), and processing and packaging activity and volumes that involve pre-existing ('old') inventory.
- c. FDOC calculates and reports the volume of 'new' inventory that is created strictly by the processing of fruit. This calculation sums all packing activities, and subtracts all of that activity that was derived from pre-existing inventory (e.g., 're-processing'). The solids derived only from fruit is called 'Net PS from Fruit'
- d. Verify data on other Input Forms that report PS of SSOJ reprocessed into concentrate; these values must be reported as part (or all) of the reported 'reprocessed' FCGJ PS on Line 20.

Line 21 -"Net PS from Fruit" -- calculated by subtracting "Reprocessed PS" from "Total Gross PS" (Packed). Net PS from Fruit represent amounts of FCGJ derived only from the fruit processed for the week. The value is later used in the calculations and reporting of 'Yield' in terms of FCGJ PS produced per box of fruit. It is important to report the value for the 'reprocessed PS' value to reflect known work-in-progress (WIP), carryover, or other juices derived from the reprocessing activities for the reporting week. This allows the 'Net PS from Fruit' value to represent only concentrates derived from fruit processing. FDOC will assume that IF NO fruit is reported as being processed for the Reporting Week any value for 'Net PS from Fruit' is reported in error. The Input Form FCGJ & FCTJ will calculate and compare these data entry points, and a flag will be generated if the data does not calculate appropriately. A processor will often have an accurate measurement of the 'Net PS from Fruit,' and will calculate the 'Reprocessed' value from known values for 'Pack' and 'Net PS from Fruit'. Either calculation is acceptable.

Line 22 – Enter known losses or gains realized during FCGJ production, handling, transportation, or storage. During production, it is common to experience losses or gains in packaged amounts or weekly inventory determinations, compared to calculated expectations. Spillage or other losses must also be accounted for in properly reporting current FCGJ Goods on Hand. This value shall include any known losses or gains occurring during the transportation of FCOJ between processors ('Intercannery transfers'), or transportation between storage locations controlled by a single reporting facility ('Interfacility transfers'). Failure to account for these gains or losses may give rise to 'false' movement figures for the industry as a whole. THIS IS THE ONLY LINE ON THIS WORKSHEET WHERE NEGATIVE VALUES ARE ACCEPTABLE!!!

**Line 23** - Enter the total boxes of fruit used ONLY for the production of FCOJ. This value is critical for calculating and reporting accurate Yield data for PS/box and gallons/box of 40° Brix FCGJ.

Line 24 – Calculates the 'Yield per Box' of fruit. The 'FCGJ Yield per Box' is calculated from the Total Boxes of fruit used in the production of FCGJ, and the Net [FCGJ] PS from Fruit; if the calculated value falls outside of expected ranges, a flag will be generated. FDOC expects facilities to audit data entry forms for flags and to address the questionable data. Reasonable FCGJ yield values range between 3.5 and 6.5 PS per box.

The yield in terms of gallons of of FCGJ per box of fruit is a key value used by the industry expressed in equivalent Gallons of 40° Brix FCGJ on FDOC Weekly Reports.. It is critical to report the 'Net PS from Fruit', and 'Boxes Used in FCGJ (ONLY!)' values correctly.

FCGJ REPORT OF GOODS ON HAND-- Input Form FCGJ & FCTJ provides data entry points for Goods on Hand (GOH) for both the current week (CW), and the previous week (PW). This data is needed to support calculations of both individual facility and combined Reporting Facility data 'movement' values, and to provide key data for auditing the 'reasonableness' and accuracy of data within a facility's GOH reporting. Values are reported as Pounds Solids (PS) GOH.

Report all inventories held by you within your facilities, or held for you under your control at an outside storage facility that does not report to the FDOC. All storage facilities of a certain size are required to report inventory and production activities to FDOC, but in the rare case where this is not true, each facility is responsible for reporting that inventory. Your facility is also responsible for reporting any inventory you hold, whether it is owned by you, owned by another Reporting Facility (or its subsidiaries), or inventory held under your control for any other party. You are not responsible for reporting your inventory held and controlled by any other facility currently reporting this data to the FDOC.

Line 25 —Enter both the CW and PW values for 'Retail' PS Goods on Hand.

Line 26 - Enter both the CW and PW values for 'Institutional' PS Goods on Hand.

Line 27 – Enter both the CW and PW values for 'Bulk' White FCGJ PS Goods on Hand.

Line 28 - Enter both the CW and PW values for 'Bulk' Red/Pink FCGJ PS Goods on Hand.

Line 29 – Calculates the total of Bulk PS of FCGJ GOH, both 'white' and 'Red/Pink'

Line 30 -- Calculation sums the total PS, Goods on Hand, both PW and CW

Line 31 – Calculation of 'Bulk Inventory Difference' -- Input Form FCGJ & FCTJ will calculate the 'net' change in bulk inventory (Line 31) by summing production and all receipts of bulk products to the PW GOH and subtracting reprocessing and CW bulk GOH. This calculation generates a weekly 'Bulk Inventory Differential' which reflects the change in inventory value due to processing, production packing, and receipts. This value will be later compared to the sum of all forms of bulk FCGJ usage. Equivalence of these values provides an audit for verifying accurate reporting of the CW bulk Goods on Hand.

#### Receipts of bulk Inventory, with reporting based upon sources

Line 32 - 'Receipts of Non-Domestic (Fruit) Product' – enter the PS of bulk FCGJ received that was produced from non-domestic fruit sources. This category is also meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This category is also used to capture non-domestic FCGJ held in the US and transported into Florida, where the <u>fruit</u> source for the product is non-domestic fruit. This Line is also where you are to report receipts of 'blended' FCOJ products where <u>no domestic fruit</u> product sources are declared as part of the blend, but would include blends of any combination of declared non-domestic fruit origin products.

Line 33- Receipts of Domestic (Fruit) Product' – enter the PS of bulk FCGJ received which was produced from domestic fruit sources other than Florida fruit (this may include U.S. state and U.S. protectorate sources). This category is meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This does not include non-domestic fruit brought into the US and processed domestically.

This Line is also where you are to report receipts of 'blended' FCGJ products where a domestic fruit source product is declared as part of the blend.

Once a non-Florida (fruit source) product (domestic or non-domestic) product is reported as received in Florida, it is only reported as a domestic/non-domestic receipt the one time; once included in the Florida industry inventory, the product becomes 'Florida-based' inventory and the fruit source distinction is no longer relevant to these reporting instructions. Only the facility that first takes physical possession within Florida (or ownership if the received product is transferred to a third party [non-reporting] storage facility under the Reporting Facility's control) will report the amount as a receipt of a domestic/non-domestic product. If, for instance, one Reporting Member moves any bulk FCGJ product within Florida to another Florida facility, it is reported as 'Bulk Delivered to a Reporting Facility (Line 45 below); it is not again to be reported/categorized as a 'domestic/non-domestic receipt/delivery'.

Line 34 - 'Receipts of FL-based Product from Non-Reporting Facility' – enter the PS of product already based in FL that has been received from a Non-Reporting (Florida-based) Facility. 'Non-Reporting Facility' is any third-party possessing product in Florida, not currently reporting data to FDOC. The FDOC rules attempt to capture data from most Florida parties or facilities handling citrus products, but there some facilities that are exempt, or otherwise not currently reporting to FDOC, and there may be the occasional receipt from such facilities.

'Foreign Imports', and 'Domestic receipt of a non-FL product' -- this terminology was used previously in reporting receipts into Florida facilities, and distinction was made between 'dutiable' and 'nondutiable' or 'zero rate duty' FCGJ products. Those distinctions are no longer utilized within these reporting instructions for domestic and non-domestic product receipts.

Line 35 – A total of 'Bulk RECEIVED from Reporting Facilities' will be shown on Line 35 when the adjacent section (to the right) of the **Input Form FCGJ & FCTJ** is used for entering Intercannery receipts of bulk FCGJ from each specific processing or storage facility. Enter the PS of bulk FCOJ received from each of the Reporting Facilities listed; each current Reporting Facility's abbreviation is listed so that data is entered in a specific cell. Do NOT change headings or create your own. If you have a transaction with an unlisted facility, please contact FDOC Staff for instructions. The worksheet 'Facility Abbrev' provides translations of the abbreviations.

- a. Report as 'Bulk Received from a Reporting Facility' the transfer of product from your facility to, or from, an outside storage facility in Florida (also a Reporting Facility). When losses and gains associated with such transfers are realized, those volumes will be reported to FDOC as part of "Net Gains or Losses due to processing, handling, and storage" for the week.
- b. Intercannery/Interfacility Transfers (ICT) differentials are maintained and tracked separately for the purposes of isolating these amounts from other calculations of 'movement'. From the perspective of the Florida citrus industry, an ICT of FCGJ from one from one Reporting Facility to another is equivalent to moving FCOJ from one tankfarm to another within a single facility --- there should be no net change in total Membership GOH once the transaction has been completed. Recognized gains or losses during ICT should be reported as part of FCOJ 'Net Loss/Gain in Production, Handling & Storage' on Line 22.

In the short term, ICT differentials may often be generated due to timing issues in shipping and receiving bulk goods. Data submitted to FDOC for any one reporting week may not capture all ICT shipments and receipts that actually occurred over more than one Week Ending reporting date. One facility may ship product in one reporting week, while the receipt of that product is accounted for in a following reporting

week by the receiving facility. FDOC will track net ICT, and identify unbalanced transfers, throughout the season.

Do NOT report the transfer of products between you own company storage facilities if they do not separately report data to the FDOC. Those inventories are part of the total goods on hand you report every week, and these internal transfers do not require FDOC tracking. Recognized gains or losses during such transfers should be reported as part of FCOJ 'Net Loss/Gain in Production, Handling & Storage' on Line 22.

Line 36 – 'Total Bulk Received' – Calculation sum of Lines 32-35

**Line 37** – As with bulk FCOJ received from another facility, enter the amount, in PS, of Cased Goods of FCOJ received from a Reporting Facility in the area adjacent to Line 37.

FCGJ BULK PS -- USAGE - Input Form FCGJ & FCTJ provides data entry points for several forms and categories of bulk FCGJ usage. The primary descriptions of FCGJ usages are also termed 'Bulk FCGJ Disappearance'.

Line 38 – 'Used in CGJ' - Bulk FCGJ PS Used in Chilled Grapefruit Juices [CGJ] (Packaged and Bulk) – Enter the PS of FCGJ used by the reporting facility in the production of Chilled Juice products. Do not report any values other than what is known to have occurred within your facilities or under your control (the point of this value is to account for part of your FCGJ 'disappearance'). A 'flag' may prompt you to check the data entry point on the SSJ Input Form for equivalence to this value.

This value should be equal to the value shown on the SSJ Input Form, Line 33.

**Line 39**— 'Bulk Exported' – This value is referenced from data entry further down the Input Form (within the "E-M-U" data entries). This value will reflect the PS of bulk FCGJ used for export. This includes bulk FCGJ shipped to Canada.

**Line 40** – 'Used in Beverage Bases and Diluted Drinks' -- Enter the bulk PS of FCGJ used by the reporting facility in the production of beverage bases, or in the production of diluted (less than 100% juice) drinks and blends.

Line 41 – 'Used in Canned Recon' – Enter the bulk PS of FCGJ used by the reporting facility in the production of reconstituted, and canned, products.

**Line 42** – 'Sold to a Non-Reporting Facility or Customer' – Enter the bulk PS of inventory sold/delivered to a third party (non-reporting) in or out of the State of Florida. This value should include <u>bulk</u> products sold under special purchase plans such as Military contracts, and USDA purchase plans. **<u>Do</u>** <u>Not</u> include exports; these are accounted for separately.

Line 43 – DELETED – NO LONGER USED

Line 44 – 'TOLL PACK to Non-Reporting Facility/Owner' - (Reported <u>during the Week Shipped</u>)— Enter the PS of bulk FCOJ used by the Reporting Facility in the production of product processed for a third party (Non-Reporting). For FDOC reporting purposes, product is reported as 'Toll Pack" during the week that the product is actually delivered, whether delivered during the week of production or not. "Copacked" products delivered to another reporting facility are reported on Line 45.

**Line 45** – 'Bulk Delivered to a Reporting Facility' (Includes Co-Pack amounts delivered to Reporting Facilities). The total of 'Bulk DELIVERED to other Reporting Facilities appears in the Line 45 summation cell. Receipt data is entered into the adjacent section (to the right) of the **Input Form.** Enter the data as described above for Line 36 (Total Bulk Received).

a. Do NOT record as bulk disappearance or usage the transfer of product between your facilities, or from your facility to an outside storage facility (non-Reporting facility), if you maintain ownership of the product shipped. This is an 'interfacility transfer', as described for Line 37. You have not changed

- your inventory and that type of change in warehousing should not be reported. When losses and gains associated with such transfers are realized, those volumes will be reported to FDOC as part of "Net Gains or Losses due to processing, handling, and storage" for the week.
- b. A list of current Reporting Facilities is included with these documents, and provided through updates from FDOC, to assist in the proper recording of 'intercannery/interfacility' transfers (between reporting facilities only)
- Line 46 'Total Bulk Usage' Calculation sums Lines 38 45.
- **Line 47** 'Total Bulk Inventory Reduction/Usage' Calculation that sums Line 46, and other bulk deliveries of bulk FCGJ, e.g., E-M-U shipments.

This calculated value is compared on **Input Form FCGJ & FCGJ** to the value on Line 31. Any difference other than zero will generate a flag alerting data entry personnel that the data does not match; <u>a further audit of data entries should be made to determine the source of the discrepancies and clear this flag.</u> 'Round-off' differences will occasionally produce a value of +/- 1 that can be ignored.

Line 48 – In the area adjacent (to the right) to Line 48, enter the amount, in PS, of any cased goods delivered to another Reporting Facility.

FCGJ EXPORT-MILITARY-USDA [E-M-U] SHIPMENTS – Input Form FCGJ provides data entry points for with specific deliveries for Exports, Military Purchases, and USDA purchases

- Line 49 Enter the amount of packaged FCGJ products Exported (including Canada)
- **Line 50** This value is added to Line 51 and referenced above on Line 39 above for part of the 'disappearance' calculations. Enter the PS of bulk white FCGJ used for export. This includes bulk white FCGJ shipped to Canada.
- **Line 51** This value is added to Line 50 and referenced above on Line 39 above for part of the 'disappearance' calculations. Enter the PS of bulk red/pink FCGJ used for export. This includes bulk red/pink FCGJ shipped to Canada.
- Line 52 Enter the PS amount of packaged FCGJ products sold as Military Purchase
- Line 53 Enter the PS amount of bulk FCGJ sold as Military Purchase
- Line 54 Enter the PS amount of packaged FCGJ product sold as USDA Purchase
- Line 55 Enter the PS amount of bulk FCGJ products sold as USDA Purchase
- Line 56 Calculation that sums the PS associated with all EMU sales

# FDOC INPUT FORM FCGJ & FCTJ TANGERINE FIELD BOX DATA and FROZEN CONCENTRATED TANGERINE JUICE (Part of Combined Form FCGJ & FCTJ)

The FCTJ portion of **Input Form FCGJ & FCTJ** is to be filed weekly, when fruit is being processed, when FCTJ is being generated by fruit processing, and during those weeks when fruit is not being processed but in which FCTJ products are being processed for packaging and bulk activities. The FCTJ portion of **Input Form FCGJ & FCTJ** is designed to provide data that may be compiled and published by FDOC as Weekly Reports to the FDOC Membership and other interested parties.

As with all data Forms, accuracy in data reporting, and auditing of data inputs, is extremely important. The electronic format of **Input Form FCGJ & FCTJ** incorporates multiple auditing evaluations and warning 'flags' that compare data for accuracy and reasonableness. Specific calculations and audits are described below. **ALL DATA ON THIS WORKSHEET MUST BE ENTERED AS POSITIVE VALUES.** 

#### Data Input Area FCTJ - Specific Data Entry Instructions

FCTJ CURRENT WEEK PRODUCTION PACK & BOXES -- On the FCTJ portion of Input Form FCGJ & FCTJ, much less data input is required than for other product. Only data associated with fruit defined as "tangerine" and activities associated with the production of FCTJ are to be recorded here. Do not include other mandarin-type fruit in this area of data entry. Distinctions between processing tangerines to produce FCTJ, and processing of tangerine fruit simultaneously with round oranges are noted in the definitions.

**Line 60**- Enter the number of boxes of tangerines acquired for the week and used in the production of "tangerine' products (varieties must meet the standards of identity).

**Line 61-** Enter the weighted average price for the boxes reported on Line 60. The 'weighted average price' per box should be calculated as the sum of dollars required to acquire the total number of boxes, divided by the total boxes of tangerine acquired and used strictly in the production of FCTJ.

Line 62 -- Enter total PS of FCTJ that have been packed or stored in 'Bulk'-type containers ((pails, totes, tankfarms tanks); FCTJ is reported in PS only. Only bulk FCTJ is reported.

Line 63- Enter the total PS of FCTJ 'reprocessed'.

**Line 64**-"Net PS from Fruit" -- calculated by subtracting "Reprocessed PS" from "Bulk PS" (Produced). 'Net PS from Fruit' represent FCTJ from fruit processed for the week. The value is later used in the calculations of 'Yield' as PS per box of fruit. Known PS values may be directly entered, but the calculation of Bulk PS – Reprocessed PS must = Net PS from Fruit.

Line 65 – Calculates the 'Yield per Box' of fruit. The 'FCTJ Yield per Box' is calculated from the Total Boxes of fruit used in the production of FCTJ, and the Net [FCTJ] PS from Fruit; if the calculated value falls outside of expected ranges, a flag will be generated. FDOC expects facilities to audit data entry forms for flags and to address the questionable data. Reasonable FCTJ yield values range between 2.9 and 8.3 PS per box.

**Line 66** - Enter the PS amount of FCTJ reprocessed/blended with FCOJ. This amount should also have been part of the 'reprocessed' FCOJ entered on **Input Form FCOJ**. This value will display on **Input Form FCOJ**, Line 28.

Line 67 – A total of 'Bulk RECEIVED from Reporting Facilities' will be shown on Line 67 when the adjacent section (to the right) of the FCTJ portion of **Input Form FCGJ & FCTJ** is used for entering

Intercannery/interfacility receipts of bulk FCTJ from each specific Reporting Facility. Enter the amount in PS received from each of the Members listed, or enter the name and volume received from a supplying Member if their name is not listed.

Line 68 – 'Bulk Delivered to a Reporting Facility (Includes Toll PackedCo-Packed products) of 'Bulk DELIVERED to Reporting Facilities' will be shown on Line 68 when the adjacent section (to the right) of the FCTJ portion of **Input Form FCGJ & FCTJ** is used for entering Intercannery/interfacility receipts of bulk FCTJ from each specific facility. Enter the data as described above for Line 67.

Line 69 – Enter the PS of FCTJ received from a Non-Reporting Facility

Line 70 – Enter both the CW and PW GOH value for PS of FCTJ

#### FDOC INPUT FORM SSJ SINGLE STRENGTH JUICES (SSJ)

Input Form SSJ is to be filed weekly with FDOC both when 1) SSJ is being generated by fruit processing, and 2) during those weeks in which SSJ packaged and bulk products are being produced from stored bulk SSJ and from concentrates. Input Form SSJ is designed to provide FDOC with data associated with the weekly totals of Goods-On-Hand (Inventory) including packaged goods and bulk product, and to record all intercannery transfers of SSJ, by category. Input Form SSJ is also used to report the portion of boxes of fruit utilized in the production of single strength products (only), and to calculate the average yield in Pounds Solids (PS) per box. As with all data Forms, accuracy in data reporting is extremely important.

All amounts are to be reported in Pounds Solids (PS); when data is maintained in Pounds Solids (PS), then calculations for 'gallons' are based upon PS/1.029 for 'standard' SSOJ gallons, and as PS/0.865 for 'standard' SSGJ gallons.

Net PS from Fruit is calculated as the total 'pack' PS of Packaged Goods, plus the amount of 'Bulk' PS produced, minus the PS derived from reconstituted concentrate, minus the PS of reprocessed (from storage) bulk SSJ. An alternative calculation may be used when Net PSs from Fruit is a known value -- total 'pack' PS of Packaged Goods, plus PS of Bulk SSJ produced, minus the known Net PS from Fruit is equal to 'reprocessed' PS (as a total – each facility must proportion known reconstitution PS from reconstituted concentrate, and the amount of PS represented by 'reprocessed' bulk SSJ from storage. Yields are calculated by dividing the PS from Fruit by the Total Boxes of fruit used.

A separate data entry point is provided for reporting the PS of frozen concentrate produced from the concentration (evaporation) of single strength juice products originating from pre-existing SSJ inventories. Single strength juices evaporated into concentrates are to be included on **Input Form FB/FCOJ** (or FCGJ/FCTJ) as part of the 'reprocessed' PS of concentrate. SSJ evaporated into concentrates are not reported as part of the 'reprocessing' PS of SSJ, but only as part of the 'reprocessed' FCOJ reported.

When there is no fruit processed for the week, there can be no 'Net PS from Fruit' for the week. When there is no fruit processed for the week, the total of 'packed' goods (packaged and bulk) must be accounted for in the total of 'reprocessed' goods for the week (from concentrate, and from SSJ bulk inventory). There may also be Net Losses or Gains (NLG) in PS during processing activities or handling activities (including transportation); a data point is provided for reporting NLG separately. Net losses or gains are part of the inventory reporting, and the audits of these calculations include losses or gains values.

# ALL DATA ON THIS WORKSHEET MUST BE ENTERED AS POSITIVE VALUES, EXCEPT FOR LINES 8 (SSOJ) & 37 (SSGJ) –'NET LOSSES/GAINS'!!! SINGLE STRENGTH ORANGE JUICE

**Line 1** – Enter the number of boxes of fruit used (only) in the production of SSOJ for the week. This value will be summed with the reported boxes used in the production of FCOJ and compared to the total boxes reported on Input Form FB/FCOJ. Check these sums for equivalence!

#### Production 'Pack for Week'

- Line 2 Enter the total amount in PS, of all packaged SSOJ goods for the week.
- Line 3 Enter the total PS of 'bulk' SSOJ goods packed for the week
- Line 4 Enter the PS of FCOJ reprocessed as SSJ for the week

- Line 5- Enter the PS of bulk SSOJ reprocessed for the week
- **Line 6-** Enter (or calculate) the 'Net PS from Fruit' for the week. The sum of Packaged and Bulk production, minus the two reprocessed values must equal the Net PS from Fruit Reported.
- Line 7 Calculation of 'Yield' in PS per Box of fruit
- Line 8 Enter the PS of SSOJ 'Net Gain or Loss in Production Handling & Storage' for the week. This value includes any known losses occurring during the transportation of SSJ between Reporting Facilities, or between a facility's different locations of stored product, or values necessary to account for inventory changes that may be currently unexplained. Significant losses or gains, or consistent unexplained inventory differences are issues that need to be evaluated by management to determine cause(s). Report Net Losses as negative values; Net Losses are the only negative values allowed to be reported on any of these input forms.
- **Line 9** Enter the PS of pre-existing SSOJ evaporated into FCOJ. This value will appear on **Input Form FB/FCOJ**, Line 24 as a reminder when you are reporting reprocessed FCOJ. These PS **ARE** to be included as part of the FCOJ 'reprocessed' value entered on **Input Form FB/FCOJ** (this activity results in an increase in the FCOJ inventory). This value will also be used in the bulk SSOJ GOH audit calculation. <u>DO NOT</u> include this value as part of the 'Reprocessed' PS values reported on Lines 4&5 of Form SSJ! BUT, be sure to account for this reduction of SSOJ inventory in the Current Week GOH value reported.

#### 'Goods on Hand' (GOH)

- Line 10 Enter the Current Week (CW) 'Packaged' Goods on Hand for SSOJ, and in the cell to the right, enter the Previous Week's (PW) GOH value. The PW data will contribute to the audit calculations to be performed.
- Line 11 Enter the Current Week (CW) 'Bulk' Goods on Hand for SSOJ, and in the cell to the right, enter the Previous Week's (PW) GOH value. The PW data will contribute to the audit calculations to be performed.
- Line 12 Calculation that sums the packaged and bulk values for SSOJ, for CW and PW.
- Line 13 Input Form SSJ will calculate the 'expected' change in bulk inventory (Line 13) by summing the PS of PW GOH, CW production and all receipts of bulk products, and subtracting reprocessing PS and CW bulk GOH. This calculation generates a weekly 'Calc. Bulk Inventory Differential' which reflects the change in inventory value due to processing, production packing, and receipts. This value will be later compared to the sum of all forms of bulk SSOJ usage. Equivalence of these values provides an audit for verifying accurate reporting of the CW bulk Goods on Hand.

#### 'Receipts of SSOJ'

Line 14 - A total of 'Bulk SSOJ RECEIVED from Reporting Facilities' will be shown on Line 14 when the adjacent section (to the right) of the **Input Form SSJ** is used for entering Intercannery/interfacility receipts of bulk SSOJ from each specific Reporting Facility. Enter the PS received from each facility listed, DO NOT attempt to create a name – if the facility is not listed, please contact FDOC for instructions. Any 'equivalency' conversions between gallons and PS are to be on a 'standardized' gallon basis, where the SSOJ standardized gallon is based on PS/1.029 = 'standardized gallons'.

Transfers of products between Facilities are called "Intercannery/Interfacility Transfers" (ICT).

Intercannery Transfer transactions are tracked separately for the purposes of isolating these PS from other calculations of compiled industry 'movement'. From the perspective of the citrus industry and FDOC tracking, an ICT of SSOJ from one Reporting Facility to another is equivalent to moving SSOJ from one

tank in a tankfarm to another within a single facility --- there should be no net change in total industry GOH once the transaction has been completed.

In the short term, ICT differentials may often be generated due to timing issues in shipping and receiving bulk goods. Data submitted to FDOC for anyone reporting week may not capture all ICT shipments and receipts that are recorded in a later Reporting Week. One facility may record shipping product in one reporting week, and the receipt of that product is accounted for in a following reporting week by the receiving Reporting Facility. FDOC will track ICT differentials throughout the season and use this data to identify unbalanced transfers.

Line 15 – enter the PS of bulk SSOJ received that was produced from non-domestic fruit sources. This category is also meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This category is also used to capture non-domestic SSOJ held in the US and transported into Florida, where the <u>fruit</u> source for the product is non-domestic fruit. This Line is also where you are to report receipts of 'blended' SSOJ products where <u>no domestic fruit</u> product sources are declared as part of the blend but would include blends of any combination of declared non-domestic fruit origin products.

Line 16- Receipts of Domestic (Fruit) Product' – enter the PS of bulk SSOJ received which was produced from domestic fruit sources other than Florida fruit (this may include U.S. state and U.S. protectorate sources). This category is meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This Line is also where you are to report receipts of 'blended' SSOJ products where a domestic fruit source product is declared as part of the blend. Once a non-Florida (fruit source) product (domestic or non-domestic) product is reported as received in Florida, it is only reported as a domestic/non-domestic receipt the one time; once included in the Florida industry inventory, the product becomes 'Florida-based' inventory and the fruit source distinction is no longer relevant to these reporting instructions. Only the facility that first takes physical possession within Florida (or ownership if the received product is transferred to a third party [non-reporting] storage facility under the Reporting Facility's control) will report the amount as a receipt of a domestic/non-domestic product. If, for instance, one Reporting Member moves any bulk SSOJ product (e.g., Brazilian or All-Florida SSOJ) within Florida to another Florida facility, it is reported as 'Bulk Delivered to a Reporting Facility (Line 20 below); it is not again to be reported/categorized as a 'domestic/non-domestic receipt/delivery'.

Line 17 - 'Receipts of FL-based Product from Non-Reporting Facility' – enter the PS of product already based in FL that has been received from a Non-Reporting (Florida-based) Facility. 'Non-Reporting Facility' is any third-party possessing product in Florida, not currently reporting data to FDOC. The FDOC rules attempt to capture data from most Florida parties or facilities handling citrus products, but there some facilities that are exempt, or otherwise not currently reporting to FDOC, and there may be the occasional receipt from such facilities.

'Foreign Imports', and 'Domestic receipt of a non-FL product' -- this terminology was used previously in reporting receipts into Florida facilities, and distinction was made between 'dutiable' and 'nondutiable' or 'zero rate duty' SSOJ products. Those distinctions are no longer utilized within these reporting instructions for domestic and non-domestic product receipts.

#### 'Deliveries of SSOJ'

#### Line 19 – NO longer used!

Line 20 – 'Bulk Delivered to a Reporting Facility' (Includes Toll or Co-Pack for Third Parties). Enter the PS delivered to another Reporting Facility. These transfers are reported in the adjacent area (to the right)

for ICT of bulk product between Reporting Facilities (Intercannery/interfacility – ICT). Enter the data as described above for Line 14. The sum of ICT will appear on Line 20.

- a. Do NOT record as bulk disappearance or usage the transfer of product from your facility to, or from, an outside storage facility (that is not a Reporting Facility), if you maintain ownership of the product shipped. You have not changed your inventory or ownership, and that type of change in warehousing should not be reported.
- b. A list of current Reporting Facilities is included with this Manual to assist in the proper recording of 'intercannery' transfers (between Reporting Facilities only).
- Line 21 'Delivered/Sold to a Non-Reporting Facility or Third Party' Enter the PS of bulk SSOJ (other than exports) delivered/sold to a Non-Reporting Facility. This data will be used in auditing calculations for Goods on Hand. This includes domestic sales only; export shipments/sales are reported on Lines 25 & 26.
- Line 22 Calculation summing total deliveries of SSOJ from inventory, as 'Total Bulk INVENTORY Reduction.' This calculated value is compared on **Input Form SSJ** to the value on Line 13, 'Calc. Bulk Inventory Differential'. Any differences between Line 13 and Line 22 will generate a flag alerting data entry personnel that the data does not match; a further audit of data entries should be made to determine the source of the discrepancies.
- Line 23-- A total of 'RECEIVED PS in Case Goods, from Reporting Facilities appears in the Line 23 summation cell. Receipt data is entered into the adjacent section (to the right) of the **Input Form SSJ** as receipts from each specific Reporting Facility. Enter the PS of cased goods received from each of the specific facilities listed; if the facility is not listed, contact FDOC for instructions; PLEASE do not attempt to enter the name in the 'blank' available cells. FDOC uses each cell for a specific facility, even if not currently identified.
- Line 24-- A total of 'DELIVERED PS in Case Goods, to Reporting Facilities' appears in the Line 24 summation cell. Delivery data is entered into the adjacent section of the Input Form SSJ as deliveries to each specific facility. Enter the PS of cased goods delivered to each of the facilities listed; if the facility is not listed, contact FDOC for instructions; PLEASE do not attempt to enter the name in the 'blank' available cells. FDOC uses each cell for a specific facility, even if not currently identified.
- Line 25 Enter the PS of packaged SSOJ that were exported for the week; this includes Canada.
- Line 26 Enter the PS of bulk SSOJ that were exported for the week; this includes Canada.

#### SINGLE STRENGTH GRAPEFRUIT JUICE

Line 30 – Enter the number of boxes of fruit used (only) in the production of SSGJ for the week. This value will be summed with the reported boxes used in the production of FCGJ and compared to the total boxes reported on Input Form FCGJ & FCTJ. Check these sums for equivalence!

#### Production 'Pack for Week'

- Line 31 Enter the total volume, in PS, of all packaged SSGJ goods for the week.
- Line 32 Enter the total PS of 'bulk' SSGJ goods packed for the week
- Line 33 Enter the PS of FCGJ reprocessed into SSJ for the week
- Line 34- Enter the bulk SSGJ PS reprocessed for the week
- Line 35- Enter (or calculate) the 'Net PS from Fruit' for the week. The sum of Packaged and Bulk production, minus the two reprocessed values must equal the Net PS from Fruit Reported
- Line 36 Calculation of 'Yield' in PS per Box of fruit
- **Line 37** Enter the PS of SSOJ 'Net Gain or Loss in Production Handling & Storage' for the week. This value includes any known losses occurring during the transportation of SSJ between Reporting Facilities,

or between a facility's different locations of stored product, or values necessary to account for inventory changes that may be currently unexplained. Significant losses or gains, or consistent unexplained inventory differences are issues that need to be evaluated by management to determine cause(s). Report Net Losses as negative values; Net Losses are the only negative values allowed to be reported on any of these input forms.

**Line 38** – Enter the PS of pre-existing SSGJ evaporated into FCGJ. Concentrated juices processed directly from fruit are reported on **Input Form FCGJ &F CTJ.** This value will appear on **Input Form FCGJ & FCTJ**, Line 20, as a reminder when you are reporting reprocessed FCGJ. These PS **ARE** to be included as part of the FCGJ 'reprocessed' value entered on **Input Form FCGJ/FCTJ** (this activity results in an increase in the FCGJ inventory). This value will also be used in the bulk SSGJ GOH audit calculation. **DO NOT** include this value as part of the values reported on Line 34 of Form SSJ! BUT, be sure to account for this reduction of SSGJ inventory in the Current Week GOH value reported.

#### 'Goods on Hand' (GOH)

Line 39 – Enter the Current Week (CW) 'Packaged' Goods on Hand for SSGJ, and in the cell to the right, enter the Previous Week's (PW) GOH value. The PW data will contribute to the audit calculations to be performed.

**Line 40** - Enter the Current Week (CW) 'Bulk' Goods on Hand for SSGJ, and in the cell to the right, enter the Previous Week's (PW) GOH value. The PW data will contribute to the audit calculations to be performed.

Line 41 – Calculation that sums the packaged and bulk values for SSGJ, CW and PW.

Line 42 – Input Form SSJ will calculate the 'expected' change in bulk inventory (Line 42) by summing PW GOH, CW production, and all receipts of bulk products, and subtracting reprocessing volumes and CW bulk GOH. This calculation generates a weekly 'Calc. Bulk Inventory Differential' which reflects the change in inventory value due to processing, production packing, and receipts. This value will be later compared to the sum of all forms of bulk SSGJ usage. Equivalence of these values provides an audit for verifying accurate reporting of the CW bulk Goods on Hand.

#### 'Receipts of SSGJ'

Line 43 - A total of 'Bulk SSGJ RECEIVED from Reporting Facilities' will be shown on Line 43 when the adjacent section (to the right) of the **Input Form SSJ** is used for entering Intercannery/interfacility receipts of bulk SSGJ from each specific Reporting Facility. Enter the PS received from each facility listed, DO NOT attempt to create a name – if the facility is not listed, please contact FDOC for instructions. Any 'equivalency' conversions between gallons and PS are to be on a 'standardized' gallon basis, where the SSGJ standardized gallon is based on PS/0.865 = 'standardized gallons'.

Transfers of products between Facilities are called "Intercannery/Interfacility Transfers" (ICT).

Intercannery Transfer transactions are tracked separately for the purposes of isolating these PS from other calculations of compiled industry 'movement'. From the perspective of the citrus industry and FDOC tracking, an ICT of SSGJ from one Reporting Facility to another is equivalent to moving SSGJ from one tank in a tankfarm to another within a single facility --- there should be no net change in total industry GOH once the transaction has been completed.

In the short term, ICT differentials may often be generated due to timing issues in shipping and receiving bulk goods. Data submitted to FDOC for anyone reporting week may not capture all ICT shipments and receipts that are recorded in a later Reporting Week. One facility may record shipping product in one reporting week, and the receipt of that product is accounted for in a following reporting week by the

receiving Reporting Facility. FDOC will track ICT differentials throughout the season and use this data to identify unbalanced transfers.

Line 44 – enter the PS of bulk SSGJ received that was produced from non-domestic fruit sources. This category is also meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This category is also used to capture non-domestic SSGJ held in the US and transported into Florida, where the <u>fruit</u> source for the product is non-domestic fruit. This Line is also where you are to report receipts of 'blended' SSGJ products where <u>no domestic fruit</u> product sources are declared as part of the blend but would include blends of any combination of declared non-domestic fruit origin products.

Line 45 – Receipts of Domestic (Fruit) Product' – enter the PS of bulk SSGJ received which was produced from domestic fruit sources other than Florida fruit (this may include U.S. state and U.S. protectorate sources). This category is meant to provide a distinction between U.S. sources and 'foreign' sources (Caribbean Basin, South American, Central American, etc.). This Line is also where you are to report receipts of 'blended' SSGJ products where a domestic fruit source product is declared as part of the blend.

Once a non-Florida (fruit source) product (domestic or non-domestic) product is reported as received in Florida, it is only reported as a domestic/non-domestic receipt the one time; once included in the Florida industry inventory, the product becomes 'Florida-based' inventory and the fruit source distinction is no longer relevant to these reporting instructions. Only the facility that first takes physical possession within Florida (or ownership if the received product is transferred to a third party [non-reporting] storage facility under the Reporting Facility's control) will report the amount as a receipt of a domestic/non-domestic product. If, for instance, one Reporting Member moves any bulk SSOJ product (e.g., Carribbean or All-Florida SSGJ) within Florida to another Florida facility, it is reported as 'Bulk Delivered to a Reporting Facility (Line 49 below); it is not again to be reported/categorized as a 'domestic/non-domestic receipt/delivery'.

Line 46—'Receipts of FL-based Product from Non-Reporting Facility' – enter the PS of product already based in FL that has been received from a Non-Reporting (Florida-based) Facility. 'Non-Reporting Facility' is any third-party possessing product in Florida, not currently reporting data to FDOC. The FDOC rules attempt to capture data from most Florida parties or facilities handling citrus products, but there some facilities that are exempt, or otherwise not currently reporting to FDOC, and there may be the occasional receipt from such facilities.

'Foreign Imports', and 'Domestic receipt of a non-FL product' -- this terminology was used previously in reporting receipts into Florida facilities, and distinction was made between 'dutiable' and 'nondutiable' or 'zero rate duty' SSGJ products. Those distinctions are no longer utilized within these reporting instructions for domestic and non-domestic product receipts.

Line 47 – Calculation summing Lines 43-46, as 'Total Bulk Received'

#### 'Deliveries of SSGJ'

Line 48 – NO longer used!

**Line 49** – Bulk Delivered to a Reporting Facility' (Includes Toll or Co-Pack for Third Parties). Enter the PS delivered to another Reporting Facility. These transfers are reported in the adjacent area (to the right) for ICT of bulk product between Reporting Facilities (Intercannery/interfacility – ICT). Enter the data as described above for Line 43. The sum of ICT will appear on Line 49.

a. Do NOT record as bulk disappearance or usage the transfer of product from your facility to, or from, an outside storage facility (that is not a Reporting Facility), if you maintain ownership of

- the product shipped. You have not changed your inventory or ownership, and that type of change in warehousing should not be reported.
- **b.** A list of current Reporting Facilities is included with this Manual to assist in the proper recording of 'intercannery' transfers (between Reporting Facilities only).

Line 50 – 'Delivered/Sold to a Non-Reporting Facility or Third Party' – Enter the PS of bulk SSGJ (other than exports) delivered/sold to a Non-Reporting Facility. This data will be used in auditing calculations for Goods on Hand. This includes domestic sales only; export shipments/sales are reported on Lines 51, 52, & 53.

- Line 51-- Enter the PS of packaged SSGJ that were exported for the week; this includes Canada.
- Line 52-- Enter the PS of bulk white SSGJ that were exported for the week; this includes Canada.
- Line 53 -- Enter the PS of bulk red/pink SSGJ that were exported for the week; this includes Canada.
- Line 54- Calculation summing total deliveries of SSGJ from inventory, as 'Total Bulk INVENTORY Reduction'. This calculated value is compared on **Input Form SSJ** to the value on Line 46, 'Calc. Bulk Inventory Differential'. Any differences between Line 46 and Line 55 will generate a flag alerting data entry personnel that the data does not match; a further audit of data entries should be made to determine the source of the discrepancies.

Line 55-- A total of 'RECEIVED PS in Case Goods, to Members' appears in the Line 55 summation cell. Receipt data is entered into the adjacent section (to the right) of the **Input Form SSJ** as receipts from each specific Reporting Facility. Enter the PS of cased goods received from each of the specific facilities listed; if the facility is not listed, contact FDOC for instructions; PLEASE do not attempt to enter the name in the 'blank' available cells. FDOC uses each cell for a specific facility, even if not currently identified.

Line 56- A total of 'DELIVERED PS in Case Goods, to Members' appears in the Line 56 summation cell. Delivery data is entered into the adjacent section (to the right) of the Input Form SSJ as deliveries to each specific facility. Enter the PS of cased goods delivered to each of the facilities listed; if the facility is not listed, contact FDOC for instructions; PLEASE do not attempt to enter the name in the 'blank' available cells. FDOC uses each cell for a specific facility, even if not currently identified.
