January 15, 2014 for the production period January 1, 2013 through December 31, 2013; January 15, 2015 for the production period January 1, 2014 through December 31, 2014; January 15, 2016 for the production period January 1, 2015 through December 31, 2015; and December 1, 2016 for the production period January 1, 2016 through June 30, 2016.
