


DECLARATION – REPUBLIC OF HUNGARY

RECIPROCITY IN FAMILY SUPPORT (MAINTENANCE)
ENFORCEMENT

As authorized by section 459A(a)(1) of title IV-D of the Social Security Act (42 U.S.C. 659A(a)(1)), and with the concurrence of the Secretary of Health and Human Services, I hereby declare the Republic of Hungary a “foreign reciprocating country” effective on the date of a corresponding declaration by the Republic of Hungary. This declaration shall not apply in cases where such application would be manifestly incompatible with United States public policy.

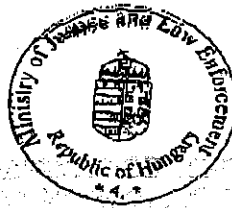

It is my great pleasure to send you herewith the declaration of reciprocity signed by the Hungarian Minister of Justice and Law Enforcement. By this declaration the reciprocity between Hungary and the United States of America in family support matters became effective on January 22, 2007. Please be advised that the revised Hungarian-language version of the forms and the information for the purposes of the guide for practitioners will be sent in the very short future.

I am convinced that by this new federal-level reciprocity we will be able to provide more help for children in need but at the same time it may help to further improve the judicial cooperation between Hungary and the USA. I thank you and all your colleagues for the very constructive and friendly atmosphere of our negotiations and look very much forward to the advanced level cooperation of our authorities. I hope that we will have an opportunity to have further and regular meetings on the application of the reciprocity.
