INSTRUCTIONS FOR REGISTRATION OF BRAKE FLUID BRAND OR FORMULA ADDITION TO A CURRENTLY REGISTERED BRAND JULY 1, ____ THROUGH JUNE 30, ____

Section 526.51, F.S., requires the annual registration of each brand of brake fluid marketed in Florida. This must be done before the product is offered for sale, and prior to July 1 of the registration year. The registration fee is \$100. The permit year extends from July 1 to June 30. It may be renewed each year for a fee of \$50. Please do not use this form for a renewal; use the **Application for Renewal of Registration of Brake Fluid (FDACS-03213 Rev. 10/12)**. If this is a **Formula Addition to a Currently Registered Brand**, please note this on the proper line on page 1. Any change in formula, composition or brand name of any brake fluid shall constitute a new product which shall be registered in accordance with Section 526.51, F.S.

The notarized affidavit must give the applicant full authorization to register the brand name; must be signed by the owner of the brand name; and must accompany this application. The affidavit must include all affected brand names, the owner's company or corporate name and address, the applicant's company or corporate name and address, and a statement from the owner authorizing the applicant to register the product with the Florida Department of Agriculture and Consumer Services (FDACS). The owner of the brand name shall maintain complete control over each product sold under that brand name in this state.

The \$100 registration fee as a check or money order payable to FDACS is to be attached to the **original** application form and sent to:

In addition: 1) At least 24 fl. oz. of the sample of the brake fluid on which the permit is being sought shall be submitted in a container, or containers, labeled exactly as containers of this brake fluid will be when sold in Florida; 2) the sample of brake fluid being submitted shall have the formula written on the container; 3) A set of labels, front and back, for record retention by the department; 4) A certified report from an independent testing laboratory, setting forth the analysis of said brake fluid if it is a new formula to be sold in the state of Florida; and 5) A **copy** of the original application are to be sent to:
