  - c. The application rate.
  - d. Registration fee. The registration fee is **\$200** (\$100 pursuant to Section 576.021(2)(a), F.S. and \$100 pursuant to Section 576.045(2)(a)2., F.S.).
- 2. The registration fee should be in the form of a check or money order, made payable to Florida Department of Agriculture and Consumer Services.
- 3. The required documents and registration fee should be mailed to the address provided above on this form. The sequence of these documents should be the check or money order on top, followed next by the "Application for Specialty Fertilizer Registration Cover page", followed by the "List(s) of Requested Registrations", followed by each set of documents as defined in item 1.
